Course Description:

A little over half of the course will center on how historians have interpreted the Civil War with special attention to recent and thriving scholarly discussions about the environmental history of the conflict and Civil War memory. The remainder of the semester will be devoted to researching, writing, and talking about a Civil War era (1848-1877) topic of your choice.¹

Important Note:

I encourage you to meet with me regularly to discuss or clarify discussion or reading—or to talk about the historical profession in general. My job (and satisfaction) is as much to work with students on an individual basis as it is to lecture and facilitate discussion. Please keep this in mind throughout the semester.

Presentation:

Please prepare and deliver ONE *lecture* based on your research paper. This lecture should last 30-40 minutes, and the content must be suited for a junior/senior level college course PLUS a historiographical discussion at the end. Presentations are worth 100 points and will be graded on content and clarity. Audio/Visual tools are highly encouraged.

Review Essays:

You will write TWO 1,500-word review essays in which you carefully evaluate the assigned reading and craft a

clear, thoughtful, and persuasive analysis of each of the assigned readings for that essay. Every essay should be balanced with relevant. Each essay is worth 50 points.

Paper Prospectus:

Please craft a 4-6 page, double-spaced prospectus in which you 1) introduce your research topic—with relevant research questions, 2) identify and explain relevant historiography, 3) and project how you aim to organize and write the paper.

Research Paper:

Please research and write a 6,000+ word primary source-based research paper about the topic of your choice. An 'A' paper will be of the kind of quality that might be potentially presented/published with some revision. We will spend a great deal of time in class working out exactly what this looks like.

Attendance and Participation:

Active and informed participation is mandatory. Poor, hostile, or no discussion (outside of the formal presentations) will result in the loss of a letter grade. Five percent will be subtracted from your *final* grade for each unexcused absence. One simply cannot miss graduate classes.

Grade Replacement/Forgiveness and Census Date Policies

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. (For Fall, the Census Date is Sept. 12.) Grade Replacement Contracts are available in the Enrollment Services Center or at <http://www.uttyler.edu/registrar>. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar.

Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.

The Census Date (Sept. 12th) is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment
- Completing the process for tuition exemptions or waivers through Financial Aid State-Mandated Course Drop Policy

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date). Exceptions to the 6-drop rule may be found in the catalog. Petitions for exemptions must be submitted to the Enrollment Services Center and must be accompanied by documentation of the extenuating circumstance.

- possession during a test of materials which are not authorized by the person giving the test, such as class notes or specifically designed "crib notes". The presence of textbooks constitutes a violation if they have been specifically prohibited by the person administering the test;
- using, buying, stealing, transporting, or soliciting in whole or part the contents of an unadministered test, test key, homework solution, or computer program;
- collaborating with or seeking aid from another student during a test or other assignment without authority;
- discussing the contents of an examination with another student who will take the examination;
- divulging the contents of an examination, for the purpose of preserving questions for use by another, when the instructors has designated that the examination is not to be removed from the examination room or not to be returned or to be kept by the student;
- substituting for another person, or permitting another person to substitute for oneself to take a course, a test, or any course-related assignment;
- paying or offering money or other valuable thing to, or coercing another person to obtain an unadministered test, test key, homework solution, or computer program or information about an unadministered test, test key, home solution or computer program;
- falsifying research data, laboratory reports, and/or other academic work offered for credit;
- Taking, keeping, misplacing, or damaging the property of The University of Texas at Tyler, or of another, if the student knows or reasonably should know that an unfair academic advantage would be gained by such conduct; and
- misrepresenting facts, including providing false grades or resumes, for the purpose of obtaining an academic or financial benefit or injuring another student academically or financially.

"Plagiarism" includes, but is not limited to, the appropriation, buying, receiving as a gift, or obtaining by any means another's work and the submission of it as one's own academic work offered for credit.

"Collusion" includes, but is not limited to, the unauthorized collaboration with another person in preparing academic assignments offered for credit or collaboration with another person to commit a violation of any section of the rules on scholastic dishonesty.

All written work that is submitted will be subject to review by plagiarism software.
