COURSE DESCRIPTION:

This course serves as an introductory examination the structures, functions, and operations of law enforcement agencies in the United States, with emphasis on municipal police departments. The course surveys police operations, staff functions, personnel policies, and current innovations utilized in delivering police services. It covers such topics as police discretion, ethics, police-community relations, and the future of policing in American society. This course serves as a prerequisite to CRIJ-4333, *Advanced Police Systems and Practices*.

COURSE RATIONALE:

This course will answer the “who, what, when, where, and why” questions you’ve always had about the way policing is done in the US. The course curriculum provides an historical, structural, and operational overview of the American policing system. Topics covered will help you to grasp the immense complexities of policing in modern America.

STUDENT LEARNING OUTCOMES:

Upon successful completion of this course, you will be able to:

1. Describe the types of police agencies and explain the role of police in America within the context of a democratic society.
2. Describe means and methods utilized to ensure police accountability.
3. Explain the historical development of policing.
4. Describe the selection process for police officers.
5. Compare and contrast organizational structures, policies, strategies and tactics employed to ensure police effectiveness, efficiency and equity.

Grade Replacement/Forgiveness and Census Date Policies

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. Grade Replacement Contracts are available in the Enrollment Services Center or [HERE](#). Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar.

Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT-Tyler;

graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.

The Census Date is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment
- Completing the process for tuition exemptions or waivers through Financial Aid
- State-Mandated Course Drop Policy

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another two-year or four-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date).

Exceptions to the six-drop rule may be found in the catalog. Petitions for exemptions must be submitted to the Enrollment Services Center and must be accompanied by documentation of the extenuating circumstance. Please contact the Enrollment Services Center if you have any questions.

IMPORTANT NOTE ABOUT THIS CLASS:

The material presented in this class covers concepts from the mundane to the contentious. It is imperative that all participants understand the importance of keeping discussions civil and appropriate. We will not have a class where individuals are belittled or berated because of a particular opinion on a topic. *Ad hominem* attacks are the refuge of those who are unable to discuss a position in a scholarly manner. Remember former First Lady Eleanor Roosevelt's take on this issue: "Great minds discuss ideas; average minds discuss events; small minds discuss people." One of my favorite quotes on this topic is from Larry Winget. He wrote,

To College Students: You don't need safe-zones to protect your fragile ego. You need big, new, scary ideas that challenge your beliefs and expand your thinking. You need ideas that will offend you, hurt your feelings, stomp on your toes, and make you mad. This is necessary for growth and learning. So stop being offended by everything. Stop being a victim. Grow up.

I'm not asking you to agree with one another; I'm asking you to be civil, thoughtful, and willing to listen. One of the primary ways you learn during your university education is by being exposed to multiple points of view and ideas other than your own. I encourage a spirited, lively, and scholarly discussion of the myriad topics we'll cover. I believe that groupthink is a horrible thing, so I encourage you to research the topic and present your ideas. Don't agree with others simply because it's the easy thing to do. Be yourself and be willing to stand up for your beliefs.

Having written the paragraphs above, though, I need to make sure you understand something very important: if you make an assertion of fact, you need to check your source of information and be able to cite the source(s). Just because something is on the Internet doesn't mean it's true. Where did you find your information? Is it a valid, scholarly source? Did the person have a political or personal agenda? Did he or she play fast and loose with the facts? In the words of President Ronald Reagan, "trust, but verify!"
