Course Description and Objectives

In-depth study of accounting theory and concepts, with emphasis on corporate financial accounting and reporting under U.S. GAAP, and exposure to IFRS.

Prerequisite: ACCT 2301 and a passing score on the Principles of Accounting Competency Exam. Corequisite: ACCT 3170

Student Learning Outcomes

- 1) Understand the changing environment of accounting and the "conceptual framework" that provides the theoretical basis for the generally accepted accounting principles used in the United States (U.S.) for financial reporting.
- 2) Appy theory and principles for properly measuring income, recording and reporting asset accounts, and understanding the concept of comprehensive income.
- 3) Prepare financial statements and other financial reports based on U.S. generally accepted accounting principles.
- 4) Use ratio analysis in analyzing financial statements and understand the related note disclosures.

Course Requirements

Exams (82.5% of grade)

You will complete 4 exams:

- Chapter 3 and P.A.C.E. (15% of grade)
- Chapters 1 and 2 (7.5% of grade)
- Chapters 4, 5, and 6 (30% of grade)
- Chapters 7, 8, and 9 (30% of grade)

The content and format of the exams will vary but may include any of the following: multiple choice questions, problems, fill in the blank, completion, matching, or essays. During exams, only simple four-function calculators are allowed. Sharing calculators is not permitted. No programmable calculators or cell phones are allowed during an examination.

Homework (10% of grade)

Homework assignments are completed in CengageNOWv2. Each assignment is due at 11:59pm on the Friday of the week we finish a chapter. I allow two attempts per assignment and multiple "Check My Work" attempts during each exercise or problem. Make every attempt to complete HW on time to avoid a 50% penalty for homework that is submitted after the due date. Homework assignments will remain open after the due date, so students can check their work and redo problems as they study for exams.

Got It? (7.5% of grade)



Excluding Chapter 1, which has only 9, each chapter has between 20 and 35 "Got It?" questions. In total, there are 235 of these questions in the 9 chapters we will cover. Based on projected enrollment, each student will be responsible for about 6 questions over the semester. I will randomize the class roster and assign questions sequentially, so that each student will answer a question about once every 40 questions.

In Canvas, you will find a "Got It?" icon on the Home Page that will link to a collaborative workspace that connects to a shared Word document housed on OneDrive. Each student will answer their assigned questions and upload them to the shared document for all to use as a study guide. There will be a new shared

document for the material of each exam (e.g., one for Chapters 1-3, 4-6, 7-9). Other students may comment or suggest revisions to ensure that the usefulness of the study guide is maximized.

NOTE: Any deviation from the above grading scale will be to the benefit of the student. I round all grades up (Ex., 89.3 = 90). This is a complete listing of the course grading requirements. Extra-credit assignments will not be available on an individual basis —no exceptions.

Late Work and Comprehensive Final Exam

Students have the option to take a comprehensive final exam to replace their lowest score on any of the exams, including a missed exam. Other make-up exams will only be given in accordance with University policy for religious observances or participation in University-sponsored events. All athletes and any others who may miss classes per University policy must present, at the beginning of the semester, a schedule of approved absences.

Expectations

- 1. Students should make every attempt to read chapters prior to coming to class. For all course lectures, in-class activities, and discussions, I assume that you have completed the required reading prior to coming to class.
- 2. Textbooks (or access to the Cengage e-Book) and calculators should be brought to each class.
- 3. Class starts promptly at the assigned time. Sometimes life gets in the way, so if you have a problem that prohibits you from arriving to class on time, please inform me as soon as possible. If this is a continuing issue, please select a seat near the entrance to minimize the disruptions to the classroom.
- 4. Inform me in advance if you must leave the class before the scheduled ending time.
- 5. Electronic devices should be used only for taking notes or completing other course-related activities. No matter how boring I am at any time, please refrain from texting and surfing the internet in class.
- 6. Courtesy to the instructor and fellow students is expected. Open discussion is encouraged in the classroom; derogatory remarks and profanity will not be allowed in the classroom.
- 7. Please attend class. Missing just one class can cause you to fall far behind. I attempt to record every class using Zoom, so that resource should be available to you. I expect you to obtain materials and class notes from a peer. I cannot redo a class on a one-to-one basis.
- 8. This is a tough class, and I understand that some of you may be tempted to use prohibited assistance in completing assignments or taking exams. I have zero tolerance for violations of the Student Standards of Academic Conduct (see University policy below). I will assess a severe penalty, including the possibility of assign a failing grade for the course, and report all violations to the Office of the Dean of Students.

<u>Student Standards of Academic Conduct:</u> Disciplinary proceedings may be initiated against any student who engages in scholastic dishonesty, including, but not limited to, cheating, plagiarism, collusion, the submission for credit of any work or materials that are attributable in whole or in part to another person, taking an examination for another person, any act designed to give unfair advantage to a student or the attempt to commit such acts.

- i. "Cheating" includes, but is not limited to:
 - Copying from another student's test paper;
 - Using, during a test, materials not authorized by the person giving the test;
 - Failure to comply with instructions given by the person administering the test;
 - Possession during a test of materials which are not authorized by the person giving the test, such as class notes or specifically designed "crib notes". The presence of textbooks constitutes a violation if they have been specifically prohibited by the person administering the test;
 - Using, buying, stealing, transporting, or soliciting in whole or part of the contents of an unadministered test, test key, homework solution, or computer program;
 - Collaborating with or seeking aid from another student during a test or other assignment without authority;
 - Discussing the contents of an examination with another student who will take the examination;
 - Divulging the contents of an examination, for the purpose of preserving questions for use by another, when the instructors has designated that the examination is not to be removed from the examination room or not to be returned or to be kept by the student;

- Substituting for another person, or permitting another person to substitute for oneself to take a course, test, or any course-related assignment;
- Paying or offering money or other valuable thing to, or coercing another person to obtain an unadministered test, test key, homework solution, or computer program or information about an unadministered test, test key, homework solution, or computer program;
- Falsifying research data, laboratory reports, and/or other academic work offered for credit:
