Required materials:

- 3. professionally-made reeds

Sophomore Year--Fall semester

Scales: careful review of all major scales; introduction of extended range (b-flat to f^3).

Objective: controlled performance of scales with even sound throughout all registers.

Priority is given to tone quality and evenness of scale.

Jury: performance of all major scales, extended range, any order.

Tempo: slurred or tongued at quarter = 90 in sixteenth notes

Etudes: Barrett etudes (40 melodic studies)

Objective: introductory use of melodies with appropriate tone, vibrato, shaping of phrase, and evenness of scale. Melodies in the keys of Aflat, E, Dflat, B, Gflat, Fsharp major; relative minors Jury: performance of one etude selected by instructor at printed tempos.

Solo Literature: introduction to easier standard literature for undergraduate level

Objective: performance in applied lessons of a minimum of two works, demonstrating proficiency in tone and technique, from the list below. Performance of one work on student recital in March. (non-music majors: no recital performance required.)

Jury: selected excerpts from a solo practiced during the fall semester.

Examples: Mozart: Quartet in F major, K. 370

Saint-Saëns: Sonata Poulenc: Sonata, Mvt. 1

...or comparable literature agreed upon by both student and instructor.

Philosophy/History: an introduction to the role of the oboist as soloist and ensemble member; brief historical background of the oboe and its family.

Objective: start/maintain proper approaches to relaxation, breathing, and movement; have a working knowledge of the physical aspects of the oboe and basic knowledge of its history.

Reeds: Music majors must attend reed class each week, where fundamental techniques of shaping cane, wrapping blanks, and the basics of scraping are taught. Non-music majors are not required to attend reed class. Objective: by the end of the semester, the student should be able to (unassisted): shape cane, wrap blanks and scrape seven blanks to 50% completion (unassisted).

Attendance and evaluation: attendance at assigned lesson and reed class times is required. Make-up lessons may not be scheduled for unexcused absences or lack of preparation. Weekly grades are given; students must keep a lesson notebook. There are a total of 18 grades each semester: 14 lesson grades, Jury grade and student recital. The latter two will count as two lesson grades. Each lesson grade consists of scales, etude, solo, and practice journal.

Student Learning Outcomes

By enrollment in MUAP 2221, the student should be able to:

*have a rudimentary knowledge of technical demands throughout the oboe's range;

*produce a tone quality representative of a college-level oboist

*shape cane, wrap reeds, and begin the scraping process

*perform basic etudes and solos in a musical fashion, appropriate to the level of college freshman

Grade Replacement/Forgiveness and Census Date Policies

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. (For Fall, the Census Date is September 6.) Grade Replacement Contracts are available in the Enrollment Services Center or at http://www.uttyler.edu/registrar. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar.

Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract. The Census Date (Sep. 25th) is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- · Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- · Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- · Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- · Being reinstated or re-enrolled in classes after being dropped for non-payment
- · Completing the process for tuition exemptions or waivers through Financial Aid

State-Mandated Course Drop Policy

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date).

Exceptions to the 6-drop rule may be found in the catalog. Petitions for exemptions must be submitted to the Enrollment Services Center and must be accompanied by documentation of the extenuating circumstance. Please contact the Enrollment Services Center if you have any questions.

- *collaborating with or seeking aid from another student during a test or other assignment without authority;
- *discussing the contents of an examination with another student who will take the examination;
- *divulging the contents of an examination, for the purpose of preserving questions for use by others, when the instructor has designated that the examination is not to be removed from the examination room or not to be returned or kept by the student;
- *substituting for another person, or permitting another person to substitute for oneself to take a course, a test, or any course-related assignment;
- *paying or offering money or other valuable thing to, or coercing another person to obtain an unadministered test, test key, homework solution, or computer program or information about a test, test key, home solution or computer program;
- *falsifying research data, laboratory reports, and/or other academic work offered for credit;
- *taking, keeping, misplacing, or damaging the property of The University of Texas at Tyler, or of another, if the student knows or reasonably should know that an unfair academic advantage would be gained by such conduct; and
- *misrepresenting facts, including providing false grades or resumes, for the purpose of obtaining an academic or financial benefit or injuring another student academically or financially.
