Course Description: MUSI 4343 covers selected topics in music theory and analysis. May be repeated three times for credit when content changes. For Fall 2020, the course will present an analytical-compositional methodology called Systemic Modeling. Through music analysis, students will elaborate models of how selected existing pieces are organized to compose new pieces after these models.

Pre-Requisites: MUSI 2312 (Music Theory IV) and MUSI 2117 (Aural Skills IV). Students not possessing the pre-requisites will be administratively removed from the class unless otherwise approved by the department.

Course Learning Objectives: Upon successful completion of this course, students will be able to:

- 1. **Effectively apply varied analytical tools** in order to describe how a given piece is organized.
- 2. Organize analytical information in a formalized model that can be used in composition.
- 3. **Compose original music** after the models developed in the analysis.
- 4. **Properly notate and describe** both the analytical and compositional process.
- 5. **Develop a set of compositional tools** based on the several modeling exercises offered along the course.
- 6. Understand analysis from different perspectives, approaching multiple aspects of music composition.

Required Texts: None. Relevant readings will be distributed by the professor. A music notation software and a graphic editing software are recommended.

Methods for Assessing Outcomes: Students will be evaluated through regular out-of-class assignments, attendance and participation, and major projects.

Methods of Instruction: This course consists of a weekly synchronous session and asynchronous lectures, assignments, readings, and discussions. All asynchronous content will be available in Canvas. The deadline for completing asynchronous activities is every Friday.

** Due Dates and Excused Absences Policy: All assignments are due on the days indicated, at the start of class. No credit will be given for work that is late or missing due to *unexcused* absences, including for major projects.

At the instructor's discretion, absences may be considered *excused* only for legitimate, *documented* reasons (serious illness, family emergency, etc.). Even in cases of *excused absences*, any outstanding assignments are due at the following class period. Missed presentations typically must be made up within one week of the absence. In all cases, it is the student's responsibility to inform the instructor of absences as soon as possible, and to *document* that absence if an *excused absence* is being requested.

** Attendance Policy: Full attendance and participation are expected in this course. Arrival after class has begun will count as a tardy. Three tardies will count as one unexcused absence. Engaging in the weekly Discussions counts as attendance.

For this course, students are allowed **three (3) "free" unexcused absences**. After this, the following penalties may be applied:

4-6 unexcused absences = 1 letter grade reduction

7-9 unexcused absences = 2 letter grades reduction

10+ unexcused absences = automatic failure of the course ("F")

(This penalty is not part of the Participation grade, which reflects engaged activity in class.)

Additionally, avoidable distractions such as cell phone use/texting, eating food, outside work, and unnecessarily leaving the room during class time may results in a tardy or absence for the day, at the instructor's discretion. Multiple occurrences will result in the student being asked to leave the class session.

Grade Replacement/Forgiveness and Census Date Policies

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. Grade Replacement Contracts are available in the Enrollment Services Center or at http://www.uttyler.edu/registrar. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar.

Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.

The Census Date is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment
- Completing the process for tuition exemptions or waivers through Financial Aid

State-Mandated Course Drop Policy

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date).
