Nuventive 5.6 Updates

Users will now have the ability to link a course (and its Curriculum Mapping attributes) to a
Summary Unit Goal. A dropdown has been added to the (Assessment Unit) Mapping >
Curriculum Mapping page, containing any Summary Units for which the Assessment Unit relates.
As with past releases of Nuventive Improve, courses can still be mapped to one or more unit-level Outcomes, with or without individual Curriculum Mapping attributes. The new dropdown is very similar to the other areas listed under the Mapping menu. A new report, available to Summary Units, "Mapping: Curriculum Mapping Excel" has been added that contains a parameter allowing the user to swap the X and Y axes should they prefer one format over the other. The report will show any course to goal relationships for the goals of related Summary Units.

- Peer evaluators will look for evidence of each of the three key elements of the standard, but do so as an *integrated activity* where the parts are linked.
- The institution will not be able to show effective assessment of its outcomes if its means of assessment do not measure what it has set forth as its expected outcomes.
