- 1. **Course Description**: A study of the functions and problems of urban and municipal political units. Topics include small towns and cities, taxation, home rule, minority relations, suburban politics, personnel recruitment, and intergovernmental relations.
- 2. **Student Learning Outcomes.** By the conclusion of the course, students should be able to:
- 3. Demonstrate an understanding of how and why urban areas emerged and developed in the U.S.
- 4. Analyze governmental attempts to respond to citizens' needs in the urban environment.
- 5. Synthesize material explaining how and why machine politics developed in the United States and how reformers did end most urban political machines.
- 6. Compare and contrast how various groups have competed for and exercised political power in urban areas.
- 7. Demonstrate an understanding of service delivery and the management of service delivery in urban areas.
- 8. Analyze arguments concerning the rise of suburbs and the effects of the relationship between suburbs and the inner cities.
- 9. Make judgments about the attempts to remedy urban sprawl and other "problems" produced by suburbanization

- 4. Course Requirements
 - 1. Ten short papers on topics from the readings in *City Politics* Each paper will be worth 2 points. All ten together will equal 20 points. Points earned included in the grade average.
 - 2. Ten newspaper article summarizes. Each summary will be worth 1 point. All ten together will equal ten points.
 - 3. One major paper on a topic selected by the professor. Consult a separate handout for additional information. The paper will be worth 25 points

- 4. A series of quizzes of five to ten questions on the reading. All quizzes together will be worth 10 points.
- 5. A group project on topics selected by the professor. Consult a separate handout for additional information. The project will be worth 25 points.
- 6. A final exam composed of essay questions on topics from course material discussed in class. Students will have access to the topics of the questions before the test. The test will be worth 10 points.
- 7. All assignments listed above are combined. This combination is worth 100 points.
- 5. Grading Scale:

All points will be added together to get a total. The course grade will be based on the following grade zones:

Grade Replacement/Forgiveness and Census Date Policies: Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. Grade Replacement Contracts are available in the Enrollment

Services Center or at http://www.uttyler.edu/registrar. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar. Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three-course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. 3 Full policy details are printed on each Grade Replacement Contract. The Census Date (September 12th) is the deadline for many forms and enrollment actions that students need to know. These include: Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail, or Credit/No Credit. Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date) Schedule adjustments (section changes, adding a new class, dropping without a "W" grade) Being reinstated or re-enrolled in classes after being dropped for non-payment Completing the process for tuition exemptions or waivers through Financial Aid

State-Mandated Course Drop Policy: Texas law prohibits a student who began college for the first time in Fall 2007 or after that from dropping more than six courses during their entire undergraduate career. This definition of career includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date). Exceptions to the 6-drop rule may be found in the catalog. Petitions for exemptions must be submitted to the Enrollment Services Center and accompanied by documentation of the extenuating circumstance.
