<u>Course Description:</u> This issue-oriented and non-technical course introduces students to the fundamental concepts of economics. The course has elements from both microeconomics and macroeconomics. The course uses basic concepts from economics while explaining social issues and policies.

Course Objectives:

After completing this course, students will be able to

- 1. Describe basic economic concepts and principles.
- 2. Judge or interpret discussions, news, articles involving economic concepts/principles.

Grading Policy: The components of final grades are:

The course will consist of **three exams (20% each).** In addition, there will be both graded and ungraded forums on Canvas Discussions. The ungraded Q&A discussion forum will be open for the entire semester so that you may ask content questions, help each other, or form virtual study groups. There will also be one graded **discussion assignment**, which will constitute **10%** of your final grade. For this writing assignment, you have to a find prompt, which you will relate to the concepts covered in the course. The prompt could be a TED video talk, an article from a respected print or online publication, a political or economic cartoon, a movie, TV show, book, song, poem, or commercial. You may find more details about the discussion assignment on Canvas. I also posted some example discussions. Even though this assignment is not due until **March 28**, it will be open from the start. Hence, you may submit early if you want. Finally, you will

have a quiz for each chapter we complete. I will drop your lowest quiz score, and the rest will make up 30% of your grade. All due dates are in the course schedule below.

I will compute your weighted average course score from your scores on the above components. I will assign final letter grades based on your score relative to the distribution of scores in the class. This allows me to assign letter grades without an absolute scale, and to adjust the percentages of the class receiving different letter grades. The percentage of students receiving any particular letter grade is not predetermined. All students can get a C or above with the majority receiving an A or a B. However, I assign lower grades to students who do not submit assignments regularly.

<u>Textbook:</u> "Economic Issues and Policy" by Jacqueline Murray Brux. Cengage Learning, 6th edition. The textbook is required. You will have weekly reading assignments from the book. ISBN: 1285448774

Do some search online, and you will find many affordable options. There are rent options, eBooks, used books, or even new ones for as low as \$80. So, be wise and do not spend more than 80 bucks on the book.

<u>Course Structure:</u> We will rely on Canvas for communication. Check it regularly for announcements or any other updated materials. Make sure you receive emails sent through Canvas. You can find the course syllabus or other administrative stuff on the home page. I will create weekly units under "Modules" where I will specify the material we will cover and list the duties you must accomplish each week.

This course will be reading-intensive. You need to read, on average, one chapter (about 20 pages) each week. I will assess your knowledge of the content by weekly quizzes. The chapters are non-technical and easy to read. You just need to be disciplined and complete weekly tasks. I plan to post short videos to explain the theories and concepts. The textbook makes a good job of explaining them by concentrating on policies. I will focus more on the technical side of the chapters. Make sure to watch the videos I post. You may get questions from the materials I cover in videos but not available in the textbook.

<u>Communication</u>: Email is my preferred method of contact. I will make every effort to respond quickly to your emails. I check my emails several times a day during the week and less frequently on the weekend. When you send me an email, I will generally respond within 24 hours during the week and 48 hours on the weekend (excluding holidays). Note that I will be available via Zoom office hours regularly.

Online Proctoring: The tests in this course will be proctored using ProctorU. Beyond the cost of initial equipment needed (e.g. a camera for your computer), there will not be any additional cost for proctoring. You will need to create a ProctorU account and install the ProctorU extension before attempting any assessment.

To create a ProctorU account, follow the ProctorU tool within Canvas. Please make sure you are using the current version of Chrome or Firefox and download the ProctorU extension available at http://bit.ly/proctoruchrome or https://www.proctoru.com/firefox.

Grade Replacement/Forgiveness and Census Date Policies: Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. Grade Replacement Contracts are available in the Enrollment Services Center or at http://www.uttyler.edu/registrar. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar (The Census Date in Spring 2021 is January 25).

Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.

The Census Date (January 25th) is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment
- Completing the process for tuition exemptions or waivers through Financial Aid

State-Mandated Course Drop Policy: Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (January 25th).

Exceptions to the 6-drop rule may be found in the catalog. Petitions for exemptions must be submitted to the Enrollment Services Center and must be accompanied by documentation of the extenuating circumstance. Please contact the Enrollment Services Center if you have any questions.
