Course Objective and Description

Scope and methodology of macroeconomics. Structure and functioning of the American economy. Develops principles useful in understanding the origin and nature of recessions and inflation. Reviews monetary and fiscal policy tools for economic stabilization. The field of macroeconomics studies, *inter alia*, economic aggregates such as unemployment, inflation and output in partial and general equilibrium models. Some of the topics covered include growth theory, Keynesian models and the quantity theory of money, among others.

Note on Course Dynamics

Because of the evolving coronavirus situation, the course will be delivered entirely synchronously via Zoom. This means that all lectures will be delivered Tuesdays and Thursdays from 9:30am to 10:50am exclusively via Zoom. Additionally, class activities (e.g., oral presentations, group activities) and office hours will be held through Zoom only. Homework, quizzes and tests are to be completed online (see below). In this course attendance to Zoom sessions is mandatory, similar to a face-to-face class format. Please note that Zoom sessions will not be recorded. Note: Please make sure you have access to the adequate software and hardware throughout the semester to meet the course's requirements. Quizzes, Homework and Tests

Quizzes and Homework are to be completed online via McGrawhill Connect, or more simply: Connect. See below for details on how to register on Connect.

To help you get accustomed to the software and format of quizzes please work on "Quiz0 (not graded)"; this quiz is <u>NOT</u> graded and it is simply meant to help you get some practice with Connect. The first graded quiz is labeled as "Q1", and subsequent graded quizzes will be labeled as "Q2", "Q3", "Q4", "Q5", etc. Quizzes will be available as the semester progresses.

Please note that quizzes should be completed in one sitting so make sure to study the material well before attempting a quiz. There is one attempt to complete each quiz. Once you start a quiz time will not stop.

Quiz format: quizzes consist of multiple-choice questions. The number of questions varies with each quiz.

There will be 3 tests throughout the semester, all to be completed on Connect.

<u>Test format</u>: tests consist of multiple-choice questions with an approximate number of questions ranging from 30 to 45 questions. All tests are to be completed Connect. There is one attempt to complete each test. <u>Once you start a test time will not stop</u>.

<u>More on quiz/test format</u>: on Connect (next to each quiz/test) you will find information on the number of questions, time limit, number of points and due day/time, among others, for each quiz.

Please keep track of the availability and due dates for all quizzes and homework. It is the student's responsibility to keep track of due dates. Please note that quizzes/homework will be available for several days and so missing a due date for any given quiz/homework will translate into a score of "O". There will be no extra credit or extensions to complete a quiz/homework/test.

Homework

A key learning component of this course is the assigned homework problem sets (homework). Each student is responsible for working on the assigned problems online via McGrawhill Connect. See below for details on how to register on Connect. These homework problems are part of your final grade. Homework problems on the Connect site are labeled as "HW"; for example, the first homework problem set is "HW1", and the second set is "HW2".

Please note that homework problems are intended to help you learn the material. With this in mind, you will have an unlimited number of attempts to complete each homework, thereby allowing you to improve your score and learn the material. Homework are not timed (there is no time limit). However, homework will be available for a number of days and should be completed according to the established deadline.

For example, the first graded homework is "HW1". This homework will be available on Connect from 8/26, 9 am, and it is due on 9/15, 9 pm. Within this timeframe you have an unlimited number of attempts. Once the deadline has passed you won't be able to work on HW1. You will, however, have a chance to review your work (this will not affect your score) in order to study for tests.

Please keep track of availability and due dates for each homework. It is the student's responsibility to keep track of the availability and due dates. Homework will be available for several days and missing the due date will automatically translate into a score of ``O''. Please note that there will be no extensions to complete a homework or extra credit.

Suggested Problems



Note on Technical Issues

Class Paper and Presentation

The main purpose of this project is to enable the student to apply the concepts learned in class by analyzing a country's economy. This is a group project, where groups will be assigned in the semester.

<u>Each group is expected to give an oral presentation and submit a final paper</u>. Specifically, you are expected to choose a country (e.g., US, Chile, China), describe that country's economic profile and analyze its economic performance using the data and tools learned in class. Make sure to clear the country with me before you start working on your project.

<u>Presentation</u>: You and your group members are expected to give an oral presentation. Please prepare a Power Point file to summarize your analysis, show key data and spell out your policy recommendations. Please upload your Power Point Slides on Canvas.

<u>Research Paper:</u> You are expected to submit (due date TBD) a final research paper. The research paper should include the following sections:

Section 1 - ABSTRACT (150 words): Please briefly explain the reasons for choosing your country. For example, you may have chosen a particular country because of its importance to the regional economy and/or because the country is a key U.S. trading partner.

Section 2- THE ECONOMY (6 pages): <u>describe</u> the country's economy and growth experience over time; <u>analyze</u> the underlying factors which explain this experience. Specifically, (i) describe the country's inflation and employment profile, (ii) the overall macroeconomic performance, (iii) make sure to underline key macroeconomic policies (fiscal and monetary), and (iv) domestic and international factors which may help explain that country's macroeconomic performance. (v) Point to key economic challenges the country is facing. In this section please make connections to the models presented in class (e.g., Keynesian Cross, Aggregate Demand and Supply, Solow Model) as applicable.

Section 3 – CONCLUSION (1 page): In this section you will summarize your findings, but also propose future lines of research. You want to highlight what areas of research you would be interested in exploring in the context of this country.

Section 4 – REFERENCES (1 page): Provide a list of all references used in your analysis including data sources. A minimum of 10 sources is required.

Note: Please make sure to label each of the aforementioned sections in you paper.

Grading (paper and presentations):

1. The Research paper is worth 100 points.

- **a.** Evaluation and grading of the report will be based on:
 - i. Your ability to conduct all relevant analysis. (weight: 50%)
 - ii. Your ability to present your results in a clear, organized and concise fashion. (weight: 50%)

2. Oral Presentation - Power Point File is worth 100 points.

- a. Evaluation and grading of the Slides will be based on
 - i. Your ability to clearly present all relevant analysis necessary to develop policy recommendations in the context of the development challenges. (weight: 50%)
 - ii. Your ability to present your results in a clear, organized and concise fashion using relevant presentation aids such as charts and tables. (weight: 50%)
