# 1 Description

The study of Economics relates to any aspect of human behavior involving the allocation of scarce resources. The key implication of scarcity is that individuals need to make decisions about what to do with their limited resources. In general, Economics assumes rational decision making, meaning that individuals choose the allocation of resources which maximizes their well-being. However, individuals do not always behave rationally. This course provides an introduction to Behavioral Economics, the study of how individuals make decisions based on more realistic psychological foundations.

**Learning Outcomes:** The students who successfully complete this course will be able to:

- i. Describe behavioral Economic analysis and how it differs from standard Economic analysis.
- ii. Describe and explain the methods used in Behavioral Economics, including strengths and weaknesses.
- iii. Apply the material in the course to better understand human behavior and identify situations in which human behavior may not be fully rational.
- iv. Explain the policy implications derived from the analysis and empirical results in Behavioral Economics.

The students will learn the material by attending lectures, reading the textbooks, and completing a number of homework assignments. The comprehension of the material will be measured by the performance of the students on the assignments and examinations.

# 2 Prerequisites

The only formal academic prerequisite for this course is a course in introductory microeconomics.

## a) Textbook

The required textbook for the course is *Behavioral Economics*, 3rd edition, by Cartwright (Routledge). This book will be the primary source for the material in this course, but I will include more technical supplementary material in the lectures. This is a relatively non-technical book and contains good introductions and intuitive explanations for most of the material we will cover in the course.

## b) Mathematics

I will present the material in a student-friendly form, which means simple models with simple functional forms. I think you can get the intuition from a simple model and understand that the results can be extended to more general formulations. Therefore, only basic algebra and elementary calculus will be used in this course, which I will review in class as necessary.

# 3 Structure of the course

I will dedicate as much time to the course as necessary. The material in the course is closely related to my teaching and research interests and I intend to make this course a fun and productive experience for you.

#### a) Lectures

Research in Psychology has demonstrated that a central element in the learning process is active participation by the learner. I understand lectures can promote passive observation rather than active participation. Therefore, to promote active participation, the lectures will generally include:

- i. Presentation of supplementary technical material in which students participate in the analysis.
- ii. Discussion of the reading assignments and the supplementary material presented in the lecture.
- iii. The lectures will be more fun and productive if you have read the material ahead of time and come to class prepared to contribute to the discussion.

# b) Grades

Your grade for the course will be determined by your performance in the class, as follows:

#### i. Examination

There will be one examination. Your performance on the examination will determine 25% of your grade. The examination will cover the basic ideas related to Behavioral Economics and will be based on the reading assignments and the supplementary material presented in the lectures.

#### ii. Quizzes

There will be a number of quizzes during the semester and your performance on the quizzes will determine 20% of your grade. The quizzes will not be timed and you will have access to your textbook and lecture notes. The quizzes are intended to make sure that you are reading the required material in your textbook.

#### iii. Homework

There will be a number of homework assignments distributed during the semester. Your performance on the homework will determine 20% of your grade. The homework assignments will consist primarily of writing a summary and reaction of selected readings.

# iv. Research paper

You are required to write a short research paper, where you will further investigate and learn more about a particular topic in the class of interest to you. Your performance on the research paper will determine 25% of your grade. I will provide you with more information about the research paper later in the course.

# v. Attendance

You are required to attend and participate in class, and your attendance and participation will determine 10% of your grade. Attendance and participation are essential if you want to do well in this class. The class will be based largely on discussion, intended to improve your ability to think logically and analytically.

# **Grade Replacement/Forgiveness and Census Date Policies**

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. Grade Replacement Contracts are available in the Enrollment Services Center or at <a href="http://www.uttyler.edu/registrar">http://www.uttyler.edu/registrar</a>. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar. Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.

The Census Date is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment
- Completing the process for tuition exemptions or waivers through Financial Aid

# **State-Mandated Course Drop Policy**

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date). Exceptions to the 6-drop rule may be found in the catalog. Petitions for exemptions must be submitted to the Enrollment Services Center and must be accompanied by documentation of the extenuating circumstance.
