#### **Course Overview:**

This an introductory course that explores the world of art. Students will develop a fundamental knowledge of vocabulary, media, and art techniques that will ultimately inform the observation, classification, and understanding of artwork from various cultures. Through a thematic and cultural approach, students will become familiar with historical and contemporary artists and their artworks. The structure of this class is formed through online PowerPoint lectures, readings, online assignments, group discussions, writing & research assignments, quizzes, and exams via Canvas. Although this course is entirely online, it is important that a positive learning environment and community is established. As a result, students will not only value the opinions of peers, but also develop a deeper understanding of and appreciation for the arts.

# **Student Learning Outcomes:**

- 1. Critical thinking skills: Students will learn to include creative thinking, innovation, inquiry and analysis, evaluation and synthesis of information.
- 2. Communication skills: Students will learn how to include effective development, interpretation and expression of ideas through written, oral and visual communication.
- 3. Teamwork: Students will examine works of art as a group which includes the ability to consider different points of view and to work effectively with others to support a shared purpose or goal.
- 4. Social Responsibility: includes intercultural competence, knowledge of civic responsibility and the ability to engage effectively in regional, national and global communities.

#### **Required Text:**

Exploring Art, A Global, Thematic Approach, 5th Edition by Margaret Lazzari and Dona Schlesier.


#### Canvas:

#### **Course Calendar:**

# **Late Submission Policy:**

Students will have up to <u>one week</u> after the due date to turn in a missed assignment or quiz. However, 10% of the available points will be deducted each day the assignment is not submitted. Assignments and quizzes not submitted one week after the due date will receive a zero. Exams will <u>not</u> be accepted late. See descriptions below for specific point deductions on assignments and quizzes.

#### **Online Assignments:**

There will be ten online assignments throughout the semester. Assignments will be short response entries, guided questions, or group discussions that expand on weekly content. Online Assignments will be worth 20 points each. **Late Submission Policy:** 2 points (10% of available points) will be deducted each day.

### **Quizzes:**

There will be four quizzes. Quizzes are designed to ensure comprehension of course content and help in preparation for the exams. Quizzes are worth 50 points each. **Late Submission Policy:** 5 points (10% of available points) will be deducted each day.

# **Writing Assignment:**

There will be one writing assignment where students will select an artwork to research and develop a content analysis. Instructions will be available in advance clearly stating guidelines, requirements, and grading rubric. The writing assignment is worth 100 points. **Late Submission Policy:** 10 points (10% of available points) will be deducted each day.

#### **Collaborative Project:**

There will be one collaborative project that will be completed online using the *Collaborations* feature on Canvas. Each student will receive an individual grade that reflects his/her contribution to the group. The group project is worth 100 points. **Late Submission Policy:** 10 points (10% of available points) will be deducted each day.

#### **Exams:**

There will be four exams. The final, fourth exam will <u>NOT</u> be cumulative. There will be absolutely no late submissions, make-ups, or re-takes. A missed exam will automatically lower the student's final grade by 20%. Exams will cover vocabulary and concepts covered in the readings, lectures, additional handouts, and online assignments. Exam format will be multiple choice, short answer, and essay. Exams are worth 100 points each.

\*Failing to follow the Netiquette guidelines in all aspects of this course will result in an F in the class irrespective of the grade achieved in exams or other assignments in the course.

# **Grade Replacement/Forgiveness and Census Date Policies:**

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. (For Fall, the Census Date is Sept. 4.) Grade Replacement Contracts are available in the Enrollment Services Center or at <a href="http://www.uttyler.edu/registrar">http://www.uttyler.edu/registrar</a>. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar.

Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.

The Census Date is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment
- Completing the process for tuition exemptions or waivers through Financial Aid

## **State-Mandated Course Drop Policy:**

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date).

Exceptions to the 6-drop rule may be found in the catalog. Petitions for exemptions must be submitted to the Enrollment Services Center and must be accompanied by documentation of the extenuating circumstance. Please contact the Enrollment Services Center if you have any questions.

- i. "Cheating" includes, but is not limited to:

  - possession during a test of materials which are not authorized by the person giving the test, such as class notes or specifically designed "crib notes". The presence of textbooks

- constitutes a violation if they have been specifically prohibited by the person administering the test
- using, buying, stealing, transporting, or soliciting in whole or part the contents of an unadministered test, test key, homework solution, or computer program;
- collaborating with or seeking aid from another student during a test or other assignment without authority;
- discussing the contents of an examination with another student who will take the examination;
- divulging the contents of an examination, for the purpose of preserving questions for use by another, when the instructors has designated that the examination is not to be removed from the examination room or not to be returned or to be kept by the student;
- substituting for another person, or permitting another person to substitute for oneself to take a course, a test, or any course-related assignment;
- paying or offering money or other valuable thing to, or coercing another person to obtain an unadministered test, test key, homework solution, or computer program or information about an unadministered test, test key, home solution or computer program;
- falsifying research data, laboratory reports, and/or other academic work offered for credit:
- taking, keeping, misplacing, or damaging the property of The University of Texas at Tyler, or of another, if the student knows or reasonably should know that an unfair academic advantage would be gained by such conduct; and
- misrepresenting facts, including providing false grades or resumes, for the purpose of obtaining an academic or financial benefit or injuring another student academically or financially.
- ii. "Plagiarism" includes, but is not limited to, the appropriation, buying, receiving as a gift, or obtaining by any means another's work and the submission of it as one's own academic work offered for credit.
- iii. "Collusion" includes, but is not limited to, the unauthorized collaboration with another person in preparing academic assignments offered for credit or collaboration with another person to commit a violation of any section of the rules on scholastic dishonesty.
- iv. All written work that is submitted will be subject to review by plagiarism software.
