**Course Overview:**

The primary objectives of Design II are:

1. To assist students in developing their understanding of three dimensional space and how one can manipulate this space through the use of numerous formal applications such as, but not be limited to, Line, Plane, Volume, Mass, Movement, Rhythm, Gesture, Organization, etc.
2. To help students develop the technical skills necessary to create and construct the sculptures with which to explore three dimensional space.
3. To develop critical thinking and analysis skills that will allow the student to discern high quality product in terms of concept, content, and craftsmanship.
4. To develop an understanding and appreciation for the vast history of sculpture and three dimensional art.

**Student Learning Outcomes:**

**1. Technical proficiency**

The student will develop and assemble a technically proficient body of art work that demonstrates technical proficiency within his or her chosen concentration (2D or 3D), as well as general proficiency in the greater arena of all mediums.

**2. Conceptually proficiency**

The student will develop and assemble a conceptually proficient body of art work that demonstrates conceptual proficiency within his or her chosen concentration (2D or 3D), as well as general proficiency in the greater arena of all mediums.

**3. Historical context**

The student will develop an understanding of how his or her work relates to art history.

**4. Contemporary trends**

The student will develop an understanding of how his or her work relates to current trends in contemporary art.

**5. Written analysis**

The student will engage in written critical analysis of their artwork.

**6. Verbal analysis**

The student will engage in critical verbal analysis of their artwork.

**Attendance:**

Students are allowed three absences. After three, the student's final grade is lowered one letter grade for each additional absence. Also, punctuality is expected, as is staying for the

duration of the class period. Every two absences or early departures, or combination of either will count as on missed class. As life is a wondrous and unpredictable journey, it is understood that occasion might arise where a student may miss a deadline due to unforeseen circumstances. If this unlikely occurrence happens, it is the student's responsibility to contact the professor to discuss appropriate methods to make up missed work.

### **Grading:**

Students will be evaluated based on the effectiveness of how they solved the problems established with each assignment. The parameters of each assignment will be clearly defined without being oppressive to the student's creativity. Grades are assigned as follows:

- A Reserved for the assignments that demonstrate superior resolution to the problem assigned with exquisite creativity, and an extraordinary effort.
- B Reserved for the assignments that demonstrate good resolution to the problem assigned with good creativity and effort.
- C Reserved for the assignments that adequately solve the problem presented by the assignment with average effort and creativity.
- D Reserved for the assignments that demonstrate only partial understanding of how to adequately resolve the assignment, and demonstrate below average effort and creativity.
- F Reserved for the assignments that demonstrate a lack of understanding, effort, and/or creativity

Student's final grades will simply be an average of all of the grades that they received during the semester. Using the 4.0 scale, add up the total points received during the semester and divide by the number of assignments.

As sculpture, and art in general, is a pursuit that requires a great deal of time and effort, plan on spending time outside of class to complete assignments, as no late assignments will be accepted. Also, plan on attending all opening, lectures and functions held in the Art Gallery.
