Course Description

This course develops a framework for exploring the processes involved in focused social interaction and communication in the context of personal relationships. This course will increase the knowledge of how appropriate communication processes and competencies can strengthen these relationships.

Learning Outcomes

- 1. Apply various concepts covered in this course to our own practical processes and problems.
- 2. Demonstrate understanding of course content by producing well written work related to course concepts.
- 3. Study various theoretical perspectives that provide a framework for understanding how and why individuals communicate the way they do in personal relationships.
- 4. Explore definitions of "interpersonal relationships," and examine how communication influences their development, maintenance, and dissolution.

Assignment Descriptions

"Best Practices for Communication in Relationships." This assignment is worth 50 points. You will research an aspect of communication in relationships that we've discussed so far in class that appeals to you. You will pick a topic and write either a 2-4 double spaced page document or record a 4-6 min video discussing the best practices for communicating in a relationship during the topic you choose. For example, you could decide to discuss End of Life Communication and write a paper discussing how families can hold a *Death over Dinner* with their families to help people feel less taboo about the topic of death. You will give the best practice that you/your research would recommend. Make sure to cite our book (citation listed on the first page of the syllabus) and at least one other source (book, article, etc).

Chapter Presentation: This assignment is worth 100 points. As a small group, you will be asked to present on the chapter of your choice (chosen in week 1). Can choose either Chapters 4, 5, 9, or 10. At least 3 concepts should be presented from the chapter and at least one must be a theory. Please create a PowerPoint, Prezi or other way we can follow you. You are encouraged to please be creative and use innovative formats, such as creating games, debates, role-playing, video clips, and other original learning techniques. However, know that this assignment is expected to be recorded on a platform such as Zoom where we (the audience) can see each group member at the same time. I AM NOT EXCEPTING YOU TO BE IN THE SAME ROOM TO RECORD THIS ASSIGNMENT.

Vlogs/Blogs. This assignment is worth 100 points. The purpose of this assignment is to get you thinking about your own close relationships and how you interact within your family. You will submit a Vlog/Blog 10 times over the course of the semester. Except the week you give your chapter presentation-you are not excepted to also give a volgs/blog unless you want to and skip another week. Vlogs can be up to 5 minutes and Blogs (just a word document, but a fun name ☺) can be up to 3 double space pages. You should talk/write about some key terms that stood out to you, what you found interesting, and how you could apply it to you a current or past/future relationship.

Midterm. This assignment is worth 75 points. It will be over Chapters 1-8; multiple choice & true/false with 1-2 essays.

Final "Poster" Presentation. This assignment is worth 100 points. This will be an individual presentation on a close relationship that you have. You will create a poster/PowerPoint presentation to give based on this close relationship using course concepts you will explain the relationship, what impacts you from having this relationship, and what you do to maintain this

relationship or hope to do to improve this relationship. More details will be provided as the semester unfolds.

Participate in Online Discussion board posts: This assignment is worth 50 points. Throughout the semester (10 times specifically), you will be asked to partake in discussions. You are expected to post an original post by Thursday and reply to at least one other person's post by Sunday. Details will be posted on each discussion post.

Course Policies

Participation: Throughout the semester, you will be asked to partake in discussion and contribute to class. Please be ready, having read the course materials for that class period, with your own thoughts, questions, or insight. This type of participation is key in a small class like this; different point of views will also allow the class to understand the material better.

Attendance: Attendance is necessary in this class. However, you will be given THREE (3) "FREE" days to miss with no penalty for your absence(s). For each and every absence thereafter, 4 points will be deducted from your course point total. Eight (8) total absences earn an automatic "F." For every speech day you miss, 5 additional points will be deducted. Arriving to class late or leaving class early is inconsistent with an efficient and productive class session. Students who consistently (i.e., more than twice) fail to arrive by the time designated and/or who leave class before the end of the period will receive an absence. Finally, an attendance sheet distributed at the beginning of class will record your attendance. If you do not sign in, you will be considered absent for that day. You are responsible for signing your name on this sheet. At the end of the semester all questions concerning your attendance will be answered by recourse to this sheet.

Elasticity Clause: I reserve the right to modify the existing course calendar and assignments. If changes must be made, I will notify students as soon as possible.

Classroom Civility: People and ideas must be treated with respect. Please avoid disruptive behavior that makes it difficult to accomplish our mutual objectives.

Changes to the schedule: Changes may be made at my discretion and if circumstances require. I will do my best to notify you via email, in class, and with a hard copy of the changes. It is I your responsibility to note these changes when announced. Readings must be completed for the day they are assigned on the course schedule. Lectures are intended to complement the readings.

Plagiarism

Academic Honesty: The core values of The University of Texas at Tyler are integrity, optimism, curiosity, accountability, leadership, initiative, and development. Each member of the university is expected to uphold these values.

- i. "Cheating" includes, but is not limited to:
 - copying from another student's test paper;
 - using, during a test, materials not authorized by the person giving the test;
 - failure to comply with instructions given by the person administering the test;
 - possession during a test of materials which are not authorized by the person giving the test, such as class notes or specifically designed "crib notes". The presence of textbooks constitutes a violation if they have been specifically prohibited by the person administering the test;
 - using, buying, stealing, transporting, or soliciting in whole or part the contents of an unadministered test, test key, homework solution, or computer program;
 - collaborating with or seeking aid from another student during a test or other assignment without authority;
 - discussing the contents of an examination with another student who will take the examination;
 - divulging the contents of an examination, for the purpose of preserving questions for use by another, when the instructors has designated that the examination is not to be removed from the examination room or not to be returned or to be kept by the student:
 - substituting for another person, or permitting another person to substitute for oneself to take a course, a test, or any course-related assignment;
 - paying or offering money or other valuable thing to, or coercing another person to obtain an unadministered test, test key, homework solution, or computer program or information about an unadministered test, test key, home solution or computer program;
 - falsifying research data, laboratory reports, and/or other academic work offered
 for credit; taking, keeping, misplacing, or damaging the property of The
 University of Texas at Tyler, or of another, if the student knows or reasonably
 should know that an unfair academic advantage would be gained by such conduct;
 and

- misrepresenting facts, including providing false grades or resumes, for the purpose of obtaining an academic or financial benefit or injuring another student academically or financially.
- ii. "Plagiarism" includes, but is not limited to, the appropriation, buying, receiving as a gift, or obtaining by any means another's work and the submission of it as one's own academic work offered for credit.
- iii. "Collusion" includes, but is not limited to, the unauthorized collaboration with another person in preparing academic assignments offered for credit or collaboration with another person to commit a violation of any section of the rules on scholastic dishonesty.
- iv. All written work that is submitted will be subject to review by SafeAssignTM, available on Canvas

The "Common Knowledge" Clause: Material does not have to be cited if it is common knowledge—that is, knowledge that most American high school graduates already know. (E.g. Humans once painted in caves. Berlin is the capital of Germany. Etc.)

The "Textbook" Clause: Material does not have to be cited if both of these points are true:

- 1. If the information contained in a student's work is found in a course textbook or other assigned reading
- 2. And if that information is presented in such a way that the work is not copying or nearly copying the reading material word–for–word.

For example, if a student's textbook lists the Stone Age as beginning in 3,000 BCE, then a student can simply include this date. But, if a student copied full sentences from the textbook, then that would be plagiarism.

The "10% Rule": As a general rule, a college assignment is considered an original work only if the vast majority of text is original. Generally, no more than 10% of a work can be someone else's words, regardless of proper quotes or citation.

Intent: When reviewing a possible case of plagiarism, the student's intent will not be taken into consideration. In other words, an act of plagiarism is plagiarism whether or not the student claims to have intended plagiarism.

Mistakes & Accidents: The possibility that the student mistakenly or accidentally committed plagiarism will not be taken into consideration. I strongly suggest that you discuss your sources with the Writing Center before turning in work.

Appeal to Ignorance: A student's claim to ignorance with concern to policy will never be treated as a valid justification of plagiarism.

Collaboration: Students are not permitted to collaborate on an essay, discussion post, quiz, test, or any written assignment. Having someone proofread your work is ok, but that can only entail matters of style, grammar, and spelling.

Disciplinary Action for Plagiarism: Per departmental policy, the first offense of plagiarism will result in a zero for the assignment. Any additional st of plagiarism will result in an F for the course and possible disciplinary action by the Dean (e.g. expulsion).

State-Mandated Course Drop Policy: Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date). Exceptions to the 6-drop rule may be found in the catalog. Petitions for exemptions must be submitted to the Enrollment Services Center and must be accompanied by documentation of the extenuating circumstance. Grade Replacement/Forgiveness and Census Date Policies: Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. (For Fall, the Census Date is Sept. 9th.) Grade Replacement

Contracts are available in the Enrollment Services Center or at http://www.uttyler.edu/registrar. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar.

Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract. The Census Date (Sept. 9th) is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment
- Completing the process for tuition exemptions or waivers through Financial Aid
