A. An exploration into the theory and practice of communication across specialized contexts sports professionals face and the development of strategic communication skills needed to succeed in them, including areas such as the press conference, the ceremonial speech, and the recruiting process.

    - b) To understand, analyze and practice effective and ethical oral communication in forms and styles appropriate for various situations, purposes and audiences.
    - c) To identify, understand and practice various professional communication roles in sports.
  - 2. Access and analyze appropriate scholarly sources necessary to answer communication-based research questions and problems. (Program Learning Objective Scholarship Identification and Implementation)
    - a) To identify, access, and comprehend appropriate scholarly sources necessary to answer communication-bases research questions and problems.

#### V. ASSIGNMENTS

- A. (30%) REACTION PAPERS: This semester-long case study will give students a qualitative approach to understanding perspectives and approaches of media, athletes and organizations in sports communication through following and studying them on social media. This daily observation project will require weekly reaction papers throughout the semester and an in-class discussion of your case study.
- B. (20 %) AUDIO PODCAST FEATURE STORY (Due Sept. 27): This interview-based assignment will have you focus on a current UT Tyler student-athlete of your choice. You will produce of 3-5-minute audio spotlight which will be graded on knowledge of the subject, narrative building with identification of your athlete's main theme and supporting details, expression and organization of ideas. You will also be accessed on strong storytelling content, your delivery and elements of the production of the audio.
- C. (20%) PRESS CONFERENCE (Due Nov. 1): This public presentation project builds on your feature story and will challenge you to coordinate with the media and communicate in a press conference setting. Upon completion of our feature story assignment we will shift from journalist to a media relations role by pitching our stories to local media and your classmates by setting up and conducting a press conference.
- D. (30%) FINAL EXAM (Due Dec. 11): The final exam will cover materials discussed in class and readings from throughout the semester.

### VI. ALL ASSIGNMENTS ARE UPLOADED TO CANVAS.

A. Your reaction papers will be submitted to Canvas. Deadlines are vital elements in every form of sports communication and cannot be missed. A missed deadline will result in a 20-percent deduction per day.

### VII. Policies

- A. Course Withdrawal: The last date to withdraw from classes without penalty is November 1, 2019.
- B. Final Examination Date: Wednesday, December 11, 2019, 12:30 2:30 p.m.
- C. **Electronic Devices:** Turn off all electronic devices including cell phones and MP3 players. Allowing a cell phone or other device to ring during class is rude and disrupts class. No text messaging or checking the time on your cell phone during class. Keep these devices in your backpack during class.
- D. **Use of Computers in Class:** Do not use computers during class for reading/writing e-mail, surfing the Web, playing games, working on assignments for other classes, or

writing letters. You may use a laptop computer only for taking class notes. If you use your laptop for any other purpose, I will require you to immediately close the computer.

# **E.** Assignment Policy:

- 1. Assignments will be given throughout the semester. Students are responsible for all course materials, including, but not limited to, class lectures, handouts, workbook and textbook reading assignments.
- 2. Assignments and due dates may be changed at the instructor's discretion with fair notice to students.
- 3. Students must complete all assignments in order to pass the course. This does not mean that merely completing all assignments guarantees the student will pass the course.
- 4. Unless otherwise specified, assignments are due at the beginning of class.
- 5. ALL PAPERS MUST BE TYPED OR WORD-PROCESSED USING THE FORMAT REQUIRED FOR THE ASSIGNMENT.

- 7. Staple or paperclip multiple pages together. It is your responsibility to see this is accomplished.
- F. Late Assignments: Late assignments will not be accepted. Assignments are due at the beginning of the class period on the date specified.
- G. Attendance and Tardiness Policy: Students are expected to attend class. Four absences are allowed this includes illness, university-sponsored activities, etc. A fifth absence will lower the final grade by 5 percentage points. The seventh absence will lower the grade by 10 percentage points (example: if your final grade is 85, with seven absences your posted grade will be 75 or "C". - 1.   - a) "Cheating" includes, but is not limited to:

- (1) copying from another student's test paper;
- (2) using, during a test, materials not authorized by the person giving the test;
- (3) failure to comply with instructions given by the person administering the test;
- (4) possession during a test of materials which are not authorized by the person giving the test, such as class notes or specifically designed "crib notes". The presence of textbooks constitutes a violation if they have been specifically prohibited by the person administering the test;
- (5) using, buying, stealing, transporting, or soliciting in whole or part the contents of an unadministered test, test key, homework solution, or computer program;
- (6) collaborating with or seeking aid from another student during a test or other assignment without authority;
- (7) discussing the contents of an examination with another student who will take the examination;
- (8) divulging the contents of an examination, for the purpose of preserving questions for use by another, when the instructors has designated that the examination is not to be removed from the examination room or not to be returned or to be kept by the student;
- (9) substituting for another person, or permitting another person to substitute for oneself to take a course, a test, or any course-related assignment;
- (10) paying or offering money or other valuable thing to, or coercing another person to obtain an unadministered test, test key, homework solution, or computer program or information about an unadministered test, test key, home solution or computer program;
- (11) falsifying research data, laboratory reports, and/or other academic work offered for credit;
- (12) taking, keeping, misplacing, or damaging the property of The University of Texas at Tyler, or of another, if the student knows or reasonably should know that an unfair academic advantage would be gained by such conduct; and
- (13) misrepresenting facts, including providing false grades or resumes, for the purpose of obtaining an academic or financial benefit or injuring another student academically or financially.

- b) "Plagiarism" includes, but is not limited to, the appropriation, buying, receiving as a gift, or obtaining by any means another's work and the submission of it as one's own academic work offered for credit.
- c) "Collusion" includes, but is not limited to, the unauthorized collaboration with another person in preparing academic assignments offered for credit or collaboration with another person to commit a violation of any section of the rules on scholastic dishonesty.
- d) All written work that is submitted will be subject to review by plagiarism software.

## H. Grade Replacement/Forgiveness and Census Date Policies:

1. Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. (For Fall, the Census Date is Sept. 9, 2019.) Grade Replacement Contracts are available in the Enrollment Services Center or at http://www.uttyler.edu/registrar. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar.

- 2. Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.
- 3. The **Census Date** (**Sept. 9, 2019**) is the deadline for many forms and enrollment actions of which students need to be aware. These include:
  - a) Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
  - b) Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
  - c) Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
  - d) Being reinstated or re-enrolled in classes after being dropped for nonpayment
  - e) Completing the process for tuition exemptions or waivers through Financial Aid

# I. State-Mandated Course Drop Policy:

- 1. Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date).
- 2. Exceptions to the 6-drop rule may be found in the catalog. Petitions for exemptions must be submitted to the Enrollment Services Center and must be accompanied by documentation of the extenuating circumstance. Please contact the Enrollment Services Center if you have any questions.

### J. Student Absence due to Religious Observance:

1. Students who anticipate being absent from class due to a religious observance are requested to inform the instructor of such absences by the second class meeting of the semester.

## K. Student Absence for University-Sponsored Events and Activities:

1. If you intend to be absent for a university-sponsored event or activity, you (or the event sponsor) must notify the instructor at least two weeks prior to the date of the planned absence. At that time, the instructor will set a date and time when make-up assignments will be completed.

The University has changed its computer programming so that all students have an identification number. The electronic transmission of grades (e.g., via e-mail) risks violation of the Family Educational Rights and Privacy Act; grades will not be transmitted electronically.
