Online Structure:

This course is asynchronous, which means there will be live lectures <u>BUT</u> it is not mandatory to attend. These lectures will be recorded and posted on Canvas immediately afterwards and you can watch them whenever works for you. This is the best way to bridge the gap between face to face instruction and the flexibility of the world we're currently living in.

Whether you decide to attend the live lectures or watch the recordings, you are responsible for all the course material (lectures, any extra videos, and readings) during each week. During these live lectures you do not need to have your video or mic on, but you can ask questions in real time. You are welcome to voice your questions through the Zoom chat or by turning your microphone on. As with any class, I expect professionalism and polite discourse.

The live lectures will be Tuesdays and Thursday at 2-3:30 pm during what was our original time slot.

Course Description:

The twentieth century was one of great change in European history. While the century began as one of great promise with the proliferation of the motor car, manned flight, and moving pictures, by 1914 the continent was plunged into the Great War which, due to the violence of the century, was later referred to as the First World War. The interwar years saw the rise of fascism which ultimately led to the Second World War. After 1945 European nations were immediately forced to choose sides in the Cold War: communism versus democracy. And by the end of the century with the end of the Soviet bloc, Europe stood on yet another precipice of significant change. This course will cover this tumultuous and complicated century.

Course Objectives:

By the end of the course, students should be able to do the following:

• analyze significant issues, trends and developments during the 20th century in Europe

- demonstrate knowledge that history is not simply the recitation of names and dates, but instead is a fluid subject where interpretations are constantly changing as a result of different methodologies and patterns of analysis
- analyze and synthesize sources in order to put forward a well-supported argument of their own
- make a clearly written and presented argument, including a thesis and sufficient and well-used supporting detail

Explanation of Assignments:

Weekly responses: These responses should be at least 2 *full* pages in length (you are more than welcome to go over that page minimum) and should address the major themes of the week and critically analyze these major issues. Strong responses will synthesize lecture. These are geared to help you prepare your thoughts for discussions and will provide a helpful tool when preparing for the final exam. They also demonstrate your mastery of the material. These are due Sundays by 11:59pm and will be uploaded to Canvas. No late submissions accepted.

Essays: You will write three 6-page papers examining Isherwood's *Berlin Stories*, Patrick O'Keefe's *Say Nothing*, and Slavenka Drakulic *How We Survived Communism*.

The prompts for these essays will be passed out at least 2 weeks ahead of the deadline.

Final Exam: There will be a take home, essay format final exam covering the entire semester. Instructions for the final exam will be distributed one week prior to the exam due date. Essays will need to synthesize lecture and class readings to demonstrate your mastery of the term's information. This final is cumulative and therefore the responses must reflect the entirety of the semester.

Quizzes:

I reserve the right to give short quizzes over the assigned readings or other course material. Each quiz will be multiple choice and will be worth ten points. Quizzes will be given at the beginning of class and there are no opportunities to make up missed quizzes.

THERE WILL BE NO INCOMPLETES for failure to complete an assignment. Assignments not turned in will result in a 0 for that assignment.

Course Etiquette:

- 1. Make sure to have your Canvas notifications sent to your email. You are responsible for staying up to date on deadlines, announcements, etc.
 - a. You are responsible for all class lectures, readings, and any other videos assigned.
- 2. Late assignments lose **10 points** deducted from their grade for each day the assignment is late.
- 3. **No** emailed assignments will be accepted. Assignments *must* be submitted on Canvas as directed on the assignment.

4. Online Etiquette:

- a. The classroom space is for intellectual growth and to achieve that we must all be respectful and courteous to each other. Respect is a must! We will not always all agree (that is the heart of academics!) but it is crucial that we express our ideas in a respectful way. If a student does not adhere to these guidelines, they will receive a 0 on the weekly responses and, upon further infractions, they will be reported to the university and receive a 0 in the course.
 - Use technology responsibly and considerately. It is tempting to surf the internet, check your phone, etc. while in a Zoom classroom but please refrain.
 - ii. <u>Be courteous:</u> Remain patient, ask/wait for clarification, avoid assumptions and rushed judgement. Forgive mistakes and apologize for errors.
 - iii. <u>Be a good colleague:</u> Remember your role as a student in the course. Make sure you're following directions. Be authentic and collaborative with colleagues. Be aware of your behavior and how others interpret your communication.

- iv. <u>Be professional:</u> Proofread your own writing for spelling, grammar, and punctuation to prevent miscommunication. Avoid slang, sarcasm, or emotionally charged writing. Profanity and offensive language will not be tolerated.
- 5. When you email me, I will make sure to respond to you within 24 hours on weekdays. On weekends it may take longer but I will definitely get back to you within 48 hours at the latest.
 - a. When you email me, address your email to: Professor/Dr. Link and sign it with your name.
 - b. If you have a procedural question –about due dates, what the assignment requirements are, etc. –check the syllabus and the materials on Canvas, as your answer may be there, and you can know immediately, rather than awaiting an email reply.
 - c. I will always address you directly and respectfully in my emails to each of you; I ask the same courtesy in return. If students continue to refuse to address the faculty by name, I reserve the right to not reply to the email.

Grade Replacement/Forgiveness and Census Date Policies:

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. (For Fall, the Census Date is Sept. 12.) Grade Replacement Contracts are available in the Enrollment Services Center or at http://www.uttyler.edu/registrar. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar. Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average.

Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.

The Census Date (Sept. 12th) is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- · Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- · Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- · Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- · Being reinstated or re-enrolled in classes after being dropped for non-payment
- · Completing the process for tuition exemptions or waivers through Financial Aid State-Mandated Course

Drop Policy:

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date). Exceptions to the 6-drop rule may be found in the catalog. Petitions for exemptions must be submitted to the Enrollment Services Center and must be accompanied by documentation of the extenuating circumstance.
