Course Overview and Learning Outcomes:

This course will explore the unique situation in sixteenth century Europe when female rulers came to power across western Europe including France, the British Isles and the Netherlands, a phenomenon which the Protestant leader John Knox called “the monstrous regiment of women.” In a very patriarchal society these female monarchs faced many different challenges. We will explore the lives of these women and how they faced these challenges and to what extent they failed or succeeded.

Course Requirements and Grading Policy:

The course will consist of readings and discussions along with six book reviews, each worth 10% of your grade (for a total of 60%), a retrospective comprehensive essay (30%) and attendance and participation (10%). Late papers will not be accepted, the only exceptions being officially documented medical or family emergencies.

Makeup exams will not be given, nor will late papers be accepted; the only exceptions being officially documented medical or family emergencies. Plagiarism of any sort will not be tolerated and will result in an F for the course.
