Aim of Course:

In this course, we will read a diverse selection of Shakespeare's plays based not only upon their generic differences of tragedy, comedy, and romance, but also upon their fame or lack thereof. This assortment of plays will enable us to establish our own criteria in assessing Shakespeare's genius. Indeed, our interpretation and explanation of his dramatic and poetic skill underscore the import of this course. In the development of this understanding, we will consider various critical approaches and evaluate their applicability and effectiveness in rendering an aesthetic judgment on the play's literary and social value.

By the end of this course, students should be able to:

- 1. read, analyze, and interpret a number of passages in light of the text's dominant themes.
- 2. demonstrate an awareness of the cultural or historical significance of the texts.
- 3. explain how literary genres determine a text's construction.
- 4. synthesize a detailed knowledge of literary works belonging to a specific time period.

To sharpen our minds, we will have a mid-term, a final examination, and a ten-page research paper. Each task counts for thirty percent of the final grade. In addition, one homework analysis task will be assigned; it will be worth ten percent of the final grade. The exam must be taken during the class period of the assigned day. Regular attendance and participation are mandatory. You are allowed three absences; every other absence causes your final grade to be lowered one letter grade.

Please note: a college education is meant to teach students to think outside of their own viewpoints—to expose them to multi-faceted ways of thinking and knowing. That is intellectual

growth and exploration. A student will not be excused from class discussion or assignments simply because they do not agree with the text. Topics such as religion, sex, and politics are fundamental in literary studies and, thus, will be examined in detail.

AI is not permitted in this course at all.

I expect all work students submit for this course to be their own. I have carefully designed all assignments and class activities to support your learning. Doing your own work, without human or artificial intelligence assistance, is best for your efforts in mastering course learning objectives. For this course, I expressly forbid using ChatGPT or any other artificial intelligence (AI) tools for any stages of the work process, including brainstorming. Deviations from these guidelines will be considered a violation of UT Tyler's Honor Code and academic honesty values.

The best way to contact me is via Canvas e-mail. Per the <u>UT Tyler email policy</u> which stipulates that "the Patriot Email account serves as the communication source for all UT-Tyler learning management systems," I will not reply to emails sent from non-UTT email addresses. Grade Replacement/Forgiveness and Census Date Policies

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. (For Fall, the Census Date is Sept. 12.) Grade Replacement Contracts are available in the Enrollment Services Center or at http://www.uttyler.edu/registrar. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar.

Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.

The Census Date is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment

• Completing the process for tuition exemptions or waivers through Financial Aid

State-Mandated Course Drop Policy

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university.
