Course Overview

Applied voice is the study of singing from the standpoints of technique, literature, and performance. Principles of vocal technique based on established vocal pedagogy will be studied alongside literature appropriate for the developmental level of the student. Repertoire in English and at least one other language will be studied each semester. Performance skills in formal and informal settings will be studied.



Course Learning Outcomes

Students will be able to:

- 1. Practice and improve their sight-reading skills.
- 2. Memorize their assigned songs.
- 3. Sing their songs with healthy vocal technique.
- 4. Demonstrate good diction in English, German, French, and Italian.
- 5. Perform their songs with expressions and emotions in the public performances.
- 6. Develop confidence in performing.
- 7. Develops performance skills including but not limited to stage etiquette, stage presentation, styles, and communication.

Required Materials

Music. <u>Plan to spend at least \$50 per semester on music.</u> Your instructor will assign you a couple of books for you to purchase for each semester.

Course Activities and Policies

1. Attendance (20%): We have a new attendance policy for applied voice courses. Due to challenges with schedules and conflicts, we will not reschedule for any missed lessons regardless of reasons for absences. I won't accept doctor's note to excuse your absences. You can miss up to two lessons without affecting on your grade. From the third absence, your semester grade will lower every letter. Two tardies count as an absence. Students who miss

more than 3 lessons due to illness will be marked as incomplete. Therefore, the student will be a semester behind. Here is how the absences will affect on your grade:

A: up to two absences

B: third absence

C: fourth absence

D: fifth absence

F: six or more absences.

- 2. Lesson Preparation (10%): It is imperative that you come prepared for every lesson. Have your songs and arias learned, memorization assignments completed as assigned, errors corrected, and technical progress maintained. DO NOT ATTEMPT TO LEARN YOUR SONGS IN THE LESSONS. The instructor reserves the right to ask a student to leave and return better prepared for the next lesson, which will result in an absence on your attendance record.
- 3. Research (10%): There will be two research submission deadlines. For each deadline, students must submit the link to their website where they upload a research page on poets, and composers, IPAsource printout, and handwritten IPA/Translation sheet.
 - a. 1st submission: **September 19 (Friday) by midnight**. Research on your **two** assigned songs.
 - b. 2nd submission: **October 17 (Friday) by midnight**. For **the rest** of your assigned songs.
- **4. Studio Class (10%):** There will be THREE studio class this semester and it will take place in the <u>Choir Room</u>. Every student is required to sing a new song each time by memory. You must give your music to Mrs. Daughtery a week prior to each studio class.
 - a. September 25 (Thursday), 1-2pm (the first song by memory): Braithwaite
 - b. October 30 (Thursday), 1-2pm (the second and third song by memory): Braithwaite
 - c. November 8 (Saturday), 10am or 11am (Masterclass with Mandy Gonzalez):
 Braithwaite. *I will confirm the time as we get close. Three singers will perform and the rest of the studio is required to attend the masterclass.
 - d. **December 4 (Thursday), 1-2pm** (the rest of the songs by memory): Band Hall
- **5. Website:** Your portfolio will be compiled digitally on your website at www.wix.com or Google Sites. Students will upload their research and required recital attendance on their website and submit the links to the instructor for research submission and recital attendance.
- **6. Student Recital:** Music majors will perform on at least one student recital every semester. Repertoire for student recitals will be a piece, memorized. Students must consult with the instructor regarding the selection of their performing repertoire before they submit the form.

7. Recital Attendance (10%)

- a. Students are required to attend at least THREE voice solo recitals or musicals or operas.
- b. Patriot Singers/Chorale concert will not count for this credit.
- c. Choir concerts will not count for this credit. Students must go to solo singing performance.

- d. Students may consult the instructor to verify which concerts are considered for credit in this category.
- e. Students will upload the pictures of the program and ticket stubs on their websites to prove their attendance.
- f. All recital attendance must be uploaded on your website and be submitted by **December 7 (Sunday), midnight**.

8. Exams (40% total):

- a. Mid-term will take place on **October 6 (Monday) at 6pm in the Braithwaite Recital Hall**. All students must bring their own pianist for performance. Students must wear appropriate concert attire. Each student is required to perform **TWO pieces by memory** and must consult the instructor about their repertoire selections in advance. Last minute change of repertoire will not be accepted.
- b. Voice juries will be in-person on <u>December 9, Tuesday at 10am</u>. All selections for juries must be performed by memory. If you do not perform a jury, you will receive a D or F as your final grade.
- c. If you bring songs that we have not prepared together or putting a song in-progress without clearing it with me in advance, your grade will be lowered by one letter grade.
- d. Juries repertoire requirements:

2-credit lower division: two newly learned songs by memory

2-credit upper division: three newly learned songs by memory

9. Special Exams:

- a. Senior/Junior Recital Jury: Any student performing a degree recital must pass a jury <u>no</u> <u>later than four weeks prior to the recital</u>. The jury committee should consist of three music faculty including myself. It is the responsibility of the student to find a mutually convenient time for the jury and to reserve the space. More information can be found on the Department Handbook.
- b. The students should be prepared to perform all the music for the jury by memory. A copy of the recital program, including translations, must be presented at the recital jury.
- c. Based on the jury, the student will be advised to: (1) Perform the recital on the scheduled date, (2) Have another jury and postpone the recital, or (3) Cancel the recital and reschedule.
- d. The length of a senior recital program must be 47-50 minutes.
- e. The length of a junior recital program must be 22-25 minutes.
- f. *Voice juries and recital juries require at least **TWO full-time** faculties for committee according to the Music department Student Handbook.
- **10.** The music department will not provide an accompanist for your exams. A pianist will be provided for your student recital performance and NATS audition.

Grade Description

He or she has thoroughly maintained a portfolio to the printed standard and has shown development in his or her artistic sensibility throughout the semester by meeting the short- and long-term goals. Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. Grade Replacement Contracts are available in the Enrollment Services Center or at http://www.uttyler.edu/registrar. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar. Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details

The Census Date is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- Schedule adjustments (section changes, adding a new class, dropping without a "W"grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment
- Completing the process for tuition exemptions or waivers through Financial Aid

State-Mandated Course Drop Policy

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date).

Exceptions to the 6-drop rule may be found in the catalog. Petitions for exemptions must be submitted to the Enrollment Services Center and must be accompanied by documentation of the extenuating circumstance. Please contact the Enrollment Services Center if you have any questions.
