**Course Objectives and Learning Outcomes**

Demonstrate performing ability of a 30-minute recital program fulfilling the Junior Recital requirement for Performance majors and Music Education majors

**Course Requirements** (Repertoire, Performance and Practice)

Preparation and successful public performance of repertoire selections in consultation with instructor representing a cross section of styles from Classical through Contemporary periods. The student is responsible for writing program notes to present at the recital hearing and submitting program information to the music office 2 weeks prior to the recital date. The recital performance should reflect the ability to communicate with an audience using refined technical and musical skills and an understanding of stylistic and historical periods of music

**Required Materials**

Jury form and all repertoire performed.

AI is not allowed in this course

**Grades and Juries** (Credit or No Credit = Pass/Fail)

Course grade is the majority of votes assigned by 3 faculty committee members at the conclusion of the recital performance.

**Attendance/Late Work and Make-up Exams**

Attendance is required for a pre-recital hearing one month in advance, a dress rehearsal, and the scheduled performance
