Course Description

This course will cover the anatomical, physiological and acoustic elements of singing as a means of providing students with a detailed working knowledge of the vocal mechanism. Emphasis is placed upon application of these principles to voice instruction and providing students with tools and resources to aid them in their teaching and performing endeavors.

Required Text

- The Diagnosis and Correction of Vocal Faults by James McKinney

Learning Objectives and Student Outcomes

- Students will gain an understanding of the anatomy and physiology of the vocal mechanism through a study of respiration, phonation, resonance, registration, and articulation.
- Students will hone critical listening skills and develop vocal vocabulary to describe singing voices through adjudication exercises.
- Students will become familiar with various components of vocal technique and voice building, and how these may be applied to instruction, with emphasis placed on the ability to detect, diagnose, and correct vocal faults.
- Through assigned readings and class discussion, students will explore a variety of pedagogical approaches to voice instruction, as well as how to effectively select appropriate technical exercises and repertoire for students of all ages and abilities.

Attendance Policy

Attendance at all class meetings is mandatory. Work missed due to an unexcused absence cannot be made up. Three unexcused absences will result lowering a letter grade in this class. Classes missed due to illness, family emergency, etc. will be excused at the instructor's discretion. Requests for excuse should occur before the class meeting whenever possible. Requests for excuse for illness must be accompanied by some official documentation stating the extent of the illness. Appointments such as medical, dental, etc. must not be made during class meeting times.

Course Format and Procedures

- **Attendance (20%)**
- **Lesson Video (20%):** Each student will teach a non-voice major student for March and April. This lesson must be 30-minute long, weekly, and at least 6 times total. Students will submit a link of a 10-minute teaching video via YouTube to the professor each week by Friday midnight. The video must include the technical exercises employed, perceived purpose of the exercises, and instructor corrections and feedback.
- **Four Exams (40% total, 10% for each):** The professor will provide list of study for quizzes. The study list will include anatomy, terminology, and material covered in class.
- **In-Class Lesson Demonstration (15%):** Students will teach a 20-minute voice lesson in front of the class. Students must bring the same students whom they meet for weekly lessons. This teaching demonstration must include the technical exercises employed, perceived purpose of the exercises, and instructor corrections and feedback.
- **Presentation on Vocal Exercises (5%):** This project will consist of both a written proposal and an oral presentation of FOUR vocal exercises that students selected to use in their teaching. A written proposal must include four vocal exercises, purpose and benefits of each exercise, and choice of vowels and consonants for each exercise. Students will demonstrate the selected exercises by singing and by playing them on the piano as part of their presentation. **The written proposal is due by April 10 (Friday) at 12am.**

Grade Replacement/Forgiveness and Census Date Policies

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. Grade Replacement Contracts are available in the Enrollment Services Center or at

<http://www.uttyler.edu/registrar>. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar.

Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.

The Census Date is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment
- Completing the process for tuition exemptions or waivers through Financial Aid

State-Mandated Course Drop Policy

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year

Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date).

Exceptions to the 6-drop rule may be found in the catalog. Petitions for exemptions must be submitted to the Enrollment Services Center and must be accompanied by documentation of the extenuating circumstance. Please contact the Enrollment Services Center if you have any questions.

- using, buying, stealing, transporting, or soliciting in whole or part the contents of an unadministered test, test key, homework solution, or computer program;
- Collaborating with or seeking aid from another student during a test or other assignment without authority;
- discussing the contents of an examination with another student who will take the examination;

- divulging the contents of an examination, for the purpose of preserving questions for use by another, when the instructors has designated that the examination is not to be removed from the examination room or not to be returned or to be kept by the student;
 - substituting for another person, or permitting another person to substitute for oneself to take a course, a test, or any course-related assignment;
 - paying or offering money or other valuable thing to, or coercing another person to obtain an unadministered test, test key, homework solution, or computer program or information about an unadministered test, test key, home solution or computer program;
 - falsifying research data, laboratory reports, and/or other academic work offered for credit;
 - taking, keeping, misplacing, or damaging the property of The University of Texas at Tyler, or of another, if the student knows or reasonably should know that an unfair academic advantage would be gained by such conduct; and
 - misrepresenting facts, including providing false grades or resumes, for the purpose of obtaining an academic or financial benefit or injuring another student academically or financially.
- ii. "Plagiarism" includes, but is not limited to, the appropriation, buying, receiving as a gift, or obtaining by any means another's work and the submission of it as one's own academic work offered for credit.
- iii. "Collusion" includes, but is not limited to, the unauthorized collaboration with another person in preparing academic assignments offered for credit or collaboration with another person to commit a violation of any section of the rules on scholastic dishonesty.
- iv. All written work that is submitted will be subject to review by plagiarism software.
