Course description: Students develop technical proficiency on their instrument, become familiar with the standard repertory, and develop their musicianship. Students meet with the instructor for a 55-minute lesson each week.

Required Materials

- 1) Trumpet and Mouthpiece
- 2) Metronome / Tuner
- 3) Practice Journal
- 4) Methods, Etudes, Solos, and Excerpts as assigned

Expectations:

- 1) The student is expected to be on time, warmed-up, and prepared for his/her scheduled lesson time and studio class. In case of emergency or illness, contact the instructor as soon as possible.
- 2) Lesson notes and recorded practice run-throughs will be turned in prior to each weekly lesson via Canvas.
- 3) Methods, etudes, and solos, which are assigned, will be obtained in a timely manner.
- 4) Sight reading is a skill that is developed in this course.
- 5) The student will make every attempt to hear all brass recitals (student, faculty, guest artists)
- 6) Students are responsible for communicating clearly with accompanists and scheduling coaching sessions with applied instructor

Performance Requirements

- 1) Perform on at least one Student Recital each semester (two for BM Performance majors)
- 2) Perform in studio class as assigned each semester
- 3) Perform a jury at the end of each semester. Juries are a performance opportunity that should be treated equally with a recital performance. Students are responsible for contracting and payment of an accompanist for the jury.
- 4) Perform on Evening of Brass April 6th at 7:30pm and Trumpet Day April 18th
- 5) Perform on additional studio engagements as announced

Final examinations are administered as scheduled. Faculty members must maintain student final examination papers for a minimum of three months following the examination date.

Incomplete Grade Policy

If a student, because of extenuating circumstances, is unable to complete all of the requirements for a course by the end of the semester, then the instructor may recommend an Incomplete (I) for the course. The "I" may be assigned in place of a grade *only when all of the following conditions are met*: (a) the student has been making satisfactory progress in the course; (b) the student is unable to complete all coursework or final exam due to unusual circumstances that are beyond personal control and are acceptable to the instructor, and (c) the student presents these reasons before the time that the final grade roster is due. The semester credit hours for an Incomplete will not be used to calculate the grade point average.

The student and the instructor must submit an Incomplete Form detailing the work required and the time by which the work must be completed to their respective department chair or college dean for approval. The time limit established must not exceed one year. Should the student fail to meet all of the work for the course within the time limit, then the instructor may assign zeros to the unfinished work, compute the course average for the student, and assign the appropriate grade. If a grade has yet to be assigned within one year, then the Incomplete will be changed to an F, or NC. If the course was initially taken under the CR/NC grading basis, this may adversely affect the student's academic standing.

Grade Appeal Policy

Disputes regarding grades must be initiated within sixty (60) days from the date of receiving the final course grade by filing a Grade Appeal Form with the instructor who assigned the grade. A grade appeal should be used when the student thinks the final course grade awarded does not reflect the grades earned on assessments or follow the grading scale as documented in the syllabus. The student should provide the rationale for the grade appeal and attach supporting document about the grades earned. The form should be sent via email to the faculty member who assigned the grade. The faculty member reviews the

rationale and supporting documentation and completes the instruction section of the form. The instructor should return the form to the student, even if a grade change is made at this level. If the student is not satisfied with the decision, the student may appeal in writing to the Chairperson of the department from which the grade was issued. In situations where there is an allegation of capricious grading, discrimination, or unlawful actions, appeals may go beyond the Chairperson to the Dean or the Dean's designee of the college from which the grade was issued, with that decision being final. The Grade Appeal form is found in the [Registrar's Form Library](#).

NOTE: The Grade Appeal Form is different from the Application for Appeal form submitted to the Student Appeals Committee, which does not rule on grade disputes as described in this policy.
