PHIL 1301 Introduction to Philosophy

A survey of the major areas of traditional and modern philosophy: philosophies of knowledge, ethics, logic, aesthetics, and metaphysics

PHIL 1304 Introduction to World Religions

A comparative and philosophical introduction to the religions of the world including but not limited to Judaism, Christianity, Islam, Hinduism, and Buddhism

PHIL 2303 Introduction to Logic

• An introduction to informal, formal, and inductive logic including informal fallacies, propositional logic, and predicate logic

PHIL 2306 Introduction to Ethics

 A study of moral theory and ethical decision-making including a critical analysis of practical and professional cases

PHIL 2331 Foundations of Leadership

• A survey of approaches to leadership in both Western and Eastern philosophy, including but not limited to the ideas of Lao Tzu, Plato, and Locke

PHIL 3300 Justice and Mercy (Approaches to Philosophy)

• An exploration of the questions surrounding the tension between the concepts of justice and mercy, including but not limited to the following: (1) whether justice should be understood as retribution, (2) whether showing mercy is morally permissible, and (3) whether there are limits to forgiveness

PHIL 3301 Ancient Philosophy

• This course covers Western philosophy from the pre-Socratics through Plato and Aristotle and the Eastern traditions of India and China.

PHIL 3304 Existentialism

 A study of humanity's place in the world as understood by philosophers like Kierkegaard, Nietzsche, Buber, Sartre, and Camus

RELI 3330 Introduction to Christianity

• An introductory course that studies the origins, content, and meaning of Christianity by looking at the New Testament (both the Gospels and letters of Paul), the people and ideas that led to the major tenets of Christianity, and secondary texts to explain their meaning.

PHIL 3331 Modern Philosophy

• A study of the main issues and movements in philosophy from the seventeenth century through the twentieth century

RELI 3343 Introduction to Buddhism

• This course introduces students to the essential tenets of Buddhism in its three most popular forms: Theravada, Mahayana, and the Vajrayana and in what ways these forms of Buddhism transformed the cultures in which they arose.

A study of moral philosophy as it applies to leadership and issues in the workplace
