Description of Course Content: The course will examine barriers to out-group participation in society with attention to building systems responsive to the physical, psychological, social and economic needs of minority populations. Students will complete organizational and community assessments, identify change targets, and propose strategies & tactics for creating change. The course emphasizes a strengths-based perspective in effectuating community and organizational change.

Prerequisites: SOCW 2361, SOCW 2362, SOCW 2371, SOCW 3303, SOCW 3304, SOCW 3308, SOCW 3108, SOCW 3409 SOCW 4132, SOCW 4331.

Corequisite: None

Course Overview: The purpose of this course is to provide students with strategies and tactics to effectively promote community and organizational change. Students will demonstrate competencies by developing and implementing a seminar or conference that addresses a social problem germane to the East Texas region. The course content will reflect the Council on Social Work Education's (CSWE) requirements for accreditation.

<u>Capstone Project</u>: Students will help organize and assist with a seminar or conference related to a social problem relevant to the East Texas region. (Worth 100 Points). Event date set for October 2 or October 17th. Participation is mandatory. Conference debrief paper due 11/02/2025 (Worth 100 points). TOTAL OF 200 POINTS

<u>Chapter Quizzes/Assignments</u>: Students will complete 10 quizzes/assignments throughout the semester via canvas. (Worth 200 Points).

Interprofessional Education Event: On September 29 from 1-5pm, you will participate in an interdisciplinary event with medical, nursing, and pharmacy students to learn about and discuss substance misuse cases. This will given experience working in an interdisciplinary team in a medical setting. Mandatory for all students. If you are unable to attend, discuss with professor so alternative can be offered. 1 page reflection will be due 10/10/25. (Worth 200 points)

<u>Community Needs Analysis:</u> This paper and SWOT analysis will identify a particular population and community need. (Worth 300 points) Complete online and due by 11/23/25.

<u>Participation:</u> Instructor will consider the extent of student presence in class, participation in discussions and overall engagement. Class attendance will greatly impact participation grade. See attendance policy for grading (Worth 100 points).

Incomplete Grade Policy

If a student, because of extenuating circumstances, is unable to complete all of the requirements for a course by the end of the semester, then the instructor may recommend an Incomplete (I) for the course. The "I" may be assigned in place of a grade only when all of the following conditions are met: (a) the student has been making satisfactory progress in the course; (b) the student is unable to complete all coursework or final exam due to unusual circumstances that are beyond personal control and are acceptable to the instructor, and (c) the student presents these reasons before the time that the final grade roster is due. The semester credit hours for an Incomplete will not be used to calculate the grade point average.

The student and the instructor must submit an Incomplete Form detailing the work required and the time by which the work must be completed to their respective department chair or college dean for approval. The time limit established must not exceed one year. Should the student fail to meet all of the work for the course within the time limit, then the instructor may assign zeros to the unfinished work, compute the course average for the student, and assign the appropriate grade. If a grade has yet to be assigned within one year, then the Incomplete will be changed to an F, or NC. If the course was initially taken under the CR/NC grading basis, this may adversely affect the student's academic standing.

Grade Appeal Policy

Disputes regarding grades must be initiated within sixty (60) days from the date of receiving the final course grade by filing a Grade Appeal Form with the instructor who assigned the grade. A grade appeal should be used when the student thinks the final course grade awarded does not reflect the grades earned on assessments or follow the grading scale as documented in the syllabus. The student should provide the rationale for the grade appeal and attach supporting document about the grades earned. The form should be sent via email to the faculty member who assigned the grade. The faculty member reviews the rationale and supporting documentation and completes the instruction section of the form. The instructor should return the form to the student, even if a grade change is made at this level. If the student is not satisfied with the decision, the student may appeal in writing to the Chairperson of the department from which the grade was issued. In situations where there is an allegation of capricious grading, discrimination, or unlawful actions, appeals may go beyond the Chairperson to the Dean or the Dean's designee of the college from which the grade was issued, with that decision being final. The Grade Appeal form is found in the Registrar's Form Library. NOTE: The Grade Appeal Form is different from the Application for Appeal form submitted to the
