## Demographic Profile

The population in Harrison County, Texas was 69,584 per American Community Survey data for 2019-2023. The region has a civilian labor force of 33,530 with a participation rate of 61.0%. Of individuals 25 to 64 in Harrison County, Texas, 23.3% have a bachelor's degree or higher which compares with 36.5% in the nation. The median household income in Harrison County, Texas is \$66,040 and the median house value is \$178,200.



## Unemployment Rate

The unemployment rate for Harrison County, Texas was 5.0% as of September 2025. The regional unemployment rate was higher than the national rate of 4.3%. One year earlier, in September 2024, the unemployment rate in Harrison County, Texas was 4.9%.



## Wage Trends

The average worker in Harrison County, Texas earned annual wages of \$60,762 as of 2025Q2. Average annual wages per worker increased 4.9% in the region over the preceding four quarters. For comparison purposes, annual average wages were \$75,686 in the nation as of 2025Q2.

## Cost of Living Index

The Cost of Living Index estimates the relative price levels for consumer goods and services. When applied to wages and salaries, the result is a measure of relative purchasing power. The cost of living is 7.2% lower in Harrison County, Texas than the U.S. average.

## Occupation Snapshot

The largest major occupation group in Harrison County, Texas is Production Occupations, employing 3,067 workers. The next-largest occupation groups in the region are Office and Administrative Support Occupations (2,415 workers) and Management Occupations (2,345). High location quotients (LQs) indicate occupation groups in which a region has high concentrations of employment compared to the national average. The major groups with the largest LQs in the region are Production Occupations (LQ = 2.37), Construction and Extraction Occupations (1.66), and Educational Instruction and Library Occupations (1.48).

Occupation groups in Harrison County, Texas with the highest average wages per worker are Management Occupations (\$107,500), Legal Occupations (\$107,500), and Healthcare Practitioners and Technical Occupations (\$102,100). The unemployment rate in the region varied among the major groups from 1.5% among Legal Occupations to 9.1% among Farming, Fishing, and Forestry Occupations.

Over the next 1 year, the fastest growing occupation group in Harrison County, Texas is expected to be Healthcare Support Occupations with a +0.8% year-over-year rate of growth. The strongest forecast by number of jobs over this period is expected for Management Occupations (+6 jobs) and Transportation and Material Moving Occupations (+6). Over the same period, the highest separation demand (occupation demand due to retirements and workers moving from one occupation to another) is expected in Production Occupations (323 jobs) and Food Preparation and Serving Related Occupations (307).



## Industry Clusters

A cluster is a geographic concentration of interrelated industries or occupations. The industry cluster in Harrison County, Texas with the highest relative concentration is Chemical with a location quotient of 9.86. This cluster employs 2,076 workers in the region with an average wage of \$111,467. Employment in the Chemical cluster is projected to expand in the region about 0.2% per year over the next ten years.



## Education Levels

Expected growth rates for occupations vary by the education and training required. While all employment in Harrison County, Texas is projected to grow 0.1% over the next ten years, occupations typically requiring a postgraduate degree are expected to grow 0.5% per year, those requiring a bachelor’s degree are forecast to grow 0.4% per year, and occupations typically needing a 2-year degree or certificate are expected to grow 0.2% per year.



## Gross Domestic Product

Gross Domestic Product (GDP) is the total value of goods and services produced by a region. In 2024, nominal GDP in Harrison County, Texas expanded 2.4%. This follows a contraction of 8.3% in 2023. As of 2024, total GDP in Harrison County, Texas was \$4,484,589,000.

Of the sectors in Harrison County, Texas, Manufacturing contributed the largest portion of GDP in 2024, \$1,754,738,000. The next-largest contributions came from Mining, Quarrying, and Oil and Gas Extraction (\$603,227,000); Real Estate and Rental and Leasing (\$279,804,000); and Educational Services (\$233,433,000).
