Course Description

This course on cryptography provides an introduction to the fundamentals of securing communication and information. Students will explore key concepts such as encryption and decryption, exploring the symmetric and asymmetric encryption methods, major cryptographic algorithms, and their practical applications. The curriculum covers encryption standards, public key infrastructures, and the use of cryptography in cybersecurity and privacy. Through lectures and hands-on exercises, students will learn to design and analyze cryptographic systems, gaining both theoretical knowledge and practical skills for real-world applications.

- Analyze the security and efficiency of major algorithms like DES, AES, RSA, and ECC, Understanding ethics in digital forensics.
- Develop skills to apply cryptography in securing digital communications and data storage.
- Understand how cryptography fits into broader cybersecurity strategies and modern security challenges.

2. Lab Assignments – Throughout the semester, students will be required to complete various lab assignments each week in a virtual environment, based on the topic being covered.
3. Class Participation –The exact formula of Class Participation points will not be revealed until the end of the semester and the maximum points that can be earned is ten.

Grade Replacement/Forgiveness and Census Date Policies

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. (For Fall, the Census Date is Sept. 12.) Grade Replacement Contracts are available in the Enrollment Services Center or at <http://www.uttyler.edu/registrar>

Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar.

Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.

The Census Date is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment
- Completing the process for tuition exemptions or waivers through Financial Aid

State-Mandated Course Drop Policy

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university.

For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date).

Exceptions to the 6-drop rule may be found in the catalog. Petitions for exemptions must be submitted to the Enrollment Services Center and must be accompanied by documentation of the extenuating circumstance. Please contact the Enrollment Services Center if you have any questions.

 - collaborating with or seeking aid from another student during a test or other assignment without authority;
 - discussing the contents of an examination with another student who will take the examination;
