Course Description:	Students in this course will focus on using object-oriented programming in a modern 3D game engine. Some experience in programming is required, with object-oriented programming being extremely helpful. Some game engine experience is required.

Course Objectives¹: By the end of this course students are expected to:	
1.	To gain experience with object-oriented programming in a game development engine.
2.	To program actual in-game objects that a player can interact with in a complicated way.
3.	To program basic artificial intelligence which controls a non-player character's movement, pathfinding, and/or decision making.
4.	To import and use art assets from at least one source.
5.	To use the object-oriented features of objects in game, including inheritance, object containment.

Grading Details:

- 1) **Labs (approximately 3):** Lab assignments will be split into three or four parts. The grade for each lab part will be 33% or 25% of the total lab grade respectively. The example that follows is for a four-part lab assignment. For a three-part assignment, just remove consideration of part 3.
 - a. **Part 1:** Part 1's purpose is to introduce new concepts and to set up the physical representation of the level. It is worth 25% of the lab grade and is graded based on whether it is done, so the only possible grades are 0% and 25%. Students who miss the lecture are expected to complete this lab on their own.
 - b. **Parts 2 and 3:** These parts will be composed of text instructions with or without pictures included. Its purpose is to introduce advanced concepts that build on part 1. They are worth 25% of the lab grade each and are graded on whether it is done. Note that part 2 builds on part 1, so part 1 must be complete (and graded) before starting on part 2. Likewise, part 3 builds on part 2, so part 2 must be complete and graded before starting on part 3. Students are expected to spend class time to complete part 2 and part 3 of the lab. After completing part 2 and part 3, students will have a 75% on the lab.
 - c. **Part 4:** This part will be composed of text instructions usually **without** pictures. Its purpose is to further introduce advanced concepts that will build on part 3. It is worth 25% of the lab grade and is graded on whether it is done. Note that part 4 builds on part 3, so part 3 must be complete (and graded) before starting on part 3. Students are expected to spend class time **and homework time** to complete part 3 of the lab. After completing part 3, students will have a 100% on the lab.
 - d. **Possible Grades:** On the labs, there are a limited number of grades available. They are:
 - i. **0%** – No part of the lab is complete
 - ii. **25%** - Part 1 of the lab is complete and graded
 - iii. **50%** - Parts 1 and 2 of the lab are complete and graded
 - iv. **75%** - Parts 1, 2, and 3 of the lab are complete and graded
 - v. **100%** - Parts 1, 2, 3, and 4 of the lab are complete and graded
- 2) **Projects:** Project assignments will have a complete grading rubric attached. Students will have at least 2 weeks to complete projects. Projects are expected to be completed on the due date and will have severe penalties for lateness. Please see canvas for details. Note that if there are 2 projects, they are worth 10 points each to your final grade.
- 3) **Policy Adherence:** Students will be expected to adhere to the following policies. Points will be deducted if they are not. Note that students may lose up to 20% of your final grade for failure to adhere to these policies.
 - a. **Attend class on time and for the entirety of the class.** Exceptions will be made, of course, but students will be penalized if they miss more than 6 class periods at a rate of 2 points per unexcused absence to a maximum of 20 points. For purposes of this grade, failure to attend part of the class will count as $\frac{1}{2}$ of an absence.
 - b. **Help or receive help from others.** This is NOT optional, and I will grade extremely harshly on this matter. AAA game development is a team activity and your ability to work in groups is of the utmost importance. Helping others helps reinforce your knowledge and seeing other's work can help inform you of new

ways to do things and grant ideas for creative input. Receiving help is just as serious a matter. Do not try me on this! I prefer to work alone too! Exceptions will be made ONLY if you have a registered disability that is relevant. After submitting parts 1, 2 or 3 of a lab, you may be assigned to help someone. You are to help that person until they are ready to submit whatever part of the lab they are on. After helping, you should inform me that the helped student is **completely** ready to submit and return to your desk to continue to your own labs. Students will be informed if they lose points for failure to adhere to this policy.

Plagiarism:

Plagiarism will result in disciplinary actions. To spare yourself accusations of plagiarism review the following statements: (Adapted from SFSU Department of Computer Science cheating and plagiarism policy)

Plagiarism occurs when a student:

- submits the work of another student representing it as their own.
- allows another student to replicate or submit their work.
- submits code or portions of code with modifications in an effort to make it look original.
- fails to inform the instructor of collaborating with others on code or projects.
- posts assignments on internet sites for solutions.
- submits code found online and modified without proper citation.
- submits code found online with and used verbatim regardless of proper citation.

Plagiarism does not occur when a student

- has permission to collaborate on a program or project and list all collaborators.
- receives guidance from instructors or teaching assistants
- help with errors or provide tips on programming that will help others in the learning process.
- discuss requirements of an assignment and strategies for implementation
- inclusion of code copied from another source when properly cited and specifically allowed by instructor

Grade Replacement/Forgiveness and Census Date Policies – Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. (For Spring, the Census Date is Jan. 30.) Grade Replacement Contracts are available in the Enrollment Services Center or at <http://www.uttyler.edu/registrar>. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar. Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract. The Census Date (Jan. 30th) is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment
- Completing the process for tuition exemptions or waivers through Financial Aid

State-Mandated Course Drop Policy – Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date). Exceptions to the 6-drop rule may be found in the catalog. Petitions for exemptions must be submitted to the Enrollment Services Center and must be accompanied by documentation of the extenuating circumstance.
