Prerequisites: COSC 3315, COSC 3325, COSC 4315, COSC 4336, COSC 4360 and COSC 4385</p>

**Projects**

- There will be one, semester long project, to be completed in teams.
- Each team will give presentations demonstrating the project progress.
- All code and files required for the projects must be submitted **GitHub**.
- Peer evaluation will be conducted to track each team member's performance.
- Every Monday will be standups!
- Team members who do not contribute appropriately to an assignment will receive a significantly lower grade for that assignment than the rest of that team, possibly **"zero", at the discretion of the instructor**.
- On Project workdays, I will rotate with each group to answer your questions and provide guidance on your project.

**Simulated Shark Tank Tyler**

- The end of the semester presentations will be a simulated version of shark tank.
- I will invite experts from Industry and Professors as sharks to evaluate your projects and presentations. This will provide you the opportunity to network with the industry experts in your respective fields and ask questions.
- I will also try to have some guest lectures throughout the semester from industry experts, subject to their schedule.

- You are expected to do your own work.
