COURSE OVERVIEW/LEARNING OUTCOMES

A. <u>Course Overview</u>. This course provides an in-depth examination of commercial law principles as they apply to business transactions. Students will explore the legal frameworks governing contracts, sales and leases of goods, negotiable instruments, secured transactions, suretyship, bankruptcy, and various forms of property ownership and transfer. Emphasis will be placed on understanding statutory law (including the Uniform Commercial Code), common law principles, and relevant federal regulations.

Through examination and preparation of legal documents and other practical examples, students will gain the ability to identify legal issues, apply legal reasoning, and propose solutions to common commercial law problems.

- B. <u>Topics Covered/Learning Outcomes</u>. By the end of this course, students will be able to:
 - Contracts: Explain the elements of a valid contract, including mutual assent, consideration, and compliance with writing requirements; Identify circumstances that invalidate assent, such as misrepresentation, duress, and undue influence; Analyze situations involving performance, breach, discharge, and available contract remedies.
 - 2) Sales and Leases: Apply UCC Article 2 and Article 2A to determine rights and obligations in the sale or lease of goods; Assess the transfer of title, allocation of risk of loss, and the impact of warranties and strict liability in product liability cases; Evaluate remedies available to buyers and sellers for breach of sales or lease contracts.
 - 3) Bank Deposits, Collections, and Funds Transfers: Describe the legal relationships between banks, depositors, and third parties in funds transfers; Apply UCC Article 4 and related provisions to analyze disputes involving bank deposits and collections.
 - 4) Negotiable Instruments: Identify the formal requirements for negotiable instruments under UCC Article 3; Explain how negotiable instruments are transferred and the rights of a holder in due course. Determine the liability of parties and defenses available in negotiable instrument transactions.
 - 5) Secured Transactions: Explain the creation, perfection, priority, and enforcement of security interests under UCC Article 9; Apply statutory rules to resolve priority disputes between secured and unsecured creditors.
 - 6) Suretyship: Differentiate between suretyship and guaranty obligations; Analyze the rights, duties, and defenses of sureties and creditors.
 - 7) Bankruptcy: Explain the purposes, types, and processes of bankruptcy under federal law; Evaluate creditor and debtor rights in Chapter 7, 11, and 13 proceedings.
 - 8) Accountant's Liability: Understand the legal bases for liability of accountants, including negligence/malpractice and breach of fiduciary duties.
 - 9) Property Law: Distinguish between real and personal property and explain the legal rules governing each; Apply principles of property insurance, bailments, and documents of title; Analyze interests in real property, methods of transfer, landlord-tenant relationships, and related disputes.
 - 10) Trusts and Wills: Explain the creation, administration, and termination of trusts; Describe the requirements for a valid will and the process of probate; Identify the rights of beneficiaries and the duties of fiduciaries in estate administration.

REQUIRED WORK

A. <u>Examinations</u>. There will be four (4) exams, including the final exam. None of the exams will be cumulative, meaning they will only cover material presented in that module. The exams will be made up of multiple choice

and true/false questions, and short-answer questions. Each of the exams is worth 125 points, and together, the exams are worth 500 points, or 50% of your grade.

The exams must be taken on the date and time specified in the Course Schedule. If, due to illness or other compelling reasons beyond your control, you are unable to take an exam during the specified time, you should contact me (in advance if possible) to make other arrangements for taking the exam. I will only allow a makeup exam if you provide satisfactory documentation of an excused absence (school athletic event, illness, etc.).

B. <u>Projects</u>. There will be 8 projects throughout the semester, 2 for each module. They generally involve preparation of some kind of legal instrument for use by a fictional company you will make up at the beginning of the semester. You will be able to use generative AI and other tools to create the instruments, subject to the instructions in the assignment.

The projects must be submitted by the date and time specified in the Course Schedule. Each project is worth 50 points, and together, the projects are worth 400 points, or 40% of your grade.

C. Attendance/professionalism.

Class attendance is your responsibility. I expect students to attend and be engaged in class. Attendance/professionalism is worth 100 points. Attendance will not be taken on exam dates. On all other class dates, attendance will be taken.

- Absences will be excused in my sole discretion only for documented illnesses, participation in school athletic events, approved school activities, or inclement weather.
- You are allowed three (3) freebies—meaning, you can miss three class periods without excuse without it impacting your attendance grade.
- 6 points will be deducted (from the 100 possible points) for each absence (after freebies), <u>but if you</u> <u>miss more than 8 class periods (unexcused) including the freebies, you will get 0 points for attendance.</u>
- D. Reading Assignments. Naturally, you are expected to read each of the chapters and materials assigned in the Course Schedule. It is okay to read ahead. There is a bunch of reading in this course, some of it more interesting than others. Many of the concepts have to be digested before they are understood. **Don't get behind**—it is too hard to catch up with this much material!
