## COURSE OVERVIEW/LEARNING OUTCOMES

- A. <u>Course Overview</u>. Introduction to the legal environment of business, legal reasoning, and historical perspective. The influence on economic activity by regulatory agencies in their pursuit of public policy goals is stressed. This course also includes an introduction to business and professional ethics.
- B. <u>Learning Outcomes</u>. By the end of the course, it is expected that you will understand how the law (in the various legal areas we will cover) impacts individuals, organizations, and society. You will be able to use analytical and critical problem solving skills to apply the legal concepts you learn in this course to a myriad of fact situations. Broadly speaking, some of the learning outcomes for this course are:

### Module 1: Foundations of U.S. Legal System

- 1. Explain the primary sources of law and how they affect business decisions.
- 2. Distinguish between civil and criminal law, and between substantive and procedural law.
- 3. Describe how the U.S. Constitution impacts business regulation and individual rights.
- 4. Analyze the roles of the legislative, executive, and judicial branches in shaping business law.
- 5. Compare litigation and various forms of alternative dispute resolution, including mediation and arbitration.
- 6. Identify the stages of a civil lawsuit from filing to appeal, including key procedural rules.

### Module 2: Civil and Criminal Liability

7. Identify the elements of common torts and explain defenses to tort claims.

- 8. Explain strict liability and product liability theories and their implications for manufacturers and sellers.
- 9. Describe different categories of intellectual property and methods of legal protection.
- 10. Analyze how criminal law applies to business, including corporate and white-collar crime.
- 11. Discuss legal challenges and protections related to cybercrime in a business context.

#### **Module 3: Contracts and Business Organizations**

- 12. Identify the elements of a valid contract and explain how contracts are formed electronically.
- 13. Evaluate issues related to contract performance, breach, and remedies.
- 14. Explain the differences between legal and equitable remedies for breach of contract.
- 15. Compare limited liability business forms (LLCs, LLPs, S-Corps) and their advantages for entrepreneurs.
- 16. Describe how corporations are formed, funded, and governed under business law.
- 17. Analyze securities law, including the role of the SEC, investor protection, and insider trading regulations.

### **REQUIRED WORK**

A. <u>Examinations</u>. There will be four (4) exams, including the final exam. None of the exams will be cumulative, meaning they will only cover material presented in that module. The exams will be made up of multiple choice and true/false questions. Each of the exams is worth 100 points, and together, the exams are worth 400 points, or 80.00% of your grade. *The exams must be taken during the date windows specified in the Course Schedule.* If, due to illness or other compelling reasons beyond your control, you are unable to take an exam during the specified time, you should contact me (in advance if possible) to make other arrangements for taking the exam.

#### Online Exam Proctoring: LockDown Browser & Respondus Monitor

To ensure academic integrity during online exams, this course requires the use of LockDown Browser and Respondus Monitor. These tools help create a secure testing environment by restricting access to external resources and monitoring exam sessions through webcam recordings.

#### LockDown Browser:

- Failure to follow monitoring procedures may result in zero credit for the exam.

- You must complete exams in a quiet, well-lit location.
- No other devices, books, notes, or external resources are allowed unless explicitly permitted.

B. <u>Discussion Board</u>. The online discussion board is a vital component of this course, designed to foster a collaborative learning environment. It provides a platform for students to engage in meaningful discussions, share insights, and deepen their understanding of the course material.

#### Participation Requirements:

*Prompts*: For each of the four (4) modules, there will be a discussion prompt that I will post, or four (4) prompts total. You are required to respond to the discussion prompt for each module. Your post must be made by the date specified.

*Quality of Posts.* I can't keep you from using ChatGPT or other generative AI, but ultimately, I want YOUR <u>original</u> thoughts. Points will be deducted for posts that, in my sole judgment, demonstrate an overreliance upon generative AI. Your posts should be original, thoughtful, relevant, and demonstrate a clear understanding of the topic.

<u>Etiquette</u>: Maintain a respectful and professional tone in all posts and responses. Hateful, disrespectful, inflammatory, or inappropriate comments (in my sole discretion) will not be tolerated.

Your posts are worth 15 points each or 60 points total for all four (4) posts.

- C. <u>Capstone Video</u>. By the end of the semester, you will be required to record and upload a video of you that is about 2-3 minutes in length. More instructions will be given in the assignment. The video will be worth 40 points of your grade. By submitting the video, you give me and UT Tyler the irrevocable right and license to download, store, and use the video for any and all lawful purposes related to this course.
- D. <u>Reading Assignments</u>. Naturally, you are expected to read each of the chapters assigned in the Course Schedule. It is okay to read ahead. There is a bunch of reading in this course, some of it more interesting than others. Many of the concepts have to be digested before they are understood. **Don't get behind**—it is too hard to catch up with this much material!
