COURSE DESCRIPTION: This course focuses on critical and analytical thinking involved with business decisions. Topics include the elements of reasoning, interpretation of data, learning how to critique and construct arguments, and understanding complex business problems.

1. **Announcements and Email:** I send announcements via Canvas on a regular basis. I also communicate with you through email. You are responsible for reading and replying when necessary. 2. **Module Dates and Deadlines:** This course is divided into modules. Content modules usually span two weeks. Completely read the requirements for each assignment and discussion board when the module opens. Due dates are clearly stated within assignments and discussion boards. Deadlines are also listed within each module under module information. All assignments are due on a Sunday at 11:59 pm.
3. **Assignments:** All assignments must be submitted via Canvas as a Word file attachment with your name and date on each assignment. The assignments should use 12-point font and be double spaced. All resources used in assignments must be cited in APA format.
4. **Late Work policy for assignments:** I will accept assignments for two days past the due date and assess a seven-point penalty for each day late. After the two-day period, assignments will not be accepted and a zero will be given for the assignment.
5. **Discussion Boards:** Discussion boards are a major component of this course. These include both video and written discussion boards. Each student must post an initial response no later than the Sunday of the first week assigned. Responses to classmates must then be made no later than Sunday of the second week of the module.
6. **Late Submission Policy for Discussion Boards:** No late work will be accepted in discussion boards. This includes your initial post and replies to classmates.
7. **Extra Credit:** There is no extra credit offered for this course.

COURSE OBJECTIVES:

1. Demonstrate an understanding of the nature of critical and analytical thinking
2. Create well-written answers and opinions about a variety of topics using critical thinking skills and models
3. Detect errors in reasoning and explain how the reasoning is in error
4. Evaluate evidence and make appropriate inferences from that evidence
5. Experience group dynamics through collaborative learning activities during the semester
6. Analyze and interpret data
7. Develop and implement decision making skills needed in a business environment

Grade Replacement/Forgiveness and Census Date Policies

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. Grade Replacement Contracts are available in the Enrollment Services Center or at <http://www.uttyler.edu/registrar>. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar. Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract. The Census Date is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census

- Date) • Schedule adjustments (section changes, adding a new class, dropping without a “W” grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment
 - Completing the process for tuition exemptions or waivers through Financial Aid

State-Mandated Course Drop Policy

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date). Exceptions to the 6-drop rule may be found in the catalog. Petitions for exemptions must be submitted to the Enrollment Services Center and must be accompanied by documentation of the extenuating circumstance. - collaborating with or seeking aid from another student during a test or other assignment without authority;
- discussing the contents of an examination with another student who will take the examination;
- divulging the contents of an examination, for the purpose of preserving questions for use by another, when the instructors has designated that the examination is not to be removed from the examination room or not to be returned or to be kept by the student;
- substituting for another person, or permitting another person to substitute for oneself to take a course, a test, or any course-related assignment;
- paying or offering money or other valuable thing to, or coercing another person to obtain an unadministered test, test key, homework solution, or computer program or information about an unadministered test, test key, home solution or computer program;
- falsifying research data, laboratory reports, and/or other academic work offered for credit;
- taking, keeping, misplacing, or damaging the property of The University of Texas at Tyler, or of another, if the student knows or reasonably should know that an unfair academic advantage would be gained by such conduct; and
- misrepresenting facts, including providing false grades or resumes, for the purpose of obtaining an academic or financial benefit or injuring another student academically or financially.

ii. "Plagiarism" includes, but is not limited to, the appropriation, buying, receiving as a gift, or obtaining by any means another's work and the submission of it as one's own academic work offered for credit. iii. "Collusion" includes, but is not limited to, the unauthorized collaboration with another person in preparing academic assignments offered for credit or collaboration with another person to commit a violation of any section of the rules on scholastic dishonesty. iv.
