COURSE DESCRIPTION: This course focuses on critical and analytical thinking involved with business decisions. Topics include the elements of reasoning, interpretation of data, learning how to critique and construct arguments, and understanding complex business problems.

PREREQUISITES: COSC 1307, MATH 1342, & MANA 3370

IMPORTANT INFORMATION FOR SUCCESS IN MANA 3300.001

1. **Attendance & Participation:** Yes, you are required to come to all class meetings and participate! There are online options for this course, and you chose to take an in-person class. A portion of your points come from in-class participation. If you miss class, you may miss earning points. These cannot be made up. I understand emergencies or other unexpected circumstances arise. If this is the case, email me as soon as possible so we can discuss what you missed. If you will be absent from a class for a university-sponsored activity, let me know prior to the event or activity. If you miss more than 30% of in-class meetings, your final grade will be reduced by a letter grade.

2. **Format for assignments:**

- Name and date at the top right of all submitted documents
- 12-point font
- Double-spaced
- Citations, when necessary, listed on a separate page at the end of the assignment. All citations should be in APA Style. For more information view www.apastyle.org or <https://owl.perdue.edu>

3. **Late Work Policy for Assignments:** I will accept assignments one day past the due date and assess a ten-point late penalty. After the one-day late acceptance day, assignments will not be accepted and a zero will be given for the assignment. For example, if a 50-point assignment is due on Sunday, but you do not submit work until Monday, the highest grade you can receive is a 40. If you wait until Tuesday, it is too late. You will receive a zero for the assignment.

4. **GMetrix:** GMetrix is a computer application that will help improve your skills in Excel. These skills will be used to analyze data (analytical thinking) during the last portion of the semester. You will need Excel on your home device or use the computers on campus. If you do not score a minimum 700 on the GMetrix test by the end of the semester, the highest grade you can achieve in the course is a C.

5. **Reading Checks:** There will be in-class checks to assure you are reading what is assigned.

6. **Withdraw dates:** September 2, 2022 (Census), November 4, 2022 (Final withdraw date)

COURSE OBJECTIVES

1. Apply the elements of reasoning and standards of critical thinking to think through concepts and issues. Some applications in this class include:
 - a. Creating well-written answers and opinions about a variety of topics using critical thinking skills and models
 - b. Detecting errors in reasoning and explaining how the reasoning is in error
 - c. Evaluating evidence and making appropriate inferences from that evidence
 - d. Providing thoughtful feedback to peers and participating effectively in group collaborative learning activities
2. Demonstrate the ability to analyze and interpret data
3. Demonstrate the decision making and problem-solving skills needed in a business environment
4. Cite all sources used in your class work correctly using APA style. Meeting this objective will ensure that:
 - a. it is clear what thoughts and ideas in your work are the results of your own critical and analytical thinking
 - b. readers can use your citations to find/review the original sources of ideas and there will be no plagiarism in your class submissions.

EVALUATION:

There are 810 possible points to earn in this course. You start at 0 and earn your points by submitting assignments, participating in class, and completing all parts of the projects.

Grade Replacement/Forgiveness and Census Date Policies

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. Grade Replacement Contracts are available in the Enrollment Services Center or at <http://www.uttyler.edu/registrar>. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar. Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract. The Census Date is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census

- Date) • Schedule adjustments (section changes, adding a new class, dropping without a “W” grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment
 - Completing the process for tuition exemptions or waivers through Financial Aid

State-Mandated Course Drop Policy

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date). Exceptions to the 6-drop rule may be found in the catalog. - collaborating with or seeking aid from another student during a test or other assignment without authority;
- discussing the contents of an examination with another student who will take the examination;
- divulging the contents of an examination, for the purpose of preserving questions for use by another, when the instructors has designated that the examination is not to be removed from the examination room or not to be returned or to be kept by the student;
- substituting for another person, or permitting another person to substitute for oneself to take a course, a test, or any course-related assignment;
- paying or offering money or other valuable thing to, or coercing another person to obtain an unadministered test, test key, homework solution, or computer program or information about an unadministered test, test key, home solution or computer program;
- falsifying research data, laboratory reports, and/or other academic work offered for credit;
- taking, keeping, misplacing, or damaging the property of The University of Texas at Tyler, or of another, if the student knows or reasonably should know that an unfair academic advantage would be gained by such conduct; and

ii. "Plagiarism" includes, but is not limited to, the appropriation, buying, receiving as a gift, or obtaining by any means another's work and the submission of it as one's own academic work offered for credit. iii. "Collusion" includes, but is not limited to, the unauthorized collaboration with another person in preparing academic assignments offered for credit or collaboration with another person to commit a violation of any section of the rules on scholastic dishonesty. iv. All written work that is submitted will be subject to review by plagiarism software.
