COURSE OBJECTIVES:

This course is designed to introduce students to the practice of international business and build students' knowledge of the global business environment. The course will examine economic, cultural, and political factors affecting worldwide business. The goal of this course is to equip students with skills and knowledge that are needed to compete in the global economy of today.

This course offers the following objectives:

- 1. Present the fundamental issues in international business
- 2. Convey the critical importance of cultural, legal, and political factors as complements to business factors in international business
- 3. Explain the opportunities associated with international business
- 4. Prepare students for the issues and challenges of working internationally
- 5. Make students aware of current international business news through the reading and discussion of current business press
- 6. Apply the information from readings to current events involving firms doing business across borders
- 7. Make students comfortable presenting to a group and discussing within the group

- 6. Recognize the role of ethics in international dealings
- 7. Grasp the role geography plays in international business

EXAM INSTRUCTIONS (Respondus LockDown Browser)

You will have two exams during the semester. Although both exams are <u>open book, open note</u>, <u>you are</u> <u>REQUIRED to use Respondous Lockdown Browser</u> to finish the online exams which will prohibit you from accessing online support and cooperating with other students. Here are the detailed guidelines:

- Select a location where you are comfortable having a video recording taken of yourself and your workspace environment. This area should be free of distractions and interruptions.
- Turn off all other devices (e.g. tablets, phones, second computers) and place them outside of your reach
- Before starting the test, know how much time is available for it, and also that you've allotted sufficient time to complete it
- Clear your desk or workspace, <u>only class textbook and one-page handwritten class note are</u> allowed to refer during the exam
- Remain at your computer for the duration of the test
- If the computer, Wi-Fi, or location is different than what was used previously with the "Webcam Check" and "System & Network Check" in LockDown Browser, run the checks again prior to the exam
- To produce a good webcam video, do the following:
 - o Avoid wearing baseball caps or hats with brims
 - o Ensure your computer or device is on a firm surface (a desk or table). Do NOT have the computer on your lap, a bed, or other surface where the device (or you) are likely to move
 - o If using a built-in webcam, avoid readjusting the tilt of the screen after the webcam setup is complete
 - Take the exam in a well-lit room, but avoid backlighting (such as sitting with your back to a window)
- Remember that LockDown Browser will prevent you from accessing other websites or applications; you will be unable to exit the test until all questions are completed and submitted

Grade Replacement/Forgiveness and Census Date Policies

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. Grade Replacement Contracts are available in the Enrollment Services Center or at http://www.uttyler.edu/registrar. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar.

Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.

The Census Date is the deadline for many forms and enrollment actions that students need to be aware of. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment
- Completing the process for tuition exemptions or waivers through Financial Aid This syllabus is subject to change at the discretion of the instructor.

State-Mandated Course Drop Policy

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date).

Exceptions to the 6-drop rule may be found in the catalog. Petitions for exemptions must be submitted to the Enrollment Services Center and must be accompanied by documentation of the extenuating circumstance. Please contact the Enrollment Services Center if you have any questions.
