<b>COURSE DESCRIPTION:</b>	This course focuses on critical and analytical thinking involved with business decisions. Topics include the elements of reasoning, interpretation of data, learning how to critique and construct arguments, and understanding complex business problems.

## Important Information for Success in MANA 3300.060

1. **Announcements, email, and communication:** Open communication is key to success in this course. I send announcements via Canvas on a regular basis. I also communicate with you through Canvas messenger. You are responsible for reading and replying when necessary. If you do not understand a concept, assignment, feedback I give, or a grade, please ask! If you are having trouble with work or personal issues that are impeding your success in this class, let me know so we can work together for a successful semester.
2. **Format for assignments:**
  - Name and date typed at the top right of all submitted documents
  - 12-point font
  - Citations listed on a separate page at the end of the assignment. All citations should be in APA Style. For more information view [www.apastyle.org](http://www.apastyle.org) or <https://owl.perdue.edu>
  - Assignments submitted as a Word document, not a pdf
3. **Late Work policy for assignments and idea posts:** I will accept assignments one day past the due date and assess a twenty-point late penalty. After the one-day late acceptance day, assignments will not be accepted and a zero will be given for the assignment. For example, if a 50-point assignment is due on Sunday, but you do not submit work until Monday, the highest grade you can receive is a 40. If you wait until Tuesday, you will receive a zero for the assignment. You are responsible for keeping up with due dates!
4. **AI Use:** AI can be a wonderful tool but should be used as just that – a tool. You are welcome to use AI to help generate ideas, but I caution you in doing this. Using AI can sometimes stifle your own ideas, leading you to lean too heavily on AI for your assignment submission. I will not accept assignments or discussion posts that have been generated by AI, then copied, pasted, and submitted. This is considered plagiarism. In addition to reading your submissions, I use the AI checker that is provided in Canvas. If I believe your assignment is an AI generated submission, you will be required to meet with me to discuss and answer some questions about the submission and chapter content.
5. **Idea Posts (video and written):** Idea posts are a component of this course. These include both video and written posts. Some of the posts will require replies while other will not. Specific instructions will be given for each post.
6. **GMetrix:** GMetrix is a computer application that will help improve your skills in Excel. These skills will be used to analyze data (analytical thinking) during the last portion of the semester. You will need Excel on your home device or use the computers on campus. If you do not score a minimum of 700 on the GMetrix test by the end of the semester, the highest grade you can achieve in the course is a C.
7. **Reading Checks:** There will be checks in most modules to assure you are reading and/or watching what is assigned. Since this is an online class, you need to make sure you are reading and watching all material given to get the most out of this course.
8. **Modules:** This course is divided into two-week modules. Modules will open on a Monday, with all information (reading, videos, assigned work) for the module available. Work is typically due the second Sunday in the module unless otherwise stated.

## COURSE OBJECTIVES

1. Apply the elements of reasoning and standards of critical thinking to think through concepts and issues. Some applications in this class include:
  - a. Creating well-written answers and opinions about a variety of topics using critical thinking skills and models
  - b. Detecting errors in reasoning and explaining how the reasoning is in error
  - c. Evaluating evidence and making appropriate inferences from that evidence
  - d. Providing thoughtful feedback to peers and participating effectively in group collaborative learning activities
2. Demonstrate the ability to analyze and interpret data
3. Demonstrate the decision making and problem-solving skills needed in a business environment
4. Cite all sources used in your class work correctly using APA style. Meeting this objective will ensure that:
  - a. it is clear what thoughts and ideas in your work are the results of your own critical and analytical thinking
  - b. readers can use your citations to find/review the original sources of ideas and there will be no plagiarism in your class submissions.

## Grade Replacement/Forgiveness and Census Date Policies

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. Grade Replacement Contracts are available in the Enrollment Services Center or at <http://www.uttyler.edu/registrar>. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar. Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract. The Census Date is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment
- Completing the process for tuition exemptions or waivers through Financial Aid

## State-Mandated Course Drop Policy

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date). Exceptions to the 6-drop rule may be found in the catalog. Petitions for exemptions must be submitted to the Enrollment Services Center and must be accompanied by documentation of the extenuating circumstance. - collaborating with or seeking aid from another student during a test or other assignment without authority;
