for business problem solving. Topics include evidence-based management, interpretation of data, learning how to critique and construct arguments and understanding complex business problems.

1. <u>Announcements and email:</u> I send announcements via Canvas on a regular basis. You are responsible for reading and replying when necessary. Make sure your full name and class number are at the end of the email. To be successful in this online learning environment, you must regularly (several times a week) check Canvas and your messages.

2. Written assignment format:

- ii. 12-point font
- iii. Word documents double spaced
- iv. Name and date typed on each Word assignment.

- ii. Assignment 6: No late work accepted for grading.
- iii. <u>Idea Posts 1-4:</u> Submitted one day past due date 5-point late penalty. Two days or more past the due date, not accepted for grading.
- 4. **GMetrix:** GMetrix is a computer application that will help improve your skills in Excel. These skills are used to analyze data (analytical thinking) during the last portion of the semester. You will need Excel on your home device or use the computers on campus in the SAP lab (COB 251).
 - Your goal is to be able to complete the GMetrix test by the end of the semester with a minimum score of 700. If you do not, the highest grade you can make in the class will be a C.
 - If you are using an Apple/MAC computer, you will need to access GMetrix through the UT Tyler Virtual Desktop. Instructions are in Canvas.
- 5. <u>Idea Posts:</u> Idea posts are a component of this course. Some are video recordings, posted in Flip, answering the given prompt. You are not required to respond to classmates, but I encourage you to watch other videos to see what others are thinking. If you choose to respond to others (via video response), you can earn up to five bonus points. The responses must be more than "good job" or "I agree". There is one written idea post where replies will be required.

6. Respondus Lockdown Browser withMonitor:

This course uses LockDown Browser with Monitor for your reading checks. While there is no cost to you to use the software, you are required to have a webcam,

which may be built into your computer or may be an external camera. Respondus is available for Mac, PC, and Chromebooks. There is information in the Canvas course about downloading and using this software.

COURSE OBJECTIVES

- 1. Apply the elements of reasoning and standards of critical thinking to think through concepts and issues. Some applications in this class include:
 - a. Creating well-written answers and opinions about a variety of topics using critical thinking skills and models
 - b. Detecting errors in reasoning and explaining how the reasoning is in error.
 - c. Evaluating evidence and making appropriate inferences from that evidence
 - d. Providing thoughtful feedback to peers and participating effectively in group collaborative learning activities
- 2. Demonstrate the ability to analyze and interpret data.
- 3. Demonstrate the decision making and problem-solving skills needed in a business environment.
- 4. Cite all sources used in your class work correctly using APA style. Meeting this objective will ensure that:
 - a. it is clear what thoughts and ideas in your work are the results of your own critical and analytical thinking.
 - b. readers can use your citations to find/review the original sources of ideas and there will be no plagiarism in your class submissions.

EVALUATION:

Grades are determined on a straight percentage scale based on the number of points earned out of the maximum points.
