# **COURSE DESCRIPTION**

The new age of marketing requires an understanding of data as marketing decisions are made based on data analysis. The goal of this course is to provide students with the knowledge and skills needed to make strategic marketing decisions through intelligent use of marketing data analytics such as customer lifetime value analysis, STP (segmentation, targeting, and positioning) strategy, marketing mix, and digital marketing analytics. The course employs a combination of lectures and case studies. By the end of the course, you will be able to understand how to make effective data-driven marketing decisions.

Upon successful completion of this course, students will be able to:

- Demonstrate an understanding of marketing analytics in strategic decisions.
- Understand the roles of data technologies in marketing.

- Develop 4P marketing mix models.
- Gain exposure to digital marketing analytics.
- Apply marketing analytics skills to a real marketing issue of interest.

#### **COURSE CONTENTS**

**Exam (100 points, 2 exams):** There are two exams that students will take to solve multiple-choice questions, interpret data tables and charts, suggest strategic opinions, and often make tables and charts with given questions and data. LockDown Browser and Respondus Monitor Proctoring will be used for the Midterm Exam and the Final Exam. You are NOT permitted to use any form of Artificial Intelligence (AI) or plagiarism. I will be checking for plagiarism and AI and it will result in a zero on the exam and the incident will be reported to the university for academic dishonesty.

Activity (50 points, 2 activities): Students will take two activities to review the contents they have learned. Each activity will be 50 points.

Case Study (100 points, 4 case studies): Students will have four case studies for the contents they learn.

# **EXAM PROCTORING**

LockDown Browser + Webcam Requirement:

This course requires the use of LockDown Browser and a webcam for online exams. The webcam can be the type that's built into your computer or one that plugs in with a USB cable. # **LockDown Download Instructions**

- Select an exam from the course (Practice Quiz must be completed PRIOR to any exam)
- If you have not already installed LockDown Browser, select the link to download the application and follow the installation instructions
- Return to the exam page in a standard browser
- LockDown Browser will launch and the exam will begin
- Note: LockDown Browser only needs to be installed once per computer or device. It will start automatically from that point forward when a test requires it.

### **Guidelines for Proctored Exams:**

When taking an online exam, follow these guidelines:

- Select a location where you are comfortable having a video recording taken of yourself and your workspace environment. This area should be free of distractions and interruptions.
- Turn off all other devices (e.g. tablets, phones, second computers) and place them outside of your reach
- Before starting the test, know how much time is available for it, and also that you've allotted sufficient time to complete it
- Clear your desk or workspace of all external materials not permitted books, papers, other devices
- Remain at your computer for the duration of the test
- If the computer, Wi-Fi, or location is different than what was used previously with the "Webcam Check" and "System & Network Check" in LockDown Browser, run the checks again prior to the exam
- To produce a good webcam video, do the following:
- o Avoid wearing baseball caps or hats with brims
- o Ensure your computer or device is on a firm surface (a desk or table). Do NOT have the computer on your lap, a bed, or other surface where the device (or you) are likely to move
- o If using a built-in webcam, avoid readjusting the tilt of the screen after the webcam setup is complete
- o Take the exam in a well-lit room, but avoid backlighting (such as sitting with your back to a window)
- Remember that LockDown Browser will prevent you from accessing other websites or applications; you will be unable to exit the test until all questions are completed and submitted

#### Registrar

Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract. The Census Date is the deadline for many forms and enrollment actions of which students need to be aware. These include:

#### Grade Replacement/Forgiveness and Census Date Policies

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (Stewart Hall 230) on or before the Census Date of the semester in which the course will be repeated. Grade Replacement Contracts are available in the Enrollment Services Center or at http://www.uttyler.edu/registrar.

Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar. Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. #### **State-Mandated Course Drop Policy**

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date).

Exceptions to the 6-drop rule may be found in the catalog. Petitions for exemptions must be submitted to the Enrollment Services Center and must be accompanied by documentation of the extenuating circumstance. Please contact the Enrollment Services Center if you have any questions.

#### **Grade Appeal Policy**

UT Tyler's Grade Appeal policy requires the completion of a Grade Appeal form for this action to take place. The grade appeal begins with the instructor of your course. If you do not agree with the decision of the instructor, you may then move your appeal to the department chair/school director for that course. If you are still dissatisfied with the decision of the chair/director, you may move the appeal to the Dean of the College offering that course who has the final decision. Grade appeals must be initiated within sixty (60) days from the date of receiving the final course grade.
