WRITING ASSIGNMENTS: Under various modules you will have writing assignments. Those writing assignment might have you watch a video and provide a written reflection, you might be assigned an article review, etc. Please see the course map for more information and check out the modules.

ACTION PAPER: You will have a 5 page paper to complete in the class. You will chose a gender topic you are interested in and then write a 5 page paper describing 7 actions you can take to help with this gender issue. There are more details about the paper in Canvas under the assignment.

GROUP SERVICE LEARNING PROJECT: You will be divided into groups in this class and together, complete a service learning project as it relates to a specific gender topic. MORE DETAILS IN CANVAS.

LATE WORK: I do NOT accept late work. I also do not accept any assignments via email- NO EXCEPTIONS. All assignments are submitted through Canvas. Please

respect this policy. If you wait till the last minute, you are risking running into a roadblock and might miss your submission.

If you miss a test or assignment submission, you must provide me with an acceptable documented reason with 48 hours of the due date. The documentation must be emailed to lowens@uttyler.edu. The documentation must explicitly state the dates of excuse. For example, a doctor's documented illness explicitly stating the dates in which you were incapacitated. It will be up to my discretion to allow you to resubmit only is the documentation is acceptable.

If you have technical problems (e.g. locked out of account), you must supply me with screen shots and the work ticket you submitted to ITSUPPORT. I cannot guarantee I will let you make up the assignment. Please start early enough in the week to anticipate problems.

Please do not ask me to provide you extra opportunities. For example, every semester I get a few emails saying things such as, "I know you don't except late work, but..." or "I have X going on at home and just forgot...". I do not want to be put in a position of deciding if what is happening in your personal life is more important than another student's. Grade Replacement/Forgiveness and Census Date Policies:

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. (For Fall, the Census Date is Sept. 12.) Grade Replacement Contracts are available in the Enrollment Services Center or at http://www.uttyler.edu/registrar. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar. Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract. The Census Date is the deadline for many forms and enrollment actions of which students need to be aware. These include: • Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit. • Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date) • Schedule adjustments (section changes, adding a new class, dropping without a "W" grade) • Being reinstated or re-enrolled in classes after being dropped for non-payment • Completing the process for tuition exemptions or waivers through Financial Aid State-Mandated Course Drop Policy Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date). Exceptions to the 6-drop rule may be found in the catalog. Petitions for exemptions must be submitted to the Enrollment Services Center and must be accompanied by documentation of the extenuating circumstance.
