Course Catalog Description: This class examines issues and the importance of being a professional in the field of psychology, such as ethical decision making, integration of research and practice, and the business aspects of providing clinical services.

Student Learning Outcomes: After participating in the class, you will be able to:

- Describe potential career paths available after program completion
- Know the options for maximizing benefit within the program
- Understand how to take advantage of opportunities to develop clinical, research, and business skills relevant to practice

Requirements/Grading

1. Reflections 32% Throughout the course, you will be asked to complete brief reflection assignments where you consider an issue related to professional development in psychology.

2. Article Discussion Leader 10% Each of you will serve as a discussion leader for one article over the course of this class. In this role, you will summarize key points of the article you are discussing, raise key points relevant to professional development, and promote discussion of important issues.

4. Professional Path Presentation 36% You will work in groups to describe a professional development path and steps you are currently taking or plan to take to ensure that you are prepared to succeed in this endeavor. This may include national, state, and local professional organizations that you may become connected with and aware of and activities that develop your skills in a chosen domain (e.g., research, local organizations, types of practicum sites, and other information).

5. Knowledge of Research Principles 10% You will complete and submit the two certificates required by our IRB to conduct research at UT Tyler. These are 1) the Humanities, Social, Behavioral, and Education Sciences (RCR) and 2) Social & Behavioral Research Investigators.

6. Resume/CV 12% You will submit a copy of a resume/cv.

Artificial intelligence may not be used for assignments that involve reflecting upon your experience (e.g., your clinical judgment, planned career path, and so on should be your own). You may use artificial intelligence to help you brainstorm ideas and summarize information for other assignments. Use of artificial intelligence should be acknowledged and information reviewed for accuracy and modified. There are many examples where AI has provided inaccurate information and you are ultimately responsible for the content produced.

Missing Class and Late Work

Absences and late work are permitted with no penalty if these are due to unexpected circumstances outside of student control. These may include a number of situations, ultimately judged by the instructor, but examples of circumstances such as these include illness, death in the family, car accident, and similar. Circumstances, such as forgetting to submit work or planning a trip during class time, would generally not fall under the definition of unexpected circumstances outside student control.

Withdrawing from Class

Final Exam Policy

Final examinations are administered as scheduled. If unusual circumstances require that special arrangements be made for an individual student or class, the Dean of the appropriate college, after consultation with the faculty member involved, may authorize an exception to the schedule. Faculty members must maintain student final examination papers for a minimum of three months following the examination date.

Incomplete Grade Policy

If a student, because of extenuating circumstances, is unable to complete all of the requirements for a course by the end of the semester, then the instructor may recommend an Incomplete (I) for the course. The "I" may be assigned in place of a grade only when all of the following conditions are met: (a) the student has been making satisfactory progress in the course; (b) the student is unable to complete all coursework or final exam due to unusual circumstances that are beyond personal control and are acceptable to the instructor, and (c) the student presents these reasons before the time that the final grade roster is due. The semester credit hours for an Incomplete will not be used to calculate the grade point average.

The student and the instructor must submit an Incomplete Form detailing the work required and the time by which the work must be completed to their respective department chair or college dean for approval. The time limit established must not exceed one year. Should the student fail to meet all of the work for the course within the time limit, then the instructor may assign zeros to the unfinished work, compute the course average for the student, and assign the appropriate grade. If a grade has yet to be assigned within one year, then the Incomplete will be changed to an F, or NC. If the course was initially taken under the CR/NC grading basis, this may adversely affect the student's academic standing.

Grade Appeal Policy

Disputes regarding grades must be initiated within sixty (60) days from the date of receiving the final course grade by filing a Grade Appeal Form with the instructor who assigned the grade. A grade appeal should be used when the student thinks the final course grade awarded does not reflect the grades earned on assessments or follow the grading scale as documented in the syllabus. The student should provide the rationale for the grade appeal and attach supporting document about the grades earned. The form should be sent via email to the faculty member who assigned the grade. The faculty member reviews the rationale and supporting documentation and completes the instruction section of the form. The instructor should return the form to the student, even if a grade change is made at this level. If the student is not satisfied with the decision, the student may appeal in writing to the Chairperson of the department from which the grade was issued. In situations where there is an allegation of capricious grading, discrimination, or unlawful actions, appeals may go beyond the Chairperson to the Dean or the Dean's designee of the college from which the grade was issued, with that decision being final. The Grade Appeal form is found in the [Registrar's Form Library](#).

NOTE: The Grade Appeal Form is different from the Application for Appeal form submitted to the Student Appeals Committee, which does not rule on grade disputes as described in this policy.
