Course and Meeting Information

This course is fully online and asynchronous, meaning there are no course meetings, nor is there any one scheduled time that all students must do the same activity together. Assignments for each module may be submitted any time after they become available and before Sunday 11:59 pm of the assigned week. This course requires 6-9 hours of work per week.

This course is considered a Psychology Upper division elective. It is not required as part of your Psychology degree, but is highly encouraged if you plan on getting your PhD as many APA accredited PhD programs require a History of Psychology course as a pre-requisite for admission (including the PhD program at UT Tyler).

Course Catalog Description

An introduction to the history of psychology from its beginnings in pre-Socratic philosophy through the crucial years of the nineteenth century to the recent past and present. Attention is given to competing schools and systems of psychology, psychology’s standing as a science, and the role of marginalized groups in the history of the discipline.

Student Learning Outcomes

Content

At the end of this course you should be able to master course content (remembering and understanding) in major areas such as

- early philosophers across the globe
- the beginnings of modern science and philosophy;
- empiricism, sensationalism, and positivism;
- the rise of experimental psychology;
- voluntarism and structuralism;
- the Darwinian influence; functionalism;
- early views of mental illness;
- psychoanalysis, behaviorism, humanism, general systems theory, and postmodernism;
- ethnic minority psychology, and queer psychology, and the psychology of women.

Contacting Me

Personal meetings. To meet with me, please attend one of my office hours. I will hold office hours virtually each week at the designated time. Please email me if my office hours do not work and we can schedule another time to meet. You do not have to attend office hours if you do not need the help. The easiest way to get ahold of me is over email. For many of you, I am also your academic advisor. Please do not schedule time to meet through the advising scheduling system to discuss this course. Structure of Course

This course is online and taught asynchronously. This means that there is not a designated time that the class “meets.” You will be responsible for pacing yourself throughout. Each week on Monday at 8am, the next week’s module will open and you will be able to access the coursework, lectures, etc. You will not be able to complete more than that week. Once a week ends, the course will lock and you will be unable to access the quizzes/assignments to be graded.

Transparency Statement: Please note that as a professor, I can see how long you are in your CANVAS modules, when you submit quizzes, how long it took you to complete quizzes and if your quizzes were completed at the same time as your peers.

I do not round grades. You will have plenty of opportunities to earn points in this course and your final grade is one you earn. The last opportunity to earn points is the final exam day. If you have a concern about a grade at any time, please email me ASAP about your issue and type up the justification (with textbook or other evidence) for why I should count your answer I marked wrong. **Grade change requests without a full paragraph of written justification with evidence will be ignored.**

Extra credit. You may earn extra credit by participating in the following ways:

1. SONA research—for every hour of SONA research that you complete you will receive 2 extra credit points
2. Participation in the Psychology & Counseling Training Clinic—for every hour of counseling that you participate in you will receive 2 extra credit points. The clinic requires that you participate in a minimum of 5 hours to receive credit. If by chances you

are deemed “inappropriate” for the clinic, you will not be able to receive extra credit for counseling services.

3. Famous Psychologist Paper—you can receive the full 20 points if you write a 4-5 page paper that covers a famous psychologist and their effect on history. More details concerning this paper will be posted on Canvas. You will need to turn in/complete this paper by April 4, 2021 if you wish to receive credit.

Please note the maximum amount of extra credit that you can receive is 20 points, or 2% of your overall grade.

Assignments:

1. Weekly Quizzes (10 points each, 15 total quizzes)—each week you will have a quiz that is due by Sunday at 11:59pm that covers the readings and the lecture for the week. These quizzes will be multiple choice and will be on Canvas. They will be timed. You will have 10 minutes to complete each quiz so knowing the material before starting the quiz will be very important! Your syllabus quiz as well as an end of the semester quiz will be included in these 15 quizzes.
2. Social Bookmarks (10 points each, 10 total)—you will be asked to create “Social Bookmarks” for various topics throughout the semester. These will be due by Sunday at 11:59pm of that given week. More details concerning bookmarks will be posted on Canvas. The rubric is located on the Files tab of your Canvas course.
3. Exams (125 points, 4 total)—Each exam will be a multiple-choice exam that will cover the previous 3-4 weeks’ worth of content (readings, slides, videos). The exams will take place over Canvas. You will have 60 minutes to complete each exam.
4. Psychological Disorder Paper (250 points)—You will need to write a 6-8 page paper in which you will choose a psychological disorder and discuss the history, implications, changes, and treatment of this disorder over time. More details concerning this paper will be posted on Canvas. The rubric is located on the Files tab of your Canvas course. It is highly recommended that you start working on this course early in the semester. Do not wait until the week it is due!

Grade Replacement/Forgiveness and Census Date Policies

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. Grade Replacement Contracts are available in the Enrollment Services Center or <http://www.utt Tyler.edu/registrar>. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar.

Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract. The Census Date is the deadline for any forms and enrollment actions that students need to be aware of. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refund for partial withdrawals. (There is no refund for these after the Census Date)
- Schedule adjustments (session changes, adding a new class, dropping without a "W" grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment
- Completing the process for tuition exemptions for waivers through Financial Aid.

State-Mandated Course Drop Policy

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date). Exceptions to the 6-drop rule may be found in the catalog. Petitions for exemptions must be submitted to the Enrollment Services Center and must be accompanied by documentation of the extenuating circumstance. - Possession during a test of materials which are not authorized by the person giving the test, such as class notes or specifically designed "crib notes." The presence of textbooks constitutes a violation if they have been specifically prohibited by the person administering the test;

 - Collaborating with or seeking aid from another student during a test or other assignment without authority;
 - Discussing the contents of an examination with another student who will take the examination;
 - Divulging the contents of an examination, for the purpose of preserving questions for use by another, when the instructor has designated that the examination is not to be removed from the examination room or not to be returned or to be kept by the student;
 - Substituting for another person, or permitting another person to substitute for oneself to take a course, a test, or any course-related assignment;
 - Paying or offering money or other valuable things to, or coercing another person to obtain an unadministered test, test key, homework solution, or computer program, or information about an unadministered test, test key, homework solution or computer program;
 - Falsifying research data, laboratory reports, and/or other academic work offered for credit;
 - Taking, keeping misplacing, or damaging the property of U. T. Tyler, or of another, if the student knows or reasonably should know that an unfair academic advantage would be gained by such conduct; and,
 - Misrepresenting facts, including providing false grades or resumés, for the purpose of obtaining an academic or financial benefit or injuring another student academically or financially.
- (ii) “Plagiarism” includes, but is not limited to, the appropriation, buying, receiving as a gift, or obtaining by any means another’s work and the submission of it as one’s own academic work offered for credit.
- (iii) “Collusion” includes, but is not limited to, the unauthorized collaboration with another person in preparing academic assignment offered for credit or collaboration with another person to commit a violation of any section of the rules on scholastic dishonesty.
- (iv) All written work that is submitted will be subject to review by plagiarism software.
