METHODS OF INSTRUCTION

This is an online course. You are expected to attend all scheduled online lectures as outlined in class schedule. It is expected that you will spend an average of 6+ hours working on course materials. The course materials will be housed on CANVAS. This class will consist of a collaborative learning community in which all participants share responsibility for the learning process. The instructor will facilitate learning by lecture, guiding students to sources of knowledge, and promoting independent development and discovery of new knowledge. Online learning requires participation and leadership from each student. Lectures, videos, assigned readings, and online activities will provide a basis for discussion. Academic integrity is expected from each student and plagiarism from any source will not be tolerated.

CANVAS (https://www.uttyler.edu/canvas/) will serve as the overall structure and launching pad for all our activities in this course. In CANVAS, you will find announcements, assignments, course schedule, discussion boards, links to outside activities and so on. It is students'

responsibility to examine CANVAS materials and get in touch with the instructor immediately if they are not clear about the requirements prior to assignment due dates.

COURSE POLICIES

All assignments and quizzes are due by Sunday 11:59 pm Central Time as outlined in the class schedule. All assignments are submitted on CANVAS. Please DO NOT email or turn in hard copies of your assignments to the instructor. You are responsible for uploading the correct version of your assignment to correct location on CANVAS. Late assignments will not be graded unless an unexpected adverse event is communicated to the instructor 24 hours in advance and permission is granted or as soon as possible with documentation and permission. Even in the case of the student providing documentation and getting permission from the instructor, assignments submitted after the due date will receive a 10% grade deduction for each day up to 3 days. In other words, one day late submitted exemplary assignment which would have been graded 100% will be graded as 90% and so forth. The work can be submitted max three days late and an assignment might receive min of 70% of the grade. Thus, work submitted later than the third day will not be accepted and will receive a zero even with an excuse. I highly suggest students to be proactive and work on assignments a head of time.

COURSE ASSIGNMENTS

- 1. <u>ATTENDANCE</u>: While it is strongly recommended that you do not miss any classes, you are permitted to miss one class (2.5 hours) with no penalty. If you are going to miss a class, it is expected that you will notify the professor ahead of time. After the first excused missed class, along with missing participation and professionalism points, for each missed class students will lose additional 5 points from their overall grade. All absences must be discussed with the instructor prior to the class missed.
- 2. <u>PARTICIPATION & PROFESSIONALISM</u>: Learning/teaching is a dynamic social process. In this class, your presence and active engagement are essential. Students are required to <u>read all assigned course materials before class begins</u>, so that they can <u>actively engage</u> with course content during class. Students are expected to regularly participate in class.

Students are expected to attend classes on time. Students who are consistently late at the beginning of class will have points deducted from their participation grade. Late behavior in excess of one class will result in a drop of attendance and participation points for each incident. Professionalism will be evaluated through students' communication (i.e., email, in-person) and interaction with the instructor and their peers.

The CMHC program at UT Tyler is a face-to-face program that is temporarily functioning virtually due to the COVID-19 Pandemic. We look forward to being back in the classroom with all of you soon, until then though, to ensure we are facilitating a meaningful virtual learning environment for all of you, we have the same expectations for students attending synchronous zoom classes that we would for students attending an in-person class. As such,

we (the CMHC faculty) thought it would be helpful to share our expectations of students during synchronous portions of class (e.g., zoom based classes).

- (1) We expect that students will fully attend each class from the start time to the end time of class. Being in attendance for a zoom class means that a student has their camera turned on for the entire duration of class. Students are expected to attend classes on time. Students who are consistently late at the beginning of class will have points deducted from their participation grade.
- (2) We expect that students exhibit the same professional behaviors during class time that would be expected in an in-person class. That includes sitting up right (i.e., not laying down), being awake and alert, and participating during class. Communicating possible absences or issues to the instructor in a professional written or in person format.
- (3) We expect that students are able to find an appropriate environment to participate in class. An appropriate environment is one that is free from distraction and has privacy from other individuals (i.e., friends, family members, children).
- 3. QUIZES: You will take five (5) quizzes in this course that will cover lecture material and reading assignments. The quizzes will review topics, vocabulary, and basic understanding and will be multiple choice, matching, and true/false in format. The quizzes will be open for a period of 96 hours (Thursday at 8:00 pm through Sunday 11:59 pm the week they are indicated on the class schedule). You can choose anytime to take the quizzes during that time period. Make sure to give yourself enough time to complete quizzes as all quizzes will stop at 11:59 pm, regardless if you have completed it or not.

You can take each quiz only once. There are no proctoring systems being used for the quizzes in this course, as such, I'm aware that you will have access to your class materials. Therefore, I'm limiting the time you have to complete each quiz to 30 minutes. It will, therefore, be advantageous for you to be familiar with the materials before taking the quizzes, because you will not have enough time to use your resources to help you with all items.

Please know, if I hear of students working together on the quizzes, sharing exam information, or being in contact with each other while taking the exam, you will earn an F in this course and not be permitted to take it for grade replacement.

4. ARTICLE REVIEW: This assignment designed to assess your skills on identifying a topic of interest, finding articles related to that topic from different methodologies.

You are expected to identify three peer-reviewed counseling articles on a counseling related topic that you are interested in. Each article should represent one of the research designs (one qualitative, one quantitative, and one mixed-method). These articles should be published within the last 10 years (oldest year accepted 2011) in a counseling journal (Journal of Counselor Development, Counselor Education and Supervision, etc. Please refer to the list of counseling journals if you need help identifying journals). The article review paper should be 1-2 pages (not including title page and references) follows APA 7 guidelines (title page, running head, in-text citation, references, formatting, etc.) and should include the information below for each article:

• Complete citation using APA 7

- A half-page description for each article addressing the following questions:
 - o Why did you choose this article?
 - What is the research question?
 - o What are the research design, data, and statistical analysis utilized?
 - o Key findings
 - o Strengths and limitations of the study

Make sure to select articles on a topic(s) that are interesting to you or you would like to learn more on because you will complete your final paper on one of these articles of your choice.

FINAL PAPER: This assignment is designed to assess skill acquisition in regards to being able to read, understand, and critique articles from the counseling field. More details of the final paper will be discussed in class. Each student will complete an article critique as the final paper. Articles may reflect a variety of research methodologies (i.e., quantitative or qualitative, mixed method). Students are expected to evaluate all sections of the article (i.e., the introduction/literature review, research design, sampling procedures, and measurement and data collection procedures of the study, results, and discussion/conclusion). Details for each section are described in the Final Paper Instructions (available on CANVAS>Assignments).

EXTRA CREDIT OPPORTUNITIES

Mid-term feedback and final class evaluations are the extra credit opportunities. Each option will reward student with 1 point when the student email a screenshot of completion page to the instructor. More details will be discussed in class. I do not round up, so to ensure you are receiving the grade you are hoping for please make sure to utilize every opportunity for extra credit.

GRADING

During the semester, you will have opportunities to earn up to 100 points. Grading is on the following scale: 100% - 90% = A; 89% - 80% = B; 79% - 70% = C; 69% or less = F.

Grade Replacement/Forgiveness and Census Date Policies

Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are

The Census Date is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment
- Completing the process for tuition exemptions or waivers through Financial Aid

State-Mandated Course Drop Policy

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date).
