#### **COURSE CATALOG DESCRIPTION**

This is a clinical skills course emphasizing the acquisition of therapeutic helping relationship skills and interviewing through role playing and modeling. Video and audio feedback as well as direct supervision is provided.

This course will serve as a bridge between the study of the theories and systems of counseling and the supervised practice of counseling. Students will learn more about themselves in relation to others while also learning beginning techniques for clinical interviewing. In addition to didactic learning, students will engage in role play and digitally record their interviewing and counseling techniques. Instructor and peer feedback will be given. This course will equip students with basic skills to develop and maintain helping relationships.

#### **COURSE POLICIES**

Online lecture, discussion, reading and writing assignments, guided practice and role-plays, class activities, videotaping and reviewing, and other experiential activities. Self-reflection, self-evaluation, and offering and receiving feedback are important instructional methods in this course.

\*\*You will be in a client role and in a counselor role in different role-plays, recordings, and activities in this course. These roles are essential and mandatory to your learning, demonstration, and assessment of counseling skills. If you are not prepared to engage in these roles, you are recommended to drop this course, as it will negatively influence your grade. What you share in these role-plays is entirely up to you and your comfort level; be aware that recordings might be reviewed with the whole class. As such, all students are held to the highest privacy and confidentiality standards and must abide by the current ACA code of ethics.

#### **COURSE ASSIGNMENTS:**

In all aspects of your transition from student to professional we will work together to *supporting you* and challenging you to expand your knowledge base, to increase your breadth and depth of skill, and to improve your attitudes and dispositions related to your work. In order to provide structure to this assessment the following points have been assigned to portions of your performance. In this class you are expected to *demonstrate mastery of the appropriate skills, complete assignments in a timely* fashion, demonstrate an awareness of and adherence to ethical decision-making processes, and demonstrate an attitude of seeking excellence in your therapeutic skills. Points in this course can be earned through professionalism, role plays and related assignments.

- 1. <u>ATTENDANCE</u>: Student attendance in this class is critical. It is expected that students will attend <u>all classes</u>. In case of missed class students will lose participation and professionalism points. After the first missed class, along with missing participation and professionalism points, for each missed class students will lose 10pts. All absences must be discussed with the instructor prior to the class missed. <u>Missing more than one class may result in an "IP" or "NC"</u> for the class unless otherwise determined by the professor.
- 2. <u>PARTICIPATION & PROFESSIONALISM</u> (24 points): Learning/teaching is a dynamic social process. As this is a clinically oriented course, your presence and active engagement are essential. Students are required to <u>read all assigned course materials before class begins</u>, so that they can <u>actively engage</u> with course content during class. Students are expected to regularly participate in class and will be required to participate in experiential learning activities.
  - To ensure we are facilitating a meaningful virtual learning environment for all of you, we have the same expectations for students attending synchronous zoom classes that we would for students attending an in-person class.
  - (1) We expect that students will fully attend each class from the start time to the end time of class. Being in attendance for a zoom class means that a student has their camera turned on for the entire duration of class.
  - (2) We expect that students exhibit the same professional behaviors during class time that would be expected in an in-person class. That includes sitting up right (i.e., not laying down), being awake and alert, and participating during class.

(3) We expect that students are able to find an appropriate environment to participate in class. An appropriate environment is one that is free from distraction and has privacy from other individuals (i.e., friends, family members, children). This is essential in clinical courses and courses with large group discussion components, as confidential information is discussed that is not appropriate for others to hear.

3. **ROLE PLAYS:** Throughout the semester, students are required to complete a series of five role plays to demonstrate their counseling skills. Each role play will be recorded in Zoom and recording link will be submitted to the CANVAS Assignment section along with all the other documents required for each assignment (counseling skills evaluation, counseling skills reflection form, SOAP notes, intake report, and transcripts). Formats for these written assignments will be posted on Canvas. Additional information will be discussed in class prior to each recording.

#### LATE ASSSIGNMENT POLICY

Students responsible to follow the due dates for each assignment which are published on the course syllabus. Work turned in by 11:59 PM Central Standard Time on the due date, as evidenced by the date stamp given on the CANVAS, will be considered on time and will receive full credit. Prompt submission of assignments for assessment allows the instructor to provide guidance and timely

feedback.

Assignments submitted after the due date will receive a 10% grade deduction for each day up to 4 days. In other words, one day late submitted exemplary assignment which would have been graded 100% will be graded as 90%. Work submitted after four days past the original due date will not be accepted and will receive a zero.

#### EXTRA CREDIT OPPORTUNITY

Mid-term feedback and Final class evaluation are the extra credit opportunities. Each option will be discussed in class. Each option will reward student with 1 point when the student completes the necessary steps and informs the instructor.

**COURSE.** Students who earn less than 80 points will receive either a No Credit (NC) or In Progress (IP) depending on their course performance. #### **COURSE POLICIES AND REQUIREMENTS**

#### **COUNSELING ROLE PLAY POLICIES**

Role-play in the classroom setting is essential to simulating the counseling experience and demonstrating the traditional counseling format. Role plays will be conducted in dyads, in and outside of class, and recorded through zoom for supervision purposes. It will be necessary for students to perform the role of counselor and client to create authenticity in content, verbal, and non-verbal behaviors in the role play sessions.

Information shared during role-plays is considered confidential. Students should not discuss role plays outside of class with other students of the class or with others. It should be remembered that students/counselors-in-training are not providing personal counseling or therapy. In order to maintain proper academic boundaries and not move into the realm of personal counseling, students are encouraged not to use current personal issues that may cause embarrassment or unnecessary emotional distress to themselves or others. Students who find themselves needing further services due to issues which arise in the practice of role play should take advantage of services offered at the UT-Tyler Student Counseling Center or pursue private services.

#### INFORMED CONSENT STATEMENT

Faculty members are dedicated to the educational, personal, and professional growth and development of our students. Faculty are in a unique position as both instructors who assess students' academic skills and members of the counseling profession with an ethical obligation to the profession. In both of these roles, it is the faculty's responsibility to evaluate student competencies within the realm of professional counseling and to address any concerns regarding students' professional competence. As such, please be aware of the following information regarding this course:

- The counseling profession encourages that counselors fully integrate their own personal attributes and identity, as well as their strengths and weaknesses, into therapeutic processes. Therefore, self-awareness is critical because this knowledge relates to being an effective therapist.
- There will be an emphasis in many courses on self-awareness/exploration, as well as giving feedback to peers. Although uncomfortable at times, we encourage students to be open to self-exploration, since we frequently ask clients to do so.
- At times, class may include experiential and self-awareness exercises. It is important to distinguish between sharing one's emotional reactions to such experiential class activities and revealing information about one's personal history. Self-disclosure of personal history is not required in order to successfully pass any course; however, students may be expected to share their reactions to experiential activities.
- Self-disclosures will not be used as a basis for grading in any course. However, should a student disclose information indicating impairment or the potential for harm to clients, the faculty member may take appropriate action in accordance with the ACA Code of Ethics (2014).
- Students often experience personal growth as they progress through the program.
   However, the courses are not meant to be means of personal therapy.

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. (For Fall, the Census Date is Sept. 12.) The Census Date is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment
- Completing the process for tuition exemptions or waivers through.

#### FINANCIAL AID STATE-MANDATED COURSE DROP POLICY
