Evaluation activities

- Exam: There will be 3 Take Home Exams with recorded presentations during the semester. 1st Exam is a review assignment that covers Differential Equations including Laplace Transform concepts. Take home Exam 2 covers the material in first half of the semester and Take home Exam 3 covers the material over the entire semester (comprehensive exam). No late submission will be accepted and will result in automatic

- grade of zero. Make-up exams/presentations if approved by instructor will be administered during finals week.
- Project: Each student will choose a complex dynamic system to model and control. Students may choose to collaborate with classmates to form a group (max 5 students) by informing the instructor no later than 6th week of class. Instructor will assign a set of complex dynamic system project for students to choose from, but if a student wants make up own project then must let instructor know for further directions no later than 3rd week of class. Each student/group analyzes the project and simulate the models of the subsystems and system using MATLAB and Simulink® to then submit reports. The average of the 3 oral project reports (video recorded) result in the project grade (no peer evaluation factor is considered). Instructions on the report format/style, grading rubric form and checklist will be posted separately.
 - Assignments, Class Participation and Conduct: Attendance and participation to lectures are expected per university policy. Check class and Canvas regularly for any announced assignments including Exams according to the topics covered in lectures. Short lecture videos on each topic or chapter will be posted on Canvas as announced for review to receive completion grade. Questions involving knowledge covered in class can be checked if your work is shown to the instructor, but no solutions will not be given outright. Come prepared to class by reviewing relevant material, bringing textbook, taking notes, solving problems and participating in discussions, which are all expected. Any violation of the Student Behavior (see below) will result in 1% grade reduction for each incident. Students may appeal the grade reduction to the instructor if valid excuse or reason can be given.

Note: Instructions on the oral/video report format/style, checklist and grading rubric form will be posted separately on Canvas. Late submissions of assignments will result in 10% deduction from the graded score after each 24-hour period. All late assignments along with any optional bonus activities must be submitted on Canvas by last day of class (Dec 3, Thursday at 5pm).

Grade appeal: grades can be appealed by meeting the instructor during office hours, but no later than a week after the grade has been posted.

9. Grade Replacement/Forgiveness and Census Date Policies

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. Grade Replacement Contracts are available in the Enrollment Services Center or at <http://www.uttlyler.edu/registrar>. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar.

Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.

The Census Date is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment
- Completing the process for tuition exemptions or waivers through Financial Aid

10. State-Mandated Course Drop Policy

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date).

Exceptions to the 6-drop rule may be found in the catalog. Petitions for exemptions must be submitted to the Enrollment Services Center and must be accompanied by documentation of the extenuating circumstance. Please contact the Enrollment Services Center if you have any questions.
