### Evaluation activities

- Exams: There will be two timed, in-class exams during the semester. Exam 1 covers the material in first half of the semester and Exam 2 covers the material in the second half of the semester. No late submission for exams will be accepted and will result in automatic grade of zero. Make-up exams if approved by instructor will be administered during finals week.
- Group Project: engineering teams of max 5 students will work on a project assigned by the instructor. Each team proposes analyzes the project and simulate the model(s) using MATLAB and Simulink® to then submit reports. The average of the 2 oral reports (video and in-class recorded) result in the project grade after it is multiplied by the Peer and

Instructor Evaluation factor for final project grade. Instructions on the report format/style, grading rubric and peer evaluation form will be given separately

- Class Assignments and Conduct: Attendance and participation to lectures are expected per university policy. Check class and Canvas regularly for any announced assignments including Quizzes according to the topics covered in lectures. Questions involving knowledge covered in class can be checked if your work is shown to the instructor, but no solutions will not be given. Come prepared to class by reviewing relevant material, bringing textbook, taking notes, solving problems and participating in discussions, which are all expected. Any violation of the Student Behavior (see below) will result in 1% grade reduction for each incident. Students may appeal the grade reduction to the instructor if valid excuse or reason can be given.

Note: Instructions on the written and oral report format/style, grading rubric and peer evaluation form will be given separately on Canvas. Late submissions of assignments will result in 10% deduction from the graded score within 24 hours and 50% deduction of the graded score after 24 hours until late last day of class. All late assignments along with any optional bonus activities must be submitted on Canvas by last day of class (Thursday at 5 pm).

Grade appeal: grades can be appealed by meeting the instructor during office hours, but no later than a week after the grade has been given.

### **Grade Replacement/Forgiveness and Census Date Policies**

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. Grade Replacement Contracts are available in the Enrollment Services Center or at <http://www.uttlyler.edu/registrar>. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar.

Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.

The Census Date is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment
- Completing the process for tuition exemptions or waivers through Financial Aid

### **State-Mandated Course Drop Policy**

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date).

Exceptions to the 6-drop rule may be found in the catalog. Petitions for exemptions must be submitted to the Enrollment Services Center and must be accompanied by documentation of the extenuating circumstance. Please contact the Enrollment Services Center if you have any questions.

- collaborating with or seeking aid from another student during a test or other assignment without authority;
- discussing the contents of an examination with another student who will take the examination;
- divulging the contents of an examination, for the purpose of preserving questions for use by another, when the instructors has designated that the examination is not to be removed from the examination room or not to be returned or to be kept by the student;

- substituting for another person, or permitting another person to substitute for oneself to take a course, a test, or any course-related assignment;
  - paying or offering money or other valuable thing to, or coercing another person to obtain an unadministered test, test key, homework solution, or computer program or information about an unadministered test, test key, home solution or computer program;
  - falsifying research data, laboratory reports, and/or other academic work offered for credit;
  - taking, keeping, misplacing, or damaging the property of The University of Texas at Tyler, or of another, if the student knows or reasonably should know that an unfair academic advantage would be gained by such conduct; and
  - misrepresenting facts, including providing false grades or resumes, for the purpose of obtaining an academic or financial benefit or injuring another student academically or financially.
- ii. “Plagiarism” includes, but is not limited to, the appropriation, buying, receiving as a gift, or obtaining by any means another’s work and the submission of it as one’s own academic work offered for credit.
- iii. “Collusion” includes, but is not limited to, the unauthorized collaboration with another person in preparing academic assignments offered for credit or collaboration with another person to commit a violation of any section of the rules on scholastic dishonesty.
