**COURSE DESCRIPTION:** This course introduces the student to global health concepts and to the network of organizations and agencies working to promote health and prevent disease globally. Emphasis for this course is on the global burden of disease and the determinants of health in diverse populations, cultural settings, and different regions of the world. Students will explore the many facets of the global health programs, including the ways in which economics, political processes, environmental and social global social-cultural changes in society, impact

health outcomes and the delivery of health services to individuals and populations. The course will provide the student with a broad introduction to programs, systems and policies affecting global health with a focus on major health and health-related challenges of developing, resource-constrained and emerging nations and ways of finding solutions to address these challenges by individual countries, consortiums and global health partners.

### **Course Goal:**

1. To help students develop a greater understanding of diversity in health dimensions among human populations and how context is key to health around the world.
- 2). Introduce students to the concept of globalization of health and trends towards a global village in which continents and countries are interdependent in many ways and local health is global health just as global health is local health.
3. To provide students with basic skills and knowledge that will help them to work effectively locally or abroad in health-related agencies, organizations or private enterprises that provide health services to individuals and groups from diverse cultural backgrounds.

### **Course Objectives:**

By the end of the course, the student will be able to:

- Describe global demographic and health transitions and determinants of health.
- Identify global Measures of the Burden of disease in different age brackets and contexts.
- Discuss the major communicable and non-communicable disease burdens that impact global health.
- Discuss the significance of Millennium Development Goals (MDGs 2015) and the progress to Sustainable Development Goals (SDGs 2030).
- Describe the missions and activities of the major organizations and agencies currently engaged in health-related work on a global level.
- Discuss strategies in global health implementation, major trends in global health, and challenges.
- Explore the diverse careers and inter-professionalism in global health.

### **Course Format:**

The course outline given within this Syllabus shows weekly chapters but other activities for the course are indicated in the weekly modules online in Canvas. There could be some changes if a need arises and they will be communicated to you in a timely manner, however, these will be minimized as much as possible. Therefore, we consider our Syllabus tentatively finalized *but with room for flexibility if, and when necessary.*

The course is offered in **a 5-week period**, fully (100%) online in a virtual platform Canvas LMS. It requires you allocate specific time for this course on your timetable daily to work on your study and completion of assignments. ***Each student should read specific text chapters, watch given videos, and other assigned class materials/documents as well as complete each chapter quiz and any other assignments by the end of each weekly module.*** Every student should have their own textbook as required, and any other required materials/documents for the course where indicated. Each student is encouraged to be resourceful and read widely materials related to or those that enrich our understanding of global health issues beyond the class materials indicated in this course. Your progressive grades as well as the final grade reflect your learning readiness and preparation, class participation and personal initiative within the course.

### **Course Schedule**

The schedule for weekly readings, activities, and assignments for the entire course is posted in this syllabus below. Details and instructions for each module assignments are given in Canvas LMS. These are organized in weekly modules. Each module ends on Sundays at midnight. Assignments for each module are due by end of each module dates. *There are no weekly reminders for completing your work so please stay on top of your work and consult the course schedule regularly.*

Please reach out for any clarifications and/or appropriate assistance as needed. Do this in a timely manner to meet your deadlines.

### **Submission of Assignments**

Deadlines for submission and/or presentation of the assignments are provided in Canvas within each module. Late assignment completion and submission will not be accepted and so no grades for that unless you have a valid reason and had prior permission from the instructor.

Assignments' deadlines are scheduled with adequate time, you can complete in advance of the deadline so all work should be completed/submitted by/or before the deadline.

### Grade Replacement/Forgiveness and Census Date Policies

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment on or before the Census Date of the semester in which the course will be repeated. Grade Replacement Contracts are available in the Enrollment Services Center or at <http://www.uttyler.edu/registrar>. Each semester's Census Date can be found on the Contract itself, on the Academic Calendar, or in the information pamphlets published each semester by the Office of the Registrar.

Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract.

The Census Date (Check the Academic Calendar) is the deadline for many forms and enrollment actions of which students need to be aware. These include:

- Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.
- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- Schedule adjustments (section changes, adding a new class, dropping without a “W” grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment
- Completing the process for tuition exemptions or waivers through Financial Aid

### **State-Mandated Course Drop Policy**

Texas law prohibits a student who began college for the first time in Fall 2007 or thereafter from dropping more than six courses during their entire undergraduate career. This includes courses dropped at another 2-year or 4-year Texas public college or university. For purposes of this rule, a dropped course is any course that is dropped after the census date (See Academic Calendar for the specific date).

Exceptions to the 6-drop rule may be found in the catalog. Petitions for exemptions must be submitted to the Enrollment Services Center and must be accompanied by documentation of the extenuating circumstance. Please contact the Enrollment Services Center if you have any questions.
