Course Description: A required internship to provide an opportunity for each student to work in a public health setting in a position that carries responsibility and is of particular interest. Each placement is different, but all depend upon completion of most concentration coursework, the ability to work with minimal supervision, and permission of the student's faculty advisor and the faculty practicum coordinator. A total of 135 hours of effort is expected during the semester for satisfactory course completion.

Prerequisite: Completion of most concentration coursework. **Co-requisite:** None. Basic HIPAA/HIPS, Responsible Conduct of Research (Social and Behavioral) and Human Subjects Training

Student Learning Outcomes (SLO or "course objective"):

- 1. Develop a work plan with the preceptor and the practicum instructor identifying specific practicum objectives, activities/projects, and observational opportunities.
- 2. Develop practicum on-site schedule.
- Work immersed in a public health setting to gain an understanding of the organizational culture, mission, structure, processes and community/people served.
- 4. Complete activities, tasks, projects and observational opportunities as assigned.

Academic Honesty:

Any student who commits an act of scholastic dishonesty is subject to discipline. Cheating

<u>Plagiarism</u>

Plagiarism is presenting the words or ideas of another person as if they were your own. Materials, even ideas, borrowed from others necessitate full and complete acknowledgment of the original authors. Offering the work of another as one's own is plagiarism and is unacceptable in the academic community. A lack of adequate recognition constitutes plagiarism, whether it utilizes a few sentences, whole paragraphs, articles, books, audio-visual materials, or even the writing of a fellow student. In addition, the presentation of material gathered, assembled or formatted by others as one's own is also plagiarism. Because the university takes such misconduct very seriously, the student is urged to carefully read university policies on Misconduct in Research and Other Scholarly Activity 05.00. Examples of plagiarism are:

- Submitting an assignment as if it were one's own work when, in fact, it is at least partly the work of another.
- Submitting a work that has been purchased or otherwise obtained from an Internet source or another source.
- Incorporating the words or ideas of an author into one's paper without giving the author due credit.



Adding/Dropping:

The official deadline for adding and dropping courses is as published in the academic calendar and Graduate Bulletin (typically the day before Census Day). However, students are strongly encouraged to meet with their graduate advisor or the Program Coordinator prior to adding/dropping courses. Movement into and out of classes after the 4th class day requires approval of the Program Director. Students can drop until mid-semester without a WP or WF. Drops after mid-semester require approval of the Dean. Each student is responsible for their own enrollment status with the university.
