**Course Description: Application** of client-centered outcomes in evaluation for older adulthood practice including neurological, musculoskeletal, general medical and acquired conditions. Practice and application of standardized assessments and service delivery.

## 2018 standards course objectives

- 1. Use theories, models of practice, and frames of reference to guide and inform evaluation and intervention.
- 2. Recognize underlying components of middle and older adults' occupations and how to grade/adapt occupational to facilitate participation and engagement.
- 3. Select, administer, analyze, interpret, document, and report results of standardized and non-standardized screening and assessment tools to patients, families, and other professionals.
- 4. Plan evaluation processes for a variety of cases, including roles of OTR and COTA within desired treatment plan.
- 5. Apply foundational knowledge, previous professional experiences and new academic learning to fieldwork and community engagements to meet the needs of clients in various contexts and cultures reflecting ethical practice.

#### Connection to the MOT Curriculum

#### **Essential knowledge and Professional Skills**

The third of three courses focusing on essential knowledge and professional skills in evaluation and assessment across the lifespan, this course focuses on

assessment and communication of conditions and abilities in the middle and older adult population. Within the middle and older adult populations, the student will employ previous knowledge regarding older adult practice and refine skill sets in assessment and evaluation. Focus

#### **Grade Replacement/Forgiveness and Census Date Policies**

Students repeating a course for grade forgiveness (grade replacement) must file a Grade Replacement Contract with the Enrollment Services Center (ADM 230) on or before the Census Date of the semester in which the course will be repeated. Failure to file a Grade Replacement Contract will result in both the original and repeated grade being used to calculate your overall grade point average. Undergraduates are eligible to exercise grade replacement for only three course repeats during their career at UT Tyler; graduates are eligible for two grade replacements. Full policy details are printed on each Grade Replacement Contract. The Census Date (Sept. 12th) is the deadline for many forms and enrollment actions of which students need to be aware.

These include:

 Submitting Grade Replacement Contracts, Transient Forms, requests to withhold directory information, approvals for taking courses as Audit, Pass/Fail or Credit/No Credit.

- Receiving 100% refunds for partial withdrawals. (There is no refund for these after the Census Date)
- Schedule adjustments (section changes, adding a new class, dropping without a "W" grade)
- Being reinstated or re-enrolled in classes after being dropped for non-payment
- Completing the process for tuition exemptions or waivers through Financial Aid.

# **State-Mandated Course Drop Policy**

- 1. "Cheating" includes, but is not limited to:
  - Copying form another student's test paper,
  - using, during a test, materials not authorized by the person giving the test;
  - failure to comply with instructions given by the person administering the test;
  - possession during a test of materials which are not authorized by the person giving the test, such as class notes or specifically designed "crib notes". The presence of textbooks constitutes a violation if they have been specifically prohibited by the person administering the test;

  - falsifying research data, laboratory reports, and/or other academic work offered for credit;
