# **Course Description**

This laboratory course focuses on the application of skills and resources needed for pharmacists to effectively provide patient care in the outpatient setting.

#### **Additional Course Information**

This course will expand upon the foundational pharmacy patient care skills taught in the curriculum thus far at an advanced level. This course will prepare the student for experiential rotation in the outpatient setting by enhancing their skills on medication therapy management, point of care testing, patient and provider communications, prescription dispensing, and working up patients with more complex medical and personal issues. This course will also include successful completion of the ComMIT Motivational Interviewing online module series.

### **Grading Policy & Grade Calculation**

Grades will be determined based on evaluation of individual and team readiness assessment tests (iRATs, tRATs), individual and team cumulative assessment tests (iCATs, tCATs), midterm examinations, final written examinations, skills assessments, graded application assignments, participation in team-based projects, peer evaluations and other assessment methods that may include, but not limited to, Objective Structured Clinical Examinations (OSCE). Examinations, RATs and CATs may consist of, but not limited to, multiple-choice, true/false, fill in the blank, shortanswer, essay, and problem-based questions.

During the time the course is in progress, students whose cumulative course percentage falls below 75.0% *may* receive an academic alert and be subject to periodic course content review in special sessions with the course instructor(s). The student's faculty advisor may receive an academic alert to act upon on the student's behalf.

All examinations, tests, and assignments, including the final examination, may be **cumulative**. Students are responsible for material presented during the prior courses. The grading scale for all graded material is below. The final course grade will be assigned according to the calculated percentage and the percentages will not be rounded upward or downward. For additional information, see examination/assessment policy below.

**Professionalism:** Professionalism will total 5% of the final lab grade. *Each week, a score of 100% may be earned or lost.* Demeanor, enthusiasm, neatness, laboratory technique, and punctuality will be evaluated. Points from score will be deducted for dress code infractions, for poor demeanor/attitude in lab, or unexcused tardiness. This will be checked weekly. If the student always wears appropriate dress, conducts himself/herself in a professional manner, and is on time, a score of 100% will be earned.

For each class meeting (physical or virtual) there will be either a formative assignment, a quiz, an activity, or other assignment due. Non-formative assignments will be included in your Attendance/Professionalism/Participation grade portion and are used to assess knowledge of the skill area.
