**Course Description:** The focus of this course is population health across the healthcare delivery continuum. Determinants of health and factors that increase the risk for poor health outcomes are examined. Collaborative partnerships, clinical prevention, information systems, and interdisciplinary methodologies to promote equitable population health outcomes will be explored. Students will reflect on their personal strengths and consider implementation strategies to address population health needs in their DNP scholarly project.

2. Describe how DNP-prepared nurses can engage in effective partnerships with various health delivery, advocacy, and assistance programs to promote the health of populations. (AACN, 3.2)
3. Consider the socio-economic impact of the delivery of healthcare when planning evidence-based projects. (AACN, 3.3)
4. Assess the impact of current federal, state, regional, local, and organizational policies on health disparities and inequities within populations. (AACN, 3.4)

5. Explain how DNP-prepared nurse leaders can promote advocacy efforts that include the principles of social justice, diversity, equity, and inclusion for populations. (AACN, 3.5)
6. Propose strategies to protect the health of a population during disasters and public health emergencies. (AACN, 3.6)

### Grading Scale:

Grades will not be rounded when calculating the average (79.5 is not rounded to 80, and 89.5 is not rounded to 90). Students are required to achieve an average of 80% (B) to complete the course successfully.

**Graded Course Requirements Information:**

**Participation:** Attendance/viewing of course orientation, completion and submission of surveys, and attestation of documents downloaded will be used to derive your grade for participation.

**Missed Assignments Policy:** All course assignments are required components of this course and must be completed to receive a passing grade. If an assignment is missed, a grade of zero will be recorded and will remain as the final grade for that assignment. However, the assignment must still be completed and submitted, regardless of the grade penalty, to satisfy course completion requirements. Failure to submit all required coursework may result in a course failure, regardless of the final grade average.

**Assignment Resubmission Policy:** To support mastery learning and academic success, students are permitted to resubmit any assignment on which they initially earned less than 80%, under the following conditions:

- One-time Resubmission: Students may resubmit each eligible assignment only once.
- Grade Cap: The maximum grade that can be earned on any resubmitted assignment is 80%, regardless of the quality of the resubmission. All resubmitted assignments will have an automatic 20% deduction from the final grade earned out of 100%.
- Exclusions: This policy does not apply to assignments in which the original grade was below 80% due to late submission penalties applied in accordance with the course's Late Policy.
- Submission Deadline: Resubmitted work must be submitted within 7 days of receiving the original grade and feedback, unless otherwise approved by the instructor.

Students are strongly encouraged to review instructor feedback carefully and consult with the instructor as needed before resubmitting work.

**Knowledge Checks:** You will complete quizzes over content covered in modules throughout the course. The knowledge checks can be completed as many times as you would like until the deadline for completion. Your highest score will be kept.

**Population Health Assignments:** The population health assignments are divided into three parts. In part one, you will select a target population and describe your population using publicly available data sources with health-related data about your population. In part two, you will explore the county where you live using the University of Wisconsin Population Health Institute's County Health Rankings and Roadmaps website. Finally, you will put it all together in part three, analyzing data collected in parts one and two. Next, you will prepare a 5–10-minute presentation on your target population and how to best manage your target population in the county where you live.

**Discussions:** Throughout the semester, you will participate in group discussions to help you apply concepts related to the course and provide actionable feedback using the RISE model. Topics vary and are introduced within corresponding modules. Grading criteria for assigned discussion board postings can be found within the modules for which they are assigned.

**Reflections:** You will reflect on various topics and share what you have learned throughout the course.

**Please Note:** Detailed information and grading rubrics for course assignments will be provided in Canvas.

To successfully pass this course, students must complete and document a minimum of 100 DNP Practice Hours in Exxat. Proper and timely documentation in Exxat is mandatory and will be monitored for compliance.

Students who are applying approved post-baccalaureate clinical/practice hours to the DNP program are permitted to apply a portion of those hours to satisfy up to 50% of the required hours for this course, provided that these hours meet the program's criteria and are properly verified.

Within the first two weeks of the course, students must complete the DNP Practice Hours Plan Attestation form specifying the number of hours they plan to apply to this course. The attestation form must also include a statement of the total number of post-baccalaureate clinical/practice hours approved through the Clinical Hour Verification Request process, the number of hours applied to previous courses, and the remaining balance of hours available to be applied toward future courses. Failure to complete and submit the attestation form within the required timeframe may result in ineligibility to apply post-baccalaureate hours to the course.

Practice hours must be logged in Exxat within 7 days of completing the activity. Failure to log hours within this timeframe will result in the hours being disqualified for credit, and the activity will need to be repeated to count toward the required hours.

Failure to complete the required hours for the course or to accurately document them in Exxat will result in an incomplete or course failure, as meeting the hour requirement is essential for progression in the program. Students are responsible for ensuring that all hours are properly logged and verified within the designated timeframe.
