Core complete, SOCW 2361, SOCW 2362, SOCW 2371, SOCW 3303, SOCW 3304, SOCW 3308, SOCW 3309, SOCW 4331, SOCW 4332, SOCW 4310; SOCW 4333, SOCW 4334, SOCW 4335, SOCW 4601 (Split Practicum I; taken concurrently with this course for Block placement students), and SOCW electives.

Course Overview: The purpose of Practicum II is to provide students with a structured educational experience in an approved social service agency with an approved field instructor based upon a written learning contract. The course content will reflect the Council on Social Work Education's (CSWE) requirements for accreditation.

For BLOCK placement students only:

Each BLOCK placed student is in both Field Practicum I and Field Practicum II, beginning with first day of the semester 8/24/26 and ending on 12/11/26. Students may begin their practicum one week prior to the start of the semester 8/24/26. Students must complete their hours by the final day of the semester 12/11/26.

Students must complete a minimum of 400 hours in a field agency during their Field Practicum*.
Each student must also successfully complete the goals/behaviors specified in their Learning Contract, in addition to successfully completing all the specific behaviors listed in their Mid-Term Evaluation from Practicum I, including any corrective action provided during the evaluation.

***Disclaimer: The completion of the minimum time commitment of 400 hours for Field Placement does not ensure a passing grade. Achievement of the behaviors for each of the nine core competencies must be demonstrated.**

Descriptions of Assignments:

Field Records: Time Sheets and Supervision Logs DUE WEEKLY

Students are responsible for submitting all hour reports and supervision logs in ELC by Sunday of each week. Students are encouraged to reach out to the Field Director or to click on the “Help” button in ELC, if they have any questions.

NOTE FOR BLOCK STUDENTS: If you are enrolled as a Block student all of your supervision logs and hour reports submitted in ELC will count for your “Assignments at Field Practicum Agency” for both your Practicum I and II courses.

Journal Entries: See Canvas and Course Schedule below for specific due dates

Students will submit five (4) journal entries utilizing the prompts provided by the instructor. Each journal entry will comprise 1-2 elements of a case presentation. Topics for the journals are demographic data and presenting problem, significant medical/psychiatric history, significant personal/social history, and assessment and recommendations. Supplemental resources such as articles, videos, and examples will be posted in Canvas to assist students with this assignment. Additional details for this assignment may be found in Canvas under the “Assignments” section.

Complete Case Presentation DUE Thursday December 3rd

To practically apply the culmination of their social work education, students will build a complete case presentation on one client at their field practicum site. The case presentation should be de-identified to protect client confidentiality. At the end of the semester, students will compile their four journal entries into a case presentation and will verbally present this case at a required Zoom meeting. Additional details for this assignment may be found in the class Canvas under the “Assignments” section.

Final Evaluation DUE Sunday November 22nd

The final evaluation is submitted in ELC. The student must initiate the final evaluation in ELC by Sunday November 22nd so their Field Supervisors can complete it on time. A student must receive a minimum score of “4-Proficiency” on the final evaluation in order to receive a passing grade.

The final evaluation is completed by the agency field instructor and task supervisor (if applicable) and reviewed with the student. *If necessary, a second meeting at final evaluation can be scheduled, but is not the standard nor is it required. Please contact Professor Forehand with at least **two weeks’ notice** if you would like to schedule a second meeting for the final evaluation.*

Written, Oral and Behavioral Assignments To Be Determined (TBD) by Field Practicum Agency:

All written assignments must be grammatically correct using APA style. Assignments with many grammatical errors, misspellings, and/or evidence of plagiarism will not receive a satisfactory grade.

All assignments will be due on the date as assigned by the field instructor.

**If a student earns below a B in either Field Practicum course, the student may be required to retake Practicum 4602, at the discretion of the Field Director and BSW Program Director, in accordance with the BSW handbook and CSWE accreditation standards. Students who withdraw from Practicum are not eligible to re-take Field.*

Make-Up Assignments:

Late assignments are strongly discouraged. It is up to the discretion of the field liaison/Field Director if late assignments are accepted. Supervision/hour logs submitted after the Sunday deadline will incur a penalty of -5pts per week late. **You must submit all supervision/hour logs to be eligible to pass the course.**

All other late assignments will incur a penalty of -5 pts per day late.

It is the student's responsibility to ensure that work is completed on time and submitted correctly.

Expectations for Out-of-Class Study:

N/A. Class is considered the time spent in the Field Practicum Agency. If the field instructor, field director and student agree, agency assignments may be completed outside of scheduled field hours.

Attendance:

Students are expected to present at their assigned Field Practicum Agency prepared and engaged on each of their scheduled days. Scheduling is at the discretion of the assigned agency and agreed upon by the student prior to starting their practicum. Any absences should be scheduled by the student and approved in advance (if possible) by the field instructor/agency. Unplanned absences must follow agency protocol for notification and make up hours.

The Census Date for the semester is September 8th, 2026. This is the last day students may withdraw from the course without penalty.

Withdrawing from Class

Students may withdraw (drop) from this course using the Withdrawal Portal. Withdrawing (dropping) this course can impact your Financial Aid, Scholarships, Veteran Benefits, Exemptions, Waivers, International Student Status, housing, and degree progress. Final Exam Policy

Final examinations are administered as scheduled. If unusual circumstances require that special arrangements be made for an individual student or class, the Dean of the appropriate college, after consultation with the faculty member involved, may authorize an exception to the schedule. Faculty members must maintain student final examination papers for a minimum of three months following the examination date.

Incomplete Grade Policy

If a student, because of extenuating circumstances, is unable to complete all of the requirements for a course by the end of the semester, then the instructor may recommend an Incomplete (I) for the course. The "I" may be assigned in place of a grade only when all of the following conditions are met: (a) the student has been making satisfactory progress in the course; (b) the student is unable to complete all coursework or final exam due to unusual circumstances that are beyond personal control and are acceptable to the instructor, and (c) the student presents these reasons before the time that the final grade roster is due. The semester credit hours for an Incomplete will not be used to calculate the grade point average. The student and the instructor must submit an Incomplete Form detailing the work required and the time by which the work must be completed to their respective department chair or college dean for approval. The time limit established must not exceed one year. Should the student fail to meet all of the work for the course within the time limit, then the instructor may assign zeros to the unfinished work, compute the course average for the student, and assign the appropriate grade. If a grade has yet to be assigned within one year, then the Incomplete will be changed to an F, or NC. If the course was initially taken under the CR/NC grading basis, this may adversely affect the student's academic standing.

Grade Appeal Policy

Disputes regarding grades must be initiated within sixty (60) days from the date of receiving the final course grade by filing a Grade Appeal Form with the instructor who assigned the grade. A grade appeal should be used when the student thinks the final course grade awarded does not reflect the grades earned on assessments or follow the grading scale as documented in the syllabus. The student should provide the rationale for the grade appeal and attach supporting document about the grades earned. The form should be sent via email to the faculty member who assigned the grade. The faculty member reviews the 08/2024 rationale and supporting documentation and completes the instruction section of the form. The instructor should return the form to the student, even if a grade change is made at this level. If the student is not satisfied with the decision, the student may appeal in writing to the Chairperson of the department from which the grade was issued. In situations where there is an allegation of capricious grading, discrimination, or unlawful actions, appeals may go beyond the Chairperson to the Dean or the Dean's designee of the college from which the grade was issued, with that decision being final. NOTE: The Grade Appeal Form is different from the Application for Appeal form submitted to the Student Appeals Committee, which does not rule on grade disputes as described in this policy.
