Course Objective	Welcome to CENG4311, Reinforced Concrete Design. This course in the structural design sequence relies on your understanding of important engineering concepts: Engineering Statics (ENGR 2301), Mechanics of Materials (CENG 3306), Civil Engineering Materials, Codes and Specifications (CENG 3334), and Structural Analysis (CENG 3325). In this course we apply these fundamentals to design reinforced concrete structures. By the end of this course, you will be able to accomplish these objectives: a) Analyze and design reinforced concrete beams, one-way slabs, and columns using ACI Strength Design provisions, given a set of functional requirements and an architectural concept b) Describe the advantages and disadvantages of using reinforced concrete as a building material considering factors including economics, sustainability, and safety In this course you will learn to perform structural design as it is performed in engineering practice, and you will be exposed to the engineering design process. We will be focusing our efforts on using the American Concrete Institute Building Code Requirements for Structural Concrete.

	Throughout this course you will be applying principles from previous math, physics, and mechanics courses. You will work to maximize the use of your computer in support of your work. This course has specific objectives (see Encl 1). They can be generally organized into two groups: (1) learning to internalize engineering thought process by developing the ability to solve ill-defined, real-world problems in a rational, systematic, and creative manner and presenting your solution in a clear and concise way; and (2) developing a working knowledge of structural concrete and incorporating the Load and Resistance Factor Design (LRFD) philosophy to examine problems with realistic constraints. Bring study notes, textbook(s) (ACI Code), note-taking material, and calculator to every class. You <u>may not borrow or exchange calculators during graded events</u>. <u>If your calculator fails during a graded exercise, I am not responsible for furnishing a substitute</u>. Class preparation is your individual responsibility.

	*Professional Practice Grade Breakdown: Your professional practice grade of 10% or 10 points is composed of three components. They are attendance (3.5 points) plus participation in the course (3.5 points) plus participation in professional organizational activity (3 points), such as ASCE, AISC events. The professional organizational activity is comprised of attending a minimum of 3 professional organizational events and submission of one mini report describing the meeting contents. For the mini report a document template has been posted on canvas within the ‘Assignment’ module. Attendance will be tracked by roll calls. In grading the homework, assignments, tests, exams, etc., no credit will be given to methods not covered in this class, although these methods, tables, formulae may appear in the textbook. Errors or outdated material in the textbook should not be the reason for claiming full credit for work done. To protect your confidentiality, graded homework, assignments, and exams will not be placed in open area for collection. They will only be distributed by the instructor during class or office hours. Graded homework, assignments, and exams not collected before the final exam week will be disposed according to UT Tyler policy. Letter grades will be assigned based on the final course grade: - A 90 and above - B 80 to 89.99 - C 70 to 79.99 - D 60 to 69.99 - F below 60 No letter grade will be released until it is official on PeopleSoft. If you earn less than 65% on all Exams or if you fail to earn at least 50% on the Final exam you may fail the course, regardless of your course grade. All material covered in the course will be tested (comprehensive test). Solutions to exams <u>will NOT</u> be posted, however, you can review the solution in my office.
General Exam Rules & Formula Package	Mid-Term and the Final Exam are closed notes. The ONLY reference for these exams is the <i>formula package put together by the instructor</i>. The contents of the formula package are relevant sections from the ACI Building Code Requirements 318-19 and relevant sections of NCEES published FE/PE formula sheet. You are only allowed to bring your writing instruments (pencils & pens), erasers, and NCEES approved calculators. You are NOT allowed to work with anyone on the exam. You must work independently. No use of the internet, textbooks, notes or any other resources. Carry through all units in the problem. Any student found in violation of these rules and as such in violation of UT-Tyler student code of conduct will be subjected to penalties ranging from receiving a zero grade on the respective exam or suspension or expulsion from the university. Topics to be tested will be announced in class and on Canvas one week prior to the exam. The instructor will set questions from material taught in class. The meaning of “taught in class” includes verbal instructions or written notes on Canvas. It is very important that you attend the class activities and take additional notes. To discourage students from focusing narrowly on only a few questions, no practice exam will be given. There are enough self-practice problems in the textbook at the end of each chapter, which are not required as part of each homework assignment.
Re-schedule of Examination	<u>Final Exam</u>: There is no make-up or rescheduling. <u>Mid-term Exams</u>: Each student is only allowed one make-up exam. That is, he/she can only make-up Exam 1 or Exam 2. Make-up will be arranged if you inform the instructor prior to the day of the exam, citing a strong and valid reason. Examples of strong valid reasons (unexpected events and cannot be rescheduled) are <u>official UT Tyler travel, accident, illness, childbirth, passing of an immediate family member, jury duty, or court appearance</u>. You will be required to show documentary evidence for valid reasons (e.g., official university letter, <u>doctor’s letter, letter from</u>

	<u>funeral home</u>, <u>police report</u>, <u>court letter</u> etc.). Events that can be pre-scheduled or rescheduled are not considered valid reasons. Examples of non-valid reasons are <u>traffic</u>, <u>wedding</u>, <u>driving test</u>, <u>car breaking down or at repair shop</u>, <u>clash with another course schedule</u>, etc. Job interviews will be considered on a case-by-case basis (again, with documentary evidence). If an emergency happens during the exam day, you should contact the instructor at the earliest possible time (or call the HEC Engineering office or contact one of your classmates or TA who will then inform the instructor). Any make-up exam will be given on the Last Day of Classes (Friday, December 4, 2026). To compensate for the fact that you may apply what you learn in the entire course when answering make-up Exams 1 or 2, the make-up exam will be more difficult than the original exam. Students who fail to show up for the make-up or final exam citing an invalid reason will be given 0 points for that exam; or for a valid reason an incomplete “I” grade. He/she must take the exam the next time this course is being offered to have the “I” grade changed to a letter grade. All assessment components and marks will be retained for the calculation of the final letter grade. The letter grade will be benchmarked against the same class for the semester in which the exam had been missed.
Calculators	The use of any electronic device, except an approved calculator, is not permitted during exams. Your exam will be collected, and your grade will be zero if you are caught using a non-approved electronic device (Laptops, PDAs, MP3 players, cell phones, smart watches) / Calculator. In line with the Civil Engineering Department’s policy, only calculators permitted by NCEES for use in the <u>current semester’s FE exam</u> are permitted to be used for CENG 4311 examinations. No other model of calculator will be allowed. Models allowed by NCEES in the past but are no longer valid for the current FE exam are prohibited in the CENG 4311 exams. Project: Engineering Design Problem	This course includes a semester long design problem with a series of submissions along the way. When submissions are complete you will have executed a complete design for a structural system. More information will be posted on canvas within course module.
Collection of Student Work	Throughout the semester, I may collect student work (best, average, and worst) for ABET assessment. This will require me to keep your original and return a copy of the graded work to you. I will not draw attention to what level of work you accomplished.
Embedded Indicators of Accomplishment of Program Outcomes	At times throughout the semester, portions of student work will be analyzed to determine if our program is accomplishing stated program outcomes based on established metrics. If your work is below the minimum established metric, you will be required to repeat the assignment or that portion of the assignment until you achieve the minimum acceptable standard based on a approved rubric.
Homework	Homework will be assigned on a regular basis. Homework will be collected and graded for completion only. To receive a grade - Homework must be uploaded on canvas by the due date and time. No late homework will be accepted. Homework solutions are posted on canvas. Strong suggestion - try solving homework problems on your own, only consult solutions to check your work.
Assigned Readings	Your assigned reading prior to class is the up coming lesson as per schedule. The schedule and lessons are published on canvas. This will help you understand the material presented during class instruction and will fill in gaps for course content that we are unable to cover due to class time limit. It will also make you more familiar with the terms and concepts to be covered. To help motivate you to do the reading there may be quizzes that you are required to complete prior to class that are either announced or unannounced.
Final Day to Withdraw	The final day to withdraw from the course without penalty is October 30th, 2026.

CENG 4311 Reinforced Concrete Design - Course Objectives

1. Given a set of functional requirements and an architectural concept, design a low-rise concrete building.
2. Describe the advantages and disadvantages of using reinforced concrete as a building material.
3. Explain and apply the stages/phases of the engineering design process model.
4. Perform a load analysis using ASCE 7-10 for dead load, live load, snow load, roof live load, and wind load.
5. Use the LRFD load case combination equations to develop load case combinations for structural analysis.
6. Apply the LRFD methodology: $\phi R_n \geq \Sigma \gamma_i Q_i$
7. Model braced and rigid frames as lateral load-resisting systems.
8. Reduce a real-world 3-dimensional frame to a 2-dimensional model, accounting for the applied loads, connected members, and out of plane behavior.
9. Analyze and design a reinforced concrete beam.
10. Analyze and design a reinforced concrete column.
11. Analyze and design a reinforced concrete beam-column.
12. Analyze and design a reinforced concrete slab.
13. Use modern engineering software to solve problems.
14. Function effectively as a member of a design team.
