Course Overview: This course provides an introductory overview of statistical concepts and methods used in public health. The topics will cover general ideas, application, and interpretations. Topics include descriptive statistics, probability, probability distributions, estimation, hypothesis testing, simple linear regression and correlation, analysis of variance, and use of statistical software. Each student will learn both statistical meanings and use of statistical software throughout the course.

Student Learning Outcomes:

By the end of the course, students should have a basic understanding of the fundamentals of biostatistical methods. This includes:

- Summarizing data with numerical measures and graphs
- Basic concepts of randomness and data distributions
- Point/Interval estimation for categorical and continuous outcomes
- Hypothesis testing for categorical and continuous outcomes
- Simple linear regression
- Interpreting output from statistical computing package (Jamovi) to draw appropriate inferences, and to report results effectively
- Applying statistical procedures in the public health environment

Course Assessment / Methods of Evaluation

Readings: Textbook reading assignments are indicated in the course schedule. Additional assignments specific to each lecture will be posted as needed. Make sure to follow instructions for assignment completion posted within each module. You are responsible for any additional materials provided, so please check Canvas regularly.

Assignments: Assignments will be given out throughout the course based on assigned readings and materials covered in each module as homework. The assignments will be worth 65% of your final grade. There will be a total of 15 assignments. **Assignments are due by Monday nights at 11:59pm.**

Synchronous Sessions: There will be a total of **4 synchronous sessions** that will be held via Microsoft Teams. Meetings will be on Tuesday evening from 6 to 8 pm CST and each session will be recorded. The instructors will provide questions or activities for deeper understanding for an hour, and the remaining time will be Q&A or individual meeting. Actual in-time attendance is not-required yet required one of the following two ways to obtain attendance points. Each student **MUST** attend or submit a 1-page reflection paper on recordings to obtain full credit. A total of 4% of final grade is designated for this activity.

Mid-Term & Final Exam: Mid-term and final exam will comprise real data analysis (BRFSS), interpretation, and oral presentation. The BRFSS (Behavioral Risk Factor Surveillance System) (<https://www.cdc.gov/brfss/index.html>) is the national health survey by phone interviewing, which has



more than 400,000 adults each year. For the sake of class purpose, I minimized the data for only Texas with selected variables. The mid-term exam will be worth 18% of the final grade; the final exam will be 13%. Each exam includes oral presentation. Each student **MUST** upload the oral presentation file on canvas. Midterm will focus on descriptive analysis, and the final will focus on inferential statistical analysis, such as ANOVA or regression models.

For the midterm (total 400 points), each student **1)** selects **ONE** health-related variable (e.g. cancer, diabetes, etc.) and at least **THREE** independent variables (e.g., age, sex, race, marital status, etc.), **2)** analyzes each variable’s ***descriptive statistics (table)*** (frequencies, mean, median, standard deviation, minimum, and maximum) (50 points), and **3) graphs** (histogram and box plot) (50 points), and **4)** interprets your results (you need to interpret each table and graph briefly, about 1-3 sentences) (100 points). Then, each student will **5)** create ***Power-Point presentation*** slides (100 points), and **6)** submit your oral presentation file (100 points).

For the final exam (total 300 points), each student **MUST 1)** run ***a statistical model***, using one health-related variable and at least 3 demographic variables and interpret your results (100 points). Again, each student will **2)** create ***Power-Point presentation*** slides, including all interpretations (100 points) and **3)** submit your oral presentation file (100 points).

The oral presentation (including PowerPoint slides appropriately formatted and sourced) on their midterm and final projects. Details of the presentation, including the length and format of the presentation will be provided by the instructors.

Extra Point: This course will offer one-time for extra points. Student who completed a course evaluation survey at the end of the semester and submit their screenshot on canvas (no need to submit your answers, but your completion message on screen). I will give you 10 points toward one of your assignments. For example, if your assignment #3 score was 90, your final score on assignment #3 will be 100.

Please be aware that **NO EXTRA CREDIT WILL BE GIVEN** at the end of the semester (***except a course evaluation survey***). The average of each student’s grade will determine the final course grade, and no additional work will be allowed. The grades in the gradebook at the end of the semester are the final grades, no curves will be given.

measured in assignments, analysis outputs, interpretation, writing, and oral presentation. Writing examples and rubrics will be given to students to follow.

AI use policy: I will allow you to use AI to do statistical software work, as AI can be very useful source to learn software with ease not only this semester but also in your future. **However**, I will not allow you to use AI to write your interpretation of results, tables, and figures. I assume this is your first time to write on statistical results, and writing may be one of your critical role or duties in your career. So, let’s practice in this course without AI. As you only need to write about one or two paragraphs, the writing part will not be a big burden. If I find you have used AI for your writing, your score on that assignment will be 0.

Late Assignments/ Assessments: Students need to contact the instructor if they anticipate submitting an assignment late. Any late assignments will be subject to a 5% deduction each day for the first week (35% if submitted a week late) and an additional 10% for each day thereafter. Assignments turned in over 2 weeks late (14 days) will receive a grade of 0 for the assignment. This policy includes homework and any assignment. Reasonable accommodations will be made under special circumstances. If you need special accommodations, you must contact the Professor BEFORE the due date for the assignment.

Final examinations are administered as scheduled. Incomplete Grade Policy

If a student, because of extenuating circumstances, is unable to complete all of the requirements for a course by the end of the semester, then the instructor may recommend an Incomplete (I) for the course. The "I" may be assigned in place of a grade *only when all of the following conditions are met:* (a) the student has been making satisfactory progress in the course; (b) the student is unable to complete all coursework or final exam due to unusual circumstances that are beyond personal control and are acceptable to the instructor, and (c) the student presents these reasons before the time that the final grade roster is due. The semester credit hours for an Incomplete will not be used to calculate the grade point average.

The student and the instructor must submit an Incomplete Form detailing the work required and the time by which the work must be completed to their respective department chair or college dean for approval. The time limit established must not exceed one year. Should the student fail to meet all of the work for the course within the time limit, then the instructor may assign zeros to the unfinished work, compute the course average for the student, and assign the appropriate grade. If a grade has yet to be assigned within

one year, then the Incomplete will be changed to an F, or NC. If the course was initially taken under the CR/NC grading basis, this may adversely affect the student's academic standing.

Grade Appeal Policy

Disputes regarding grades must be initiated within sixty (60) days from the date of receiving the final course grade by filing a Grade Appeal Form with the instructor who assigned the grade. A grade appeal should be used when the student thinks the final course grade awarded does not reflect the grades earned on assessments or follow the grading scale as documented in the syllabus. The student should provide the rationale for the grade appeal and attach supporting document about the grades earned. The form should be sent via email to the faculty member who assigned the grade. The faculty member reviews the rationale and supporting documentation and completes the instruction section of the form. The instructor should return the form to the student, even if a grade change is made at this level. If the student is not satisfied with the decision, the student may appeal in writing to the Chairperson of the department from which the grade was issued. In situations where there is an allegation of capricious grading, discrimination, or unlawful actions, appeals may go beyond the Chairperson to the Dean or the Dean's designee of the college from which the grade was issued, with that decision being final.
